DATA PRIVACY STATEMENT

1. Introduction:

Queebee ("we" or "us") respects your right to privacy and is committed to protecting the personal information you entrust to us. This Data Policy Statement ("Policy") explains how we collect, use, disclose, and store your personal information in accordance with the Kenya Data Protection Act 2019 ("the Act") and other relevant legislation.

2. Information We Collect:

We collect the following types of personal information from you:

(1) Mandatory Information:

(a) Registration Information: Email address, username, password, date of birth, sexual orientation.

(2) Optional Information:

(a) Profile Information: Bio, interests, photos, voice calls, preferences for potential matches.

(b) Device Information: Device type, operating system, IP address, location data (with consent).

3. Lawful Basis for Processing:

We process your information based on the following lawful grounds under the Act:

(1) Consent: For optional information and sensitive information.

(2) Contract: To operate the App and provide services.

(3) Legitimate Interest: To improve App functionality, provide recommendations, and for internal analytics.

(4) Legal Obligation: For law enforcement purposes.

4. Data Principles We Follow:

We adhere to the following data principles as mandated by the Act:

(1) Lawfulness, fairness, and transparency: We only collect and process your information lawfully, fairly, and transparently.

(2) Purpose limitation: We use your information only for the purposes outlined in this Policy.

(3) Data minimization: We collect only the minimum information necessary for our purposes.

(4) Accuracy: We ensure your information is accurate and up-to-date.

(5) Storage limitation: We retain your information only for as long as necessary.

(6) Integrity and confidentiality: We employ appropriate security measures to protect your information.

(7) Accountability: We are accountable for your information and its compliance with this Policy.

5. Your Rights under the Act:

You have the following rights under the Act:

(1) Right to access: You can request access to your personal information we hold.

(2) Right to rectification: You can request us to correct any inaccurate information.

- (3) Right to erasure: You can request us to delete your personal information.
- (4) Right to restrict processing: You can restrict how we process your information.
- (5) Right to data portability: You can request us to transfer your information to another organization.
- (6) Right to object: You can object to our processing of your information.
- (7) Right to lodge a complaint: You can lodge a complaint with the Office of the Data Protection Commissioner.

6. Sharing Your Information:

We may share your information with the following third parties:

- (1) Service providers: For cloud storage etc., only with data processing agreements in place.
- (2) Law enforcement: If required by law or to protect the safety of others.
- (3) Others: Only with your consent or as permitted by law.

7. Data Security:

We implement appropriate technical and organizational measures to protect your information from unauthorized access, disclosure, alteration, or destruction. We regularly review and update our security measures.

8. Data Transfer:

Your information may be transferred to and processed in countries other than Kenya. We will only transfer your information to countries that provide adequate data protection safeguards.

9. Retention Policy:

We retain your information for as long as necessary to fulfill the purposes for which it was collected, unless a longer retention period is required or permitted by law.

10. Age Limitation:

Our App is not intended for users under the age of 18. We do not knowingly collect information from children. If you are a parent or guardian and you learn that your child has provided us with personal information, please contact us.

11. Changes to this Policy:

We may update this Policy from time to time. We will notify you of any changes by posting the new Policy on the App.
