## o Old Business

Garbage: The BOD has approved a motion to replace our existing garbage cans with a 3-yard dumpster. The dumpster will be enclosed by a vinyl fence that will be locked. Waste Management, Inc. charges \$100 weekly for spring/summer, and \$62 bi-weekly during the fall/winter. There will be no changes to our current recycling cans.

#### o New Business

- If you have left a tray behind after any recent SCBC Event, please retrieve it, or it will be disposed of.
- Sound System: A committee will be formed to work with Best Buy to update our current, outdated sound system (i.e., Projector, DVD, Wireless Speakers). The committee will include Mark Mastorelli and Bruce Floystad. If you have any experience or would like to be a part of this committee, please reach out to Mark Mastorelli.
- Electronic Event Sign: Roger Ackermann has done extensive research into replacing our Event Sign at the entrance to Skippers Cove. This sign will be the same size as our existing sign (3' x 8'). The electronic sign will have features that include: 4 lines, 8" letters (same as existing), changeable color background, wireless keyboard, and dimmable lighting with an on/off timer. Roger has paid the \$50 permit fee (which includes an extensive architectural review to present to the town). The total cost is still pending for the sign, electrical service, and construction material costs. Bruce Floystand is willing to donate the electrical labor and materials, and Paul Amodio will also donate time to this project. Our social clubs may also contribute to this project.
