... create the position of Director of In-Custody Death Review (director) within the Board of State and Community Corrections... require the director to review investigations of any death incident occurring within a local detention facility... make specific recommendations to the sheriff ... including ... changes to policies, procedures, and practices, as specified. ... within 90 days of receipt of the recommendations of the director, would require the sheriff ... to identify the recommendations that will be implemented and provide a timeline for implementation and the anticipated cost The bill would require these recommendations and responses to be made available to the public, and would give the director and the sheriff or administrator of the local detention facility the discretion to redact these disclosures, as specified.

[SB 2](#) passed because we are one of only 4 states without a process to revoke certification due to misconduct, They have delegated this task to the Peace Officer Standards and Training Commission, post.ca.gov. This bill prohibits a person who has been convicted of certain felonies from regaining eligibility for peace officer employment. The bill creates the Peace Officer Standards Accountability Division (within <https://post.ca.gov/>) to review investigations conducted by law enforcement agencies and to conduct additional investigations into serious misconduct that may provide grounds for suspension or revocation of a peace officer's certification. But the Legislature probably didn't fund post.ca.gov to do the SB 2 work. Also, there are 58 counties and it will take awhile.

SB 16 expands the categories of police records the public can access and closes loopholes that keep misconduct records under wraps - and also says each department or agency in this state that employs peace officers shall establish a procedure to investigate complaints by members of the public against the personnel of these departments or agencies, and shall make a written description of the procedure available to the public

AB 392 Use of force says police can use deadly force only when “necessary in defense of human life.” Chaptered Aug 2019
