## **General Annual Training Requirements**

Each year, the following are also required:

- It is required for all license types to have fifteen (15) hours of annual training with at least three (3) hours with a focus on social-emotional development.
- Fifteen hours of ongoing professional development. All of the courses listed above count toward these 15 hours in the 12 months it is completed, except for CPR and First Aid Certification, which is marked with an asterisk (\*).
- Ongoing professional development and social/emotional hours can be obtained on the PDIS or from
  other sources that provide a certificate that meets the <u>external training requirements</u>. For more
