## Payment:

- All Prices are shown in **USD** and Payment is either through **PayPal Invoice** or via a **KoFi Donation**
- A valid Email is required
- Payment is required **In Full** before a commission is started
  - Payment Plans are available for commissions over **\$150 USD**
    - The base plan would be 50% upfront and 50% at time of completion
- I only accept commissioners **16 years of age or older**
  - To request artistic nudity; you must be **18 years of age or older**

## Refunds

- Refund amount is based on what stage the commission is at the time of request.
- Please be sure to have at least a PayPal account for refunds to be sent out if needed.
  - Not Started: 100% **minus any processing fees** from payment services.
  - Sketch: 50%
  - Linework: 15%
- Full refunds are available for excessively late work (5+ months) without communication.
- Being excessively difficult may result in the cancellation of your work **without a refund**.

## Added Fees

- Fees are always discussed ahead of confirming a commission. No Surprises!
- A list of possible fees and percentages can be found in the *Client Communication* section.

# Commission Information

## What is needed from you:

- I will need an email address, social handle (for posting), and a reference sheet or image of your character.
  - I prefer SFW refs but I will also accept NSFW refs as well
  - Mood boards, pose ideas, and other references are also welcome!
  - Telling me about your character's background and personality also helps in drawing them!
  - Characters with pure white or black may be offset slightly to allow for better shadow and light rendering
- For Custom Designs I will need clear descriptions and mood ideas/boards depending on how much control you would like during the process.

## Queueing System / Turnaround Time:

### The Queue

- The queue is worked in a semi-linear fashion based on type, complexity, and payment.
  - Commissions are first ordered in the time they were paid for and then worked on based on that initial order.
  - Simpler/quicker commissions are “jump the queue” as a result.length a reasonable size for myself and for turnaround time on commissions.
  - If the queue starts to feel too long; commissions will be closed and new commissions will not be accepted until the queue has been completed or nearly completed.

### Turnaround Time

- Turnaround for a commission is between 2-6 weeks **after being started**.
  - This timeline tends to coincide with when payments have been made, so for most, this turnaround matches when they have paid for their commission.
- Commissions may be completed earlier or later than this timeline.
  - If a commission is projected to be later than expected, anyone affected will be notified.

### Rush Requests

- I do not accept pressure to rush a commission **after** it has been paid for or started.
  - Attempts to pressure me to complete a piece quickly may result in the commission being canceled with no refund.
- Rush requests **must** be discussed **before invoices are sent**:
  - I hold the right to refuse any rush request regardless of reason.
  - Any rush request after payment will be rejected; with *minimal exceptions*
  - If accepted, a fee will be added to the commission price.
  - Any pressure to accept after rejecting the request will cause the commission request to be canceled.

## Work in Progress (WIP) / Updates:

- All commissions include a WIP image in the sketch phase.
  - Commissions with shading will also have a WIP image at the flat color stage
- Higher complexity commissions will have more WIPs in other stages such as lining.
- Clients may request additional WIPs during the commission process within reason
- For payment plans: A low res image will be sent for confirmation. The final payment must be sent to receive the final, full res image.

## Edits/Alterations

- Edits during the sketch phase will typically not incur a fee unless the change is drastic (i.e. changing the entire pose or composition).
- I will not copy someone else's art style or significantly alter my own style.
- After the sketch; up to 3 alterations are allowed to be requested for free.
  - Unless they are mistakes on my part (for example: missing a color or part of your oc), most alterations will count towards this limit.
  - Alteration fee is \$5 or higher depending on what is requested, and must be paid for after the alteration has been done and approved of.
    - Alteration fee will always be discussed!
- I hold the right to refuse alterations **after** the commission has been completed and delivered.

## Rights to Completed Artwork:

### Artist Use

- I hold the right to
  - Post completed work online/ on social media
  - Use work in artbooks/art showcases
  - Use work in portfolios

**AT NO POINT CAN MY WORK BE PURPOSEFULLY FED INTO AI MODELS OR USED IN NFTs**

### Private Use

All commissions are private use unless discussed ahead of time.

- As the Client, you hold the right to
  - Crop work as needed to fit your uses
  - Print out work for yourself/personal use
  - Use as a banner for a channel or profile picture
  - Post the work online (with credit please!)
- As the Client, you DO NOT hold the right to
  - Sell merchandise using the completed work or any other monetary gains
  - Retrace, Copy, or Heavily Modify the original work
  - Remove signatures/watermarks
  - Claim as your own work

## Commercial Use

- Commercial Use means any artwork made can be used publicly for things such as monetary gain.
- Private work may be used for commercial reasons if an added fee has been paid.
- As the Client, you hold the right to:
  - Sell merchandise using the completed work (posters, keychains, shirts, etc...)
  - Crop work as needed to fit your uses
  - Use as a banner for a channel or profile picture
  - Post online (with credit please!)
- As the Client, you DO NOT hold the right to:
  - Retrace, Copy, or Heavily Modify the original work
  - Claim as your own work

## Client Communication and Disclaimers:

- I check for work-based messages at least once a day from current commissioners.
  - Please allow at least 24 hours for responses to questions and messages.
- I will only respond actively to platforms listed in my *Contact Me!* Section.
  - I may not respond on other sites/services, so please take note of that!
- I have the right to reject any requests for commissions that I am uncomfortable working on.
- I have the right to reject any requests from users I deem suspicious or controversial.
- I have the right to decline commissions from clients in the past for any reason.
- I have the right to decline commissions without requiring an explanation.
- I do not claim to know or hold knowledge of every client or character that requests a commission from me.

- ***Hateful & Racist rhetoric***
- ***Certain Religious contexts***
- ***Certain Political contexts***
- ***Zoophilic/Pedophilic contexts***

*It was not of my own volition nor permission. This sort of usage will result in the perpetrator being **blacklisted**.*
