#### 1:40 PM State of Al & Accessibility at SBCTC Colleges (30 MIN)

- What is working well:
  - Kevin Bowersox-Johnson: Accessibility checklists from state board
    - Microsoft Word Accessibility Checklist
    - Microsoft PowerPoint Accessibility Checklist
    - Microsoft Email Accessibility Checklist
    - Canvas Accessibility Checklist
  - Kevin Bowersox-Johnson: Create tracking and prioritizing/checklist for every person, only helps if you know what to do once you have those priorities
  - Kevin Bowersox-Johnson: Collective learning with a deadline: complete accessibility micro courses by a deadline, then meet to discuss
  - Use Webaim on the published view of the Libguides to help identify priorities.
  - o Canvas LMS: Learning Tools Interoperability (LTI) IT Connect
- What isn't working well/Concerns:
  - LLC: Accessibility concerns around database vendors (navigability of the website and documents). Not all libraries use the same vendors, some similarities.
     50-100 different vendors that would need to be worked with to ensure accessibility.
  - LLC: Concerns around library website accessibility (most are using Lib Guides)
  - o LLC: Journals, eBooks, test prep are also on their radar.
  - Commonality with LLC/eLC: Volume of vendors to vet and work with on accessibility. (How do we leverage our network, collective pressure). Some colleges and universities have already started this work, utilizing what has already been done. How much digging do we need to do as individual colleges on other colleges/orgs/universities' vetting? Where is the line? In the end, we are responsible.
    - Use the information as a starting point, but go back and confirm
    - Make sure to check vendors for captions and audio descriptions on videos and audio.
  - How can SBCTC support to avoid duplicating efforts? Acknowledging limited resources on the SBCTC and colleges.
    - SBCTC is getting the top 10 LTIs in Canvas. Also getting system pricing.
    - Add a category in the Ed Tech Commons for accessibility and a spot to attach documentation. IT folks are looking for a similar repository for security.

- Struggle with vetting VPATSs, contract language, etc.
  - We can't totally trust VPATs, a better bet is to look at vetting from schools/orgs (view big 10 alliance resources)
- We need to push pressure on vendors with contract language. We should not be spending millions vetting their tools for them. Focus on leveraging our power so the vendors should be demonstrating and proving the accessibility of their product.
- Individual accessibility testers vs. SBCTC test- limited funding. We do have accessibility liaisons, not necessarily a functional test. SBCTC has one functional tester.
- This is a website from U-Wisconsin that shows they have already documented testing and identified issues. https://kb.wisc.edu/accessibility/ (sorry only one Library Catalog listed) Possibly, is there a nationwide reach that can organize the efforts: NC-SARA, EDUCAUSE?
- Will the Canvas LTI vetting vendor be appropriate to use for library products?
- We just can't keep up with vetting...the responsibility is on the vendor.
- Focus on procurement. Every college is sending their own unique questions and forms which makes it so hard for vendors. We need a unified form/questions as a consortium.

- How are you making accessibility work manageable?
  - Requiring microcourses
  - Use analytic tools in Ally to approach possible issues, use that insight

  - Grays Harbor College has required training with no payment. Approach teaching online as a privilege. Must complete accessibility training prior to teaching online.
  - Olympic has an MOU that they can add accessibility to.
- Does your campus have required training?
  - Accessibility accountability in Highline faculty contract.

- State Policy requires accessibility training once a year. <u>WA State Digital</u>
   <u>Accessibility Policy- User-0-1</u>. Accompanying technical standards. Might just be required to offer.
- o Include accessibility in onboarding process and expectations around Al.
- Approved Email Sender Training Olympic College (Shared with permission)

#### AI:

- What is happening with AI Canvas partnerships?
  - Learn more about back end
  - Very nervous
  - Multiple Al partnerships
  - A lot of "I don't know" from Canvas CSM
  - Who are they partnered with? What do we have to pay for? Opt in/opt out options? Institutional level opt in/out, not course level. Suspect that we might have to pay...Michael is willing to push on this.
- How is Al impacting Libraries?
  - o Opt-in for Ai research assist tool, new interaction will be way harder to opt out
  - At least one subscription that increased the price and provided no opt out option.
     Is this a trend? "You will love it". Are they communicating with libraries prior to turning them on--no
  - Vendors are unable to answer questions...but "you will love it"
  - o Information literacy. Al literacy component.
- Al policies?
  - Marc L.- campus wide policy group. Divisions need to craft their own principles.
     "You have to follow other policies". Covers eight main principles, framework for innovation. Communicate how existing policies affect AI (FERPA, etc.). Policy approval process is too slow for AI. Make AI literacy the priority.

- Instructure's partnership with OpenAi
  - Make sure DPA in place to make sure no data is exposed when passing data from Canvas to GenAl platforms like ChatGPT
  - Basic integration is supposed to be free
  - The integration would be with the free version of ChatGPT
  - Will be discussing at the next Al Taskforce meeting

- Keep an eye on the rising cost of Canvas overall, making GenAl not free
- What about the cognitive dissonance of faculty using ChatGPT in Canvas to grade but disallowing students using it
- Disclosure for students and faculty about using ChatGPT in Canvas
- What specifically do we want Michael and Kindra to get for us?
  - Joint document for questions, concerns, asks
  - o Do we have the power to say "no" based on our Canvas contract
    - Depends on what kind of feature it is...part of the product or add on
  - Will be rolled out in the next 5-6 months
  - Michael and Guava has reached out to Kindra about many of these questions---TBD
    - Pretty sure this will be an incurred cost with the possibility of a pilot
    - Nudge Michael in November so we aren't caught off guard in winter quarter

- Learning Strategies & Innovation Committee Meeting
  - AI
- Outputs: Al framework, an inventory of Al-related outcomes/tools, and a micro-course collection. The framework should be for institutions, presented to presidents, to help them initiate conversations and address overwhelm.
- Non-Credit to Credit Articulation
  - There's potential to catalyze credit articulation for non-credit certification pathways related to AI.
- Guided Pathways
  - This was proposed as a third work plan item, as other subcommittees may not be focused on it.
  - Guided pathways is seen as crucial for achieving equity goals and supporting all students.
  - The need to strengthen guided pathways to support marginalized students by integrating learning strategies and faculty advisor support systems was emphasized.
- Accessibility
  - A fourth goal was proposed: Continue pressure on institutions to implement accessibility work to meet the upcoming federal compliance deadline (Spring 2026).
  - Challenges include a lack of upper-level leadership commitment, capacity issues, and reluctance for required training among faculty.
  - It was suggested to gauge institutional readiness for the April 2026 deadline (e.g., on a scale of 1-10).
