

Intro:

I've talked about my experience with Fed in the past, and am really disappointed that "leaked" and misleading messages have made it necessary for me to respond once again. I feel forced to share my side of the story, now with evidence and context, to hopefully close this chapter once and for all. Knowing how much it hurts to have private convos leaked, I didn't want it to have to come to sharing more info that is also private to Fed and my friends involved. Out of respect to their privacy, I'll only be talking about some of the things that were already shared and what my friends are comfortable with.

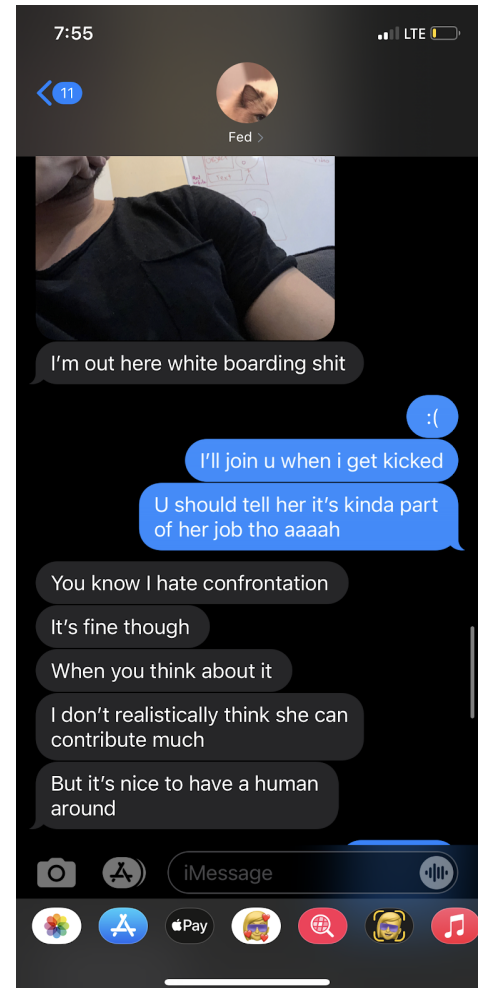
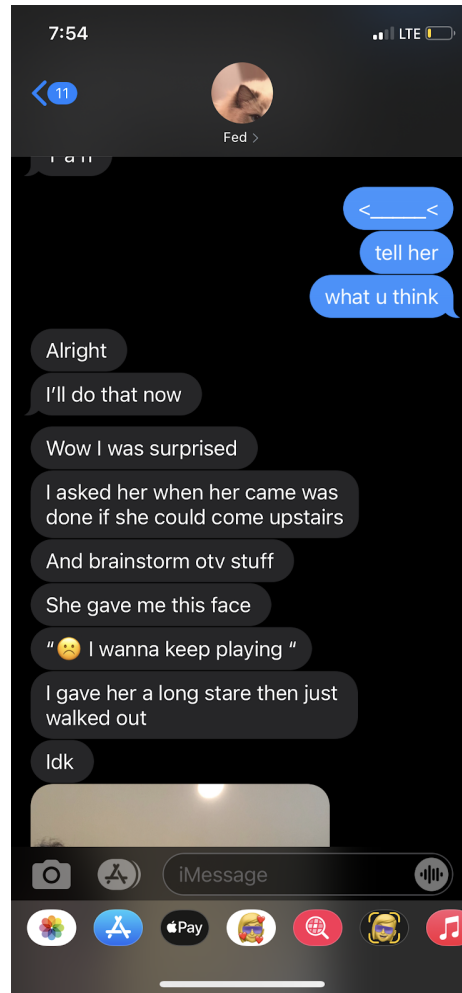
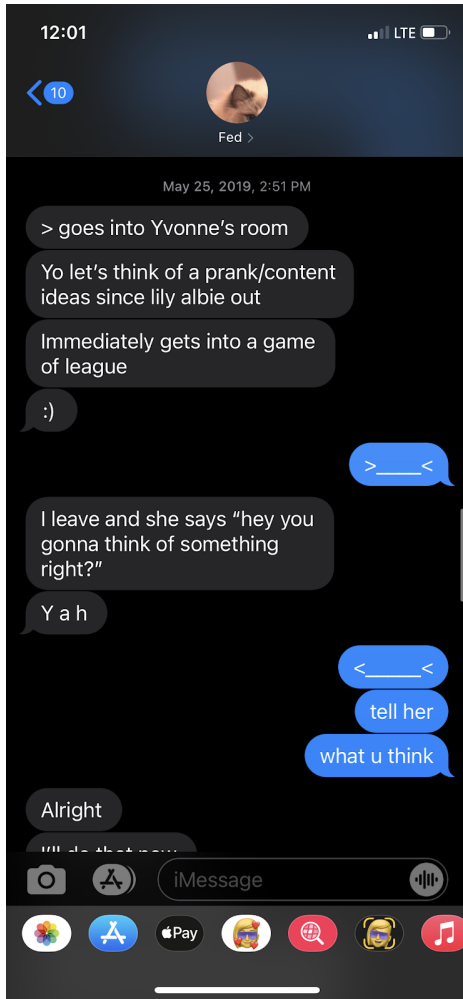
The Leak:

I found out about this document weeks ago because one of Fed's viewers DM'd one of the Offline TV members with a link to it (technically a prior version to it, there was no update at the bottom / certain private texts were not in the document I saw). I was horrified that a viewer of his had such private messages of mine and I immediately contacted Fed. We spent a couple days talking things through and coming to an understanding on how to handle things. I also informed him how the document was shared with me, so he was well aware of the specific person who was doing this. Over the next few weeks, I would have my close friends and other streamers message me and tell me they were also sent this document (sometimes from Fed, sometimes from Fed's viewer). Every time my privacy was further violated, I would tell Fed, and he would tell me he'd speak to his viewer and have the Google docs deleted. It kept happening multiple times afterwards, making it hard for me to believe that he didn't want this to be shared.

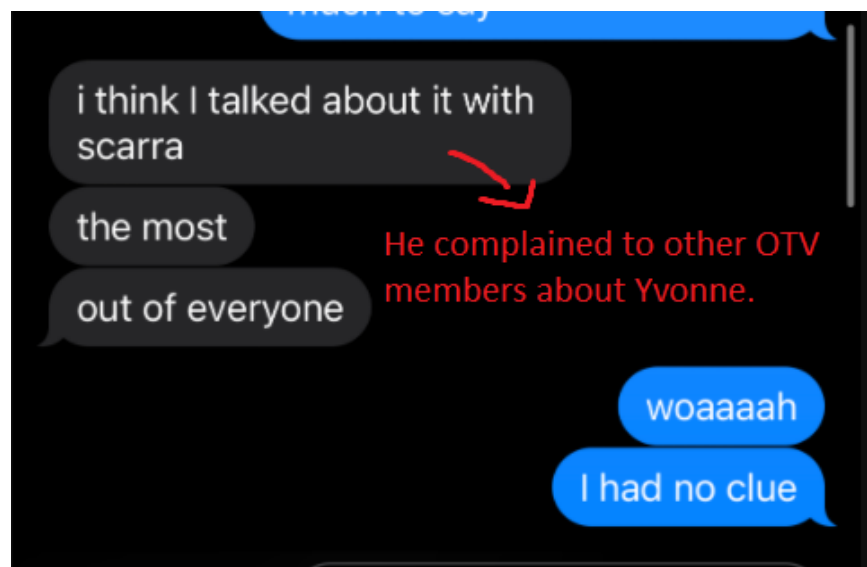
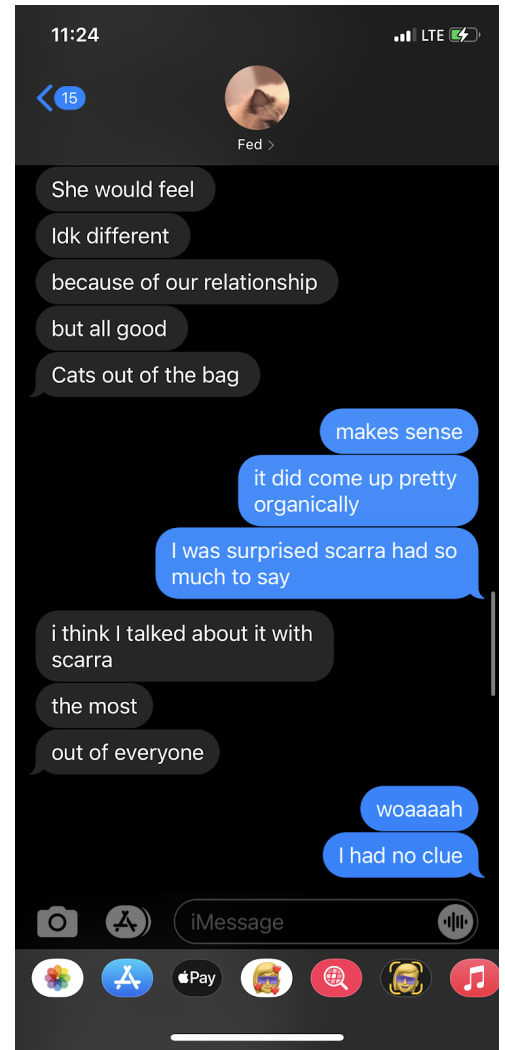
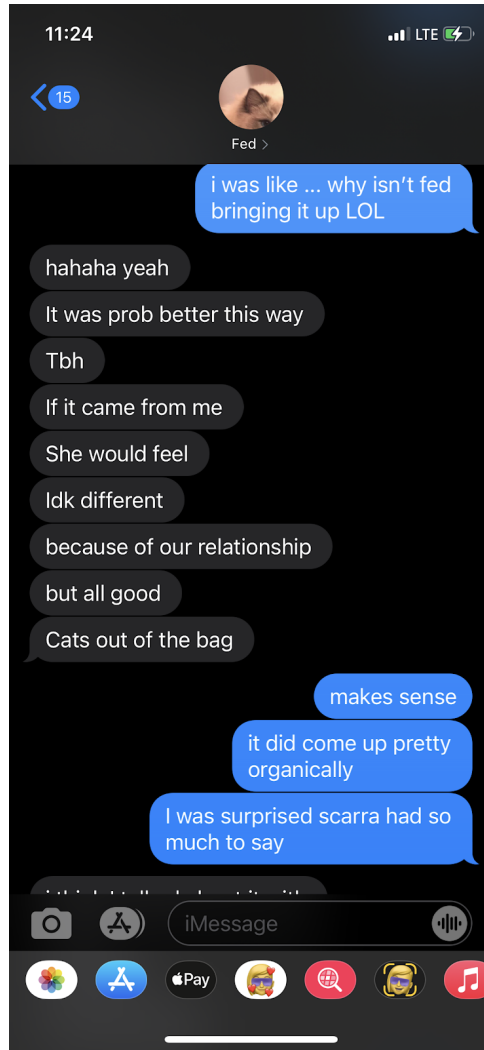
Yvonne/OTV:

I'd like to give context to the messages he included of me talking about Yvonne, since the leaked document attempts to imply that I was plotting against her when this was not the case at all. I'm really disappointed that he would try to publicly pit us against each other, especially since he knows us personally and the reality of the situation, on top of what he's already put Yvonne through. This situation is also heavily impacted by the fact that Fed touched Yvonne inappropriately, which is something that OTV members weren't aware of until later. Please keep this in mind when reading the screenshots involving other house members, because they didn't know and have done everything in their power to help Yvonne since they found out.

Because I was so close to Fed, he would rant or vent to me about others a lot. Yvonne was a sore topic for him where he would continuously complain about her. He would complain that he was taking on her workload and that she would deny his attempts to get her to do work on OTV and stream instead. Looking back at this now, no one can blame Yvonne for wanting to avoid him, but no one knew what Fed did at the time. I've included an example of this below:



These texts were from May 25th 2019, whereas Fed has shared screenshots of things I parroted about Yvonne months later on October 5th, 2019. I was not the only person that Fed would vent to about Yvonne although I repeatedly heard the same thing from him throughout those months. He would also go to other house members to complain multiple times over, which ultimately led to the point of OTV having a meeting to discuss everything. The below texts were after the meeting, and showcase that this topic stemmed from Fed bringing up issues about Yvonne:



As you can see, there were also other members of OTV that were speaking up on behalf of Fed, as it was genuinely because we were under the impression, from Fed, that there was a problem that needed fixing. At this point in time, no one else in the OTV house had the context that Fed had touched her inappropriately.

There was also a different set of texts which show my concern for the lack of work being put into OTV during the beginning of quarantine. At that time, everyone in the house, including Fed (content lead) and Yvonne (house manager), was very focused on streaming, and I was worried OTV was being left on the backburner. To contextualize my concerns, OTV has a history of hiring core employees that later become content creators (Fed, Chris/Pecca, Edison, etc) and I'm genuinely happy for the people who are inspired to create content and are successful. For the overall sake of the OTV company, there are very important roles that need dedication in order for the overall group to function and be consistent. This is why I was worried this issue would repeat itself to the point Yvonne would no longer want to work at OTV.

In Fed's document, he claims he told me what happened between them, but Fed also told Yvonne (and Yvonne shared this in her statement and Dr. K talk) that he didn't remember what happened. I want to make it clear that I did not have full awareness of what Fed did to Yvonne during any of the texts/incidents shown. It was briefly mentioned to me in late 2019, first by Yvonne, then by Fed, that there was an uncomfortable incident that happened between them, but no details were shared with me. I had no clue of the severity or extent of the situation until much later. I learned of the full situation when she publicly spoke to Dr. K and privately in a heartfelt talk with our girl friends.

In my initial stream discussing Fed, I was extremely frustrated because I had just found out what fully happened to Yvonne, and to think back at the times he complained to me about her and I blindly believed him made me livid. The same complaints that almost caused her to be let go from OTV. Even more so than that, I am frustrated with myself for not speaking to Yvonne and understanding her earlier. Given the context that I have now of what Fed had done to her, of course I would have never said those things or wanted her fired. Anyone in her position would have reacted the same way in an attempt to avoid someone who has touched them inappropriately.

Since then, Yvonne and I have talked in private about what I've said and came to a relieving understanding after an apology from my end. I regret the added stress we put her through. I'm so sorry to both Yvonne and anyone who read my messages with Fed that may have questioned her or her work ethic. I hired Yvonne to work with me back in 2018 knowing that she was smart, thoughtful, and an overall pleasure to work with. I then personally recommended her for an in-house position at OTV, and was looking forward to working with her in-person. She has grown into her role at OTV and as a content creator as well, and I'm really grateful for her and everything she's done for us.

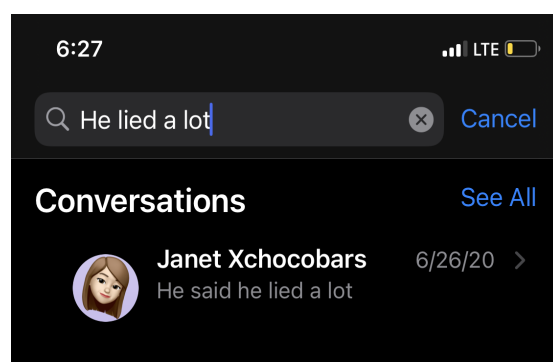
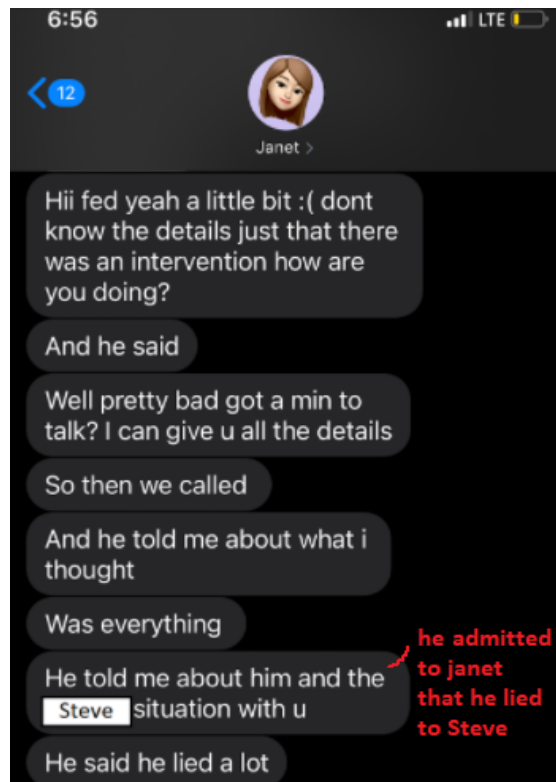
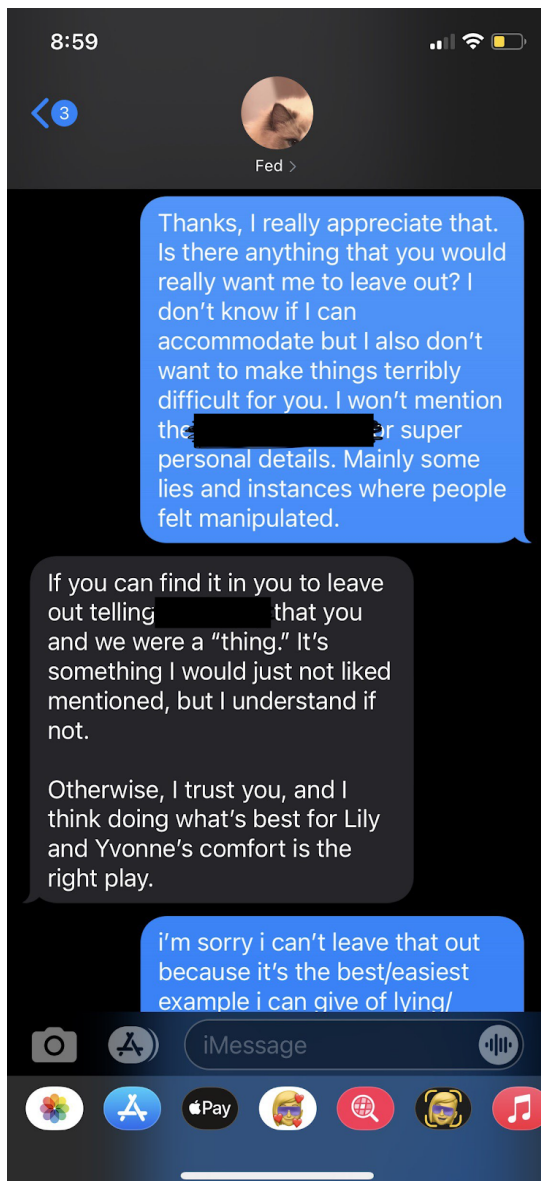
Fed:

Fed was my closest friend for a long time. During the OTV Taiwan trip in February 2018, we became closer, and considered pursuing a relationship (this is where a lot of the flirty texts shown in Fed's document are from). A couple months later, after he visited me in Canada and when we traveled back home together, I told him I didn't want to be more than friends (around May 2018).

Weeks later, OTV held a party where I expressed interest in meeting a specific person, later referred to as "Steve". After the party, Steve confided in me that Fed told him that Fed and I currently "had a thing" and asked Steve not to tell anyone. This really upset me and felt like a massive breach of trust, especially since it happened after I told Fed that I only wanted to be friends. I confronted Fed about this immediately, and he apologized. Also, prior to my stream where I spoke about Yvonne and Lily's situations with Fed, I messaged him to give him a heads up, and he specifically asked me not to bring it up to the public (1). He also admitted to this mistake when speaking to my best friend, Janet, after the intervention (2).

This is why it's so difficult for me to believe him when he just now, years after the incident and months after it became public, attempts to deny it.

Fed has been known to be a serial flirt. This was brought up several times in an intervention we held for Fed where several girls in our close friend circle spoke on situations where he'd crossed boundaries or made them uncomfortable (*the girls at the intervention were all okay with this info being shared*). For a long time, we all thought his flirtatious tendencies were just an innocent and natural part of who he was. I admit and take responsibility for the times that I later reciprocated, and the ways in which this could've complicated our friendship. I would also constantly hear of the ways in which he flirted with other girls and his "ships", and often saw it on his stream as well, which made any reciprocations feel casual and insignificant. It may have been naive, but it was far from how he's attempting to portray me.

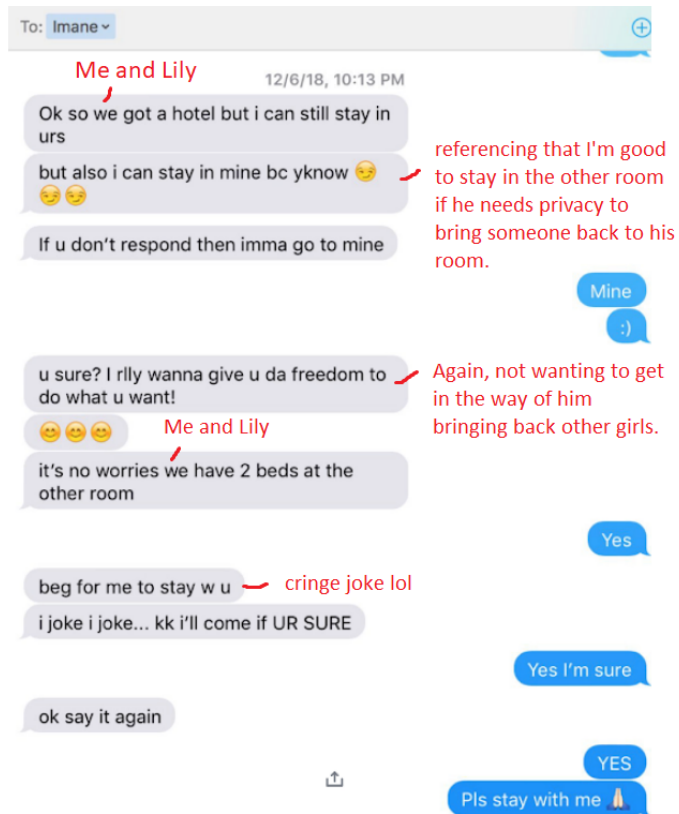
I tried to be transparent about who I was seeing, in a conscious effort to be open and not to lead him on, which I now realize struck Fed as hurtful. I understand it must be tough to move on from someone you live with, but I figured it was better that I was up front and to hear it directly from me instead of hiding it, especially since I would frequently hear of and witness him flirting with and pursuing other girls, even my close friends.

Fed also had a habit of sleeping in the girl's beds (Lily's, Yvonne's, and mine). OTV viewers might remember this because it was something we all spoke of as an odd habit, and we thought the sleepovers were strange, but harmless and just for fun. Fed clearly enjoyed the comfort and intimacy he could find in his friendships with many girls, and I was no exception. Unfortunately, he also had a habit of pushing that boundary not only with me, but with other girls as well, which was difficult for us to properly manage while considering the larger friendship circle and dynamic.

Our friendship was complicated and confusing, and there were times we unintentionally hurt each other. Would it have been possible to "cut things off completely"? Fed was my closest friend at the time, my roommate, and my coworker/talent at OTV. Anytime I tried to reinforce that I just wanted to be friends, we were always in the same vicinity and he would attempt to flirt and push that boundary again. There was massive pressure and encouragement for us to interact with each other on camera, streams, and vlogs. We'd also had several convos, both in real life and over text, pertaining to the complications of our friendship, as it wasn't a one-sided issue. Over time, I learned how to properly draw that boundary, and these issues slowly became less frequent.

Fed included messages of hotel room discussions that were misleading and taken out of context. To clarify, a few of us wound up in Vegas at the same time around December 6th 2018. I was there for a sponsored event with Lily while Fed and some other friends were there separately for fun. I messaged him and told him WE (plural as in myself and the girls) had a hotel room. I wanted for us to all stay together in his much larger room for fun, unless he wanted to stay alone so he could be at liberty to bring any girl home with him. So, all four of us (me, Lily, Fed, Yvonne) stayed together in Fed's room for the entirety of the Vegas trip. To reiterate, Fed

and I never stayed alone. There's photo + video proof of this, and this interaction was not intended to be romantic or suggestive nor did anything happen between us. If anything, I feel it shows that I was encouraging him to see other people and wanted to make sure I gave him enough space to comfortably do so (referencing the text where I say "but also I can stay in mine bc yknow").



(Fed wasn't in this group shot, but Yvonne and Lily can also confirm that we all collectively stayed together in his hotel room for this trip.)

It's extremely frustrating to see so many private and old incidents misrepresented to intentionally favor him. It's also difficult to properly show my perspective without further invading Fed's privacy or other girls' privacy. I hope that anyone reading this can try to be understanding of that.

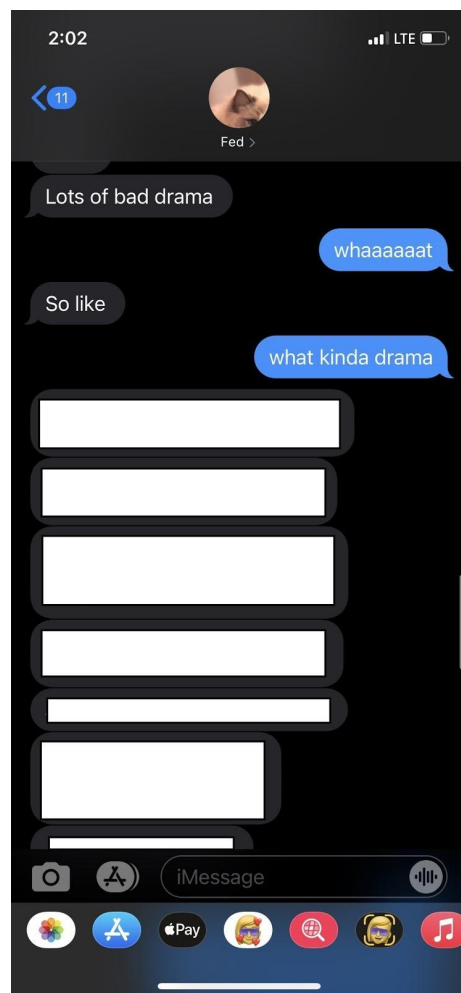
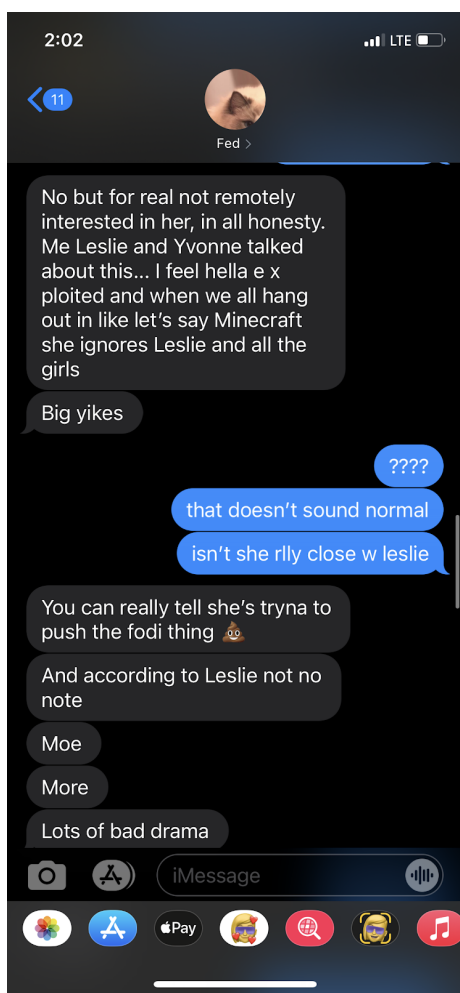
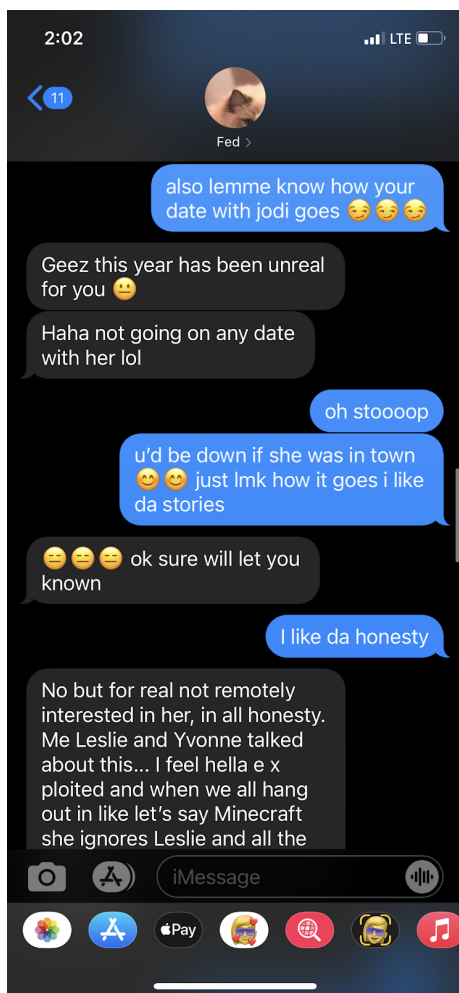
In summary, I hear a lot of hurt feelings in Fed's statement when it comes to our friendship. I cared about Fed a lot and wouldn't have wanted to hurt him. His feelings are valid and a good reminder to me that what one person thinks may be going on in a friendship, don't always match up with the other person's expectations. Looking back, I would've done a lot of things differently, and know for a fact that neither of us handled the situation perfectly. However, our private convos heavily lacked context, and I'm not okay with how they're being misrepresented.

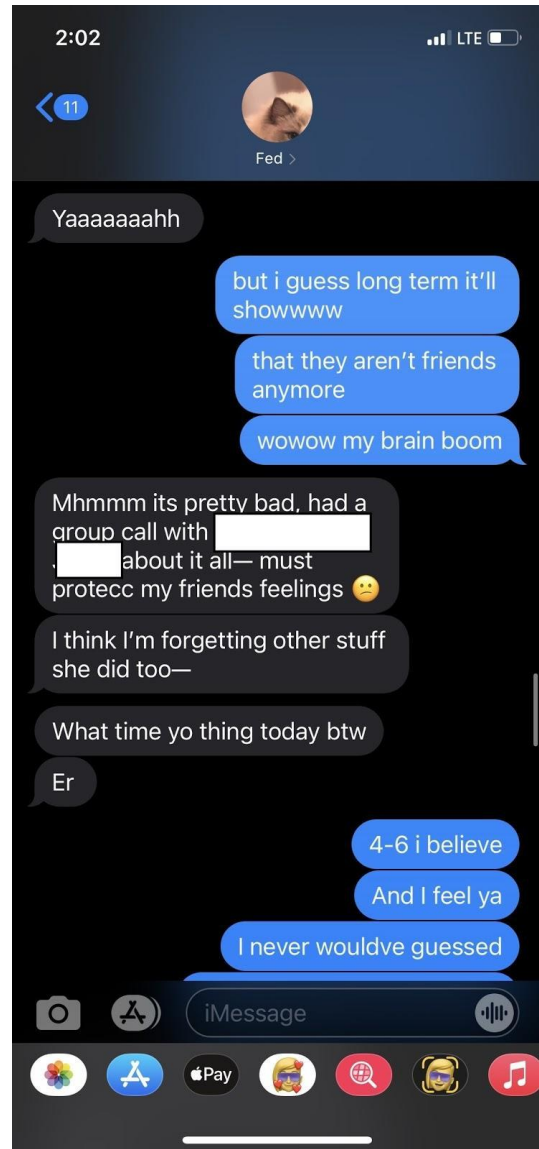
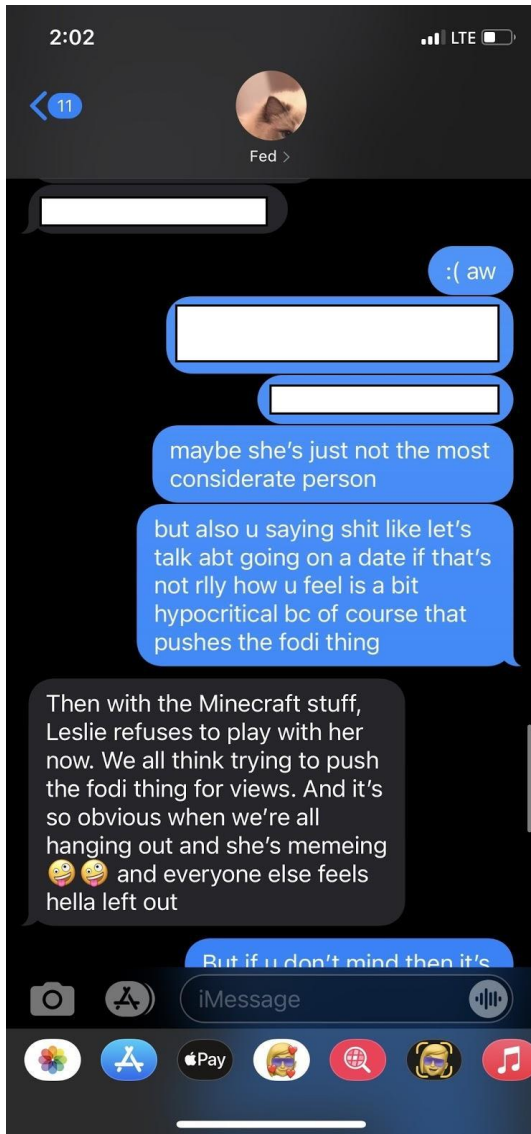
Jodi:

The way Fed framed my conversation with him regarding Jodi is extremely one-sided. This is something that Jodi and I have talked about privately weeks ago where I've owned up to, and apologized for the messages. Looking back at these texts, I'm ashamed that I wrote them and I feel terrible about the things I've said.

The two pieces of context I'd like to provide are that 1) earlier that day, I was under the impression that they were going on a date and was being supportive and 2) the things I said about Jodi are essentially me parroting Fed's opinion of her, which he also shared with me earlier that day. They were also a result of my perception of her being skewed and negative because of the info he gave me about how he felt "exploited" by her and my poor choice to believe a rumor. Below I've included the conversation I had with Fed prior to what I said about Jodi for more context:

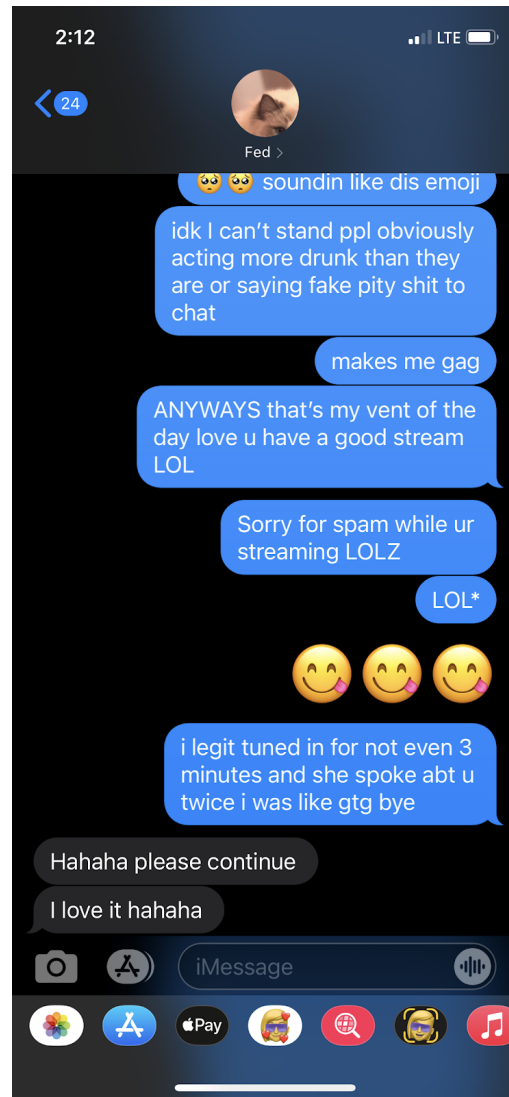
**Please note that some of the text/names have been removed out of respect to my friend's privacy. Some text messages have been blocked in order to not rehash unnecessary drama that has been resolved and is unrelated to me.*





He told me much more, but I feel there's no use sharing more texts of past drama, and I want to avoid doing so out of privacy and respect for my friends. The conversation ended with me being very surprised (last texts shown), and my perspective of Jodi being very skewed and negative out of concern for Fed saying he felt "exploited". Furthermore, as the morning texts show, I was trying to be supportive and foster a friendship where we could be more open with each other and able to talk about the people we're seeing.

Later that same day, I heard Jodi speaking about Fed on her stream, and having heard all these negative things about her from him, I had a very skewed perception of everything she said. Here is his reply that he intentionally left out from the screenshot, showcasing this was not a one-sided exchange and that he was encouraging it:



Proof these messages happened on the same day:



This is a very familiar pattern for Fed that I, and many other friends, spoke about. It's something I specifically called him out for in my first stream, and directly to him at the intervention. He would spread doubt and rumors, egging people on to think negatively of each other and dividing people up. I don't know if this was intentional, but it kept others apart and Fed as their main confidant (ex: <https://livestreamfails.com/post/86556>).

I hope the screenshots and added context shows how disingenuous it was of Fed to attempt to frame this conversation as me being possessive of him. Regardless, I really regret having spoken of Jodi in this way, and am so happy that we were able to work through it. It also taught me a valuable lesson in not only who to trust, but taking opinions with a grain of salt.

Conclusion:

Ultimately, my complicated and volatile friendship with Fed had no part in why he was kicked out of Offline TV and such private details never needed to be public. It has been extremely jarring to have my privacy violated by someone I trusted for so long. Out of respect to my friends who are mentioned in these convos, they were all shown the texts and were of course given the option to decline any convos from being included. If any parts of the convos were blocked, I have done so to maintain privacy for them and will not disclose that info. I hope this context shows my side of the story and helps put this to rest.

Note:

This is posted to my alt account because so much personal info has already been shared. I would like to clarify my side of the story and not bring additional attention to these past issues. I know many other people will probably cover what happened, but I'll be doing what I can to prevent personal matters from going public again.
