DURING OBSERVATION

What is the initial appearance of the SCP(s)? Does the appearance have any development or notable difference to their standard appearance?

Upon first sight, SCP-096 fits the usual look of the anomaly. It has multiple gunshot wounds in its middle chest and back, piercing into the body. It also has bloody hands from previous killings. There are no differences or developments from its prior appearance, with no changes to any aspect of its looks.

How is the condition of the containment of the SCP? Does it suit the SCP and its needs?

The containment chamber of SCP-096 is as standard, with no damages and equipment on standby for any emergency repairs. There are boxes located around the room, presumably holding supplies for the recontainment of SCP-096 or repairs. SCP-096's primary containment box is located in the middle of the room and has no visible damage to the outer shell. SCP-096's containment chamber is suitable for the holding of SCP-096, however could do with a few improvements, which have been proposed already.

### **How does the SCP behave throughout the observation? Are there "modes" or "phases" to examine?**

SCP-096 behaves very hidden and out of the way during the observation. During the period of observation, it tends to sit down and cover its face in corners and locations where it is far away from foundation personnel. For example, SCP-096 sits in the back left corner (from the viewing room), inside its box and in the middle of its containment to the right of its box. These are all natural behaviours of SCP-096 whilst it is alone, unaware of spectators and without disturbance. SCP-096 stayed in a depressed state of emotion for the entire time it was left alone.

Once a member of Crimson-9 entered, SCP-096 initially remained in a depressed state of emotion. After the Crimson-9 spoke to SCP-096 a bit, SCP-096 began to trust it and allow them to speak to it and reassure it that it's alright. Although SCP-096 trusted Crimson-9 enough to be around it, SCP-096 didn't trust Crimson-9 enough to move locations with it. SCP-096 remained in a depressed state and remained sitting in the back left corner of the containment chamber. SCP-096 also refused to allow the Crimson-9 Agent to be in its line of sight. When the Agent stood in its line of sight, SCP-096 picked them up and placed them behind it before sitting back down and facing the corner.

During the majority of the observation, SCP-096 seemed to only enjoy sitting in the back left corner of its containment chamber. This may be due to its distance from the viewing area and entrance to the chamber. Additionally, SCP-096 remained depressed during the entire duration of the observation, not becoming any happier than when it started or becoming sadder - its behaviour was continuous. SCP-096 also, oddly, did not wish to receive any hugs or listen to music. This is odd as SCP-096 enjoys hugs and music as it calms it.

### **If the SCP is able to communicate or express a voice, how is their tone towards staff?**

SCP-096 does not have a voice to verbally speak to people or other anomalies, however can speak via limited sign language that SCP-049 taught. SCP-096 did not use sign language to speak to any foundation personnel during the duration of this observation, remaining still.

### **If given Class-D, how does the interaction develop? Is there anything notable to acknowledge?**

No Class-Ds were provided due to the current mental state of SCP-096 and risk to site operations. No information available to provide.

### **Did any emergency, or close-calls, ensue? If a breach occurs, how is the aftermath and general behavior throughout the breach? What was the issue that caused the emergency?**

No, SCP-096 was calm the entire time and only roamed its containment alongside allowing Crimson-9 to reassure it.
