SAU#9's COVID-19 Testing, Quarantine and Isolation Procedures

Updated January 7th, 2022

The new CDC and NH Department of Health & Human Services recommended guidelines are in effect for SAU#9 schools, bringing shorter quarantines and isolation periods, as well as a decreased demand on testing centers.

What has changed?

If a student or staff member tests positive for COVID-19 (either by home antigen test or by clinic administered PCR test), they are required to isolate for **5 days** and will be eligible to end isolation on day 6, as long as their symptoms are improving and they are fever free for 24 hours without fever reducing medication.

In addition we strongly recommend the use of a home antigen test on day 6 prior to returning to school. Positive results of this test will indicate if the student/staff member is still contagious.

As reported on January 5, 2022, by Dr. Chan, NH DHHS, CDC reports that 31% of COVID positive individuals continue to be contagious between days 6-10. Please continue to be vigilant and keep yourself and/or child home if they are still sick or testing positive via a home antigen test. This will assist us in keeping our schools open. Thank you for continuing to support our in person learning environments!
