Vendor Application Information

Thank you for your interest in being a vendor at the **Great American Truck Jam!**

Vendor spaces are limited. All applications are juried and reviewed on a first-come, first-served basis.

Booth Pricing (Includes Both Event Days)

Early Registration (on or before May 31, 2026):

- 10' x 10' Booth — \$250.00
- 10' x 20' Booth — \$300.00

Standard Registration (after May 31, 2026):

- 10' x 10' Booth — \$280.00
- 10' x 20' Booth — \$330.00

Community Table:

- 10' x 10' Booth — FREE (limited availability)

Electricity:

- \$40.00 additional fee (must be requested and approved at time of application)

Event Schedule

- **Setup Begins:** Friday, August 7th at 11:00 AM
- **Breakdown Deadline:** Sunday, August 9th by 10:00 AM

All vendor spaces must be **completely cleaned before departure.**

Payment Policy

- Sites are not considered secured until full payment has been received.
Checks should be made payable to *Jeff Bursey Motorsports* and mailed to:

- We can also accept Venmo or Paypal. Please message us if you would like to choose this option.
- Payment is due within 15 days of the application approval. If payment is not received, the application will be considered denied and you will need to reapply.

Vendor Rules & Regulations

- Vendors must stay **within their assigned booth space**
- No encroaching into aisles or neighboring spaces
- Booths must be **clean, organized, and professionally presented**
- Vendors must provide their own:
 - Tent (EZ-up) with proper tie-downs
 - Tables, chairs, and setup materials
- All tents must be securely anchored or will be requested to be taken down.

Parking

- No vehicles allowed inside the vendor areas
- All vehicles must be parked in designated parking areas outside the area.

Weather Policy

- Event is **rain or shine**

Refund Policy

- All vendor fees are non-refundable at any time.

Conduct

- Vendors must act respectfully toward:
 - Guests
 - Staff, Volunteers,
 - Other vendors and all attendees

Prohibited Items

- No illegal, dangerous, or inappropriate items
- Vendors may only sell approved items listed in their application

Liability

Event organizers and the Fairgrounds are **not responsible for:**

- Lost or stolen items
- Damaged property
- Weather-related damage
- Injuries within vendor space or the venue

Vendors participate **at their own risk.**

Media Release

- Vendors agree that photos/videos taken at the event may be used for promotion
