a. Report of the Chair

- i.) Lee - Vice Chair Smith and I met with President Morishita and Cabinet to discuss COVID-19; we agree with the President this will be the topic for this meeting
- b. Report of the President

- i.) Morishita Thanked Senate and leadership for passing authority to permit faculty teaching non-online classes to move in that direction if needed; extensive conversations over the weekend and yesterday with presidents and Chancellor's Office (CO) about COVID-19 progression; different points of agreement on what will occur in the future; campuses spread out across the state; listening to local public health different in many areas; not all public health departments are in agreement; close continuous contact with Alameda County Public Health and Deputy Director of CA Public Health Department; scenarios and guidelines were made for higher ed institutions; Stanford had a confirmed researcher/faculty member on campus, is being treated, and the undergrad researchers were quarantined courses moved online; Stanford is a highly residential campus
- ii.) Morishita Cal Berkeley closed yesterday out of the blue without notification to other institutions; San Francisco and San Jose State closure notified at 5 PM yesterday; contacted the CO; no logical or rational reason from the Health Department that campus closure will aid us; this is where the dilemma occurs; how do we return to "normalcy" if we do close when there are no logical or rational reasons from the Health Department
- iii.) Morishita What are you thinking? (asked around ExCom)
  - (1) Glass Personal opinion is why are we shutting everything down and there is a sense of pressure; if we were to move online it would be outstanding to explain the process and dispel rumors and return to campus on a specific date; notion of moving online will only send information about what they should be needing; synchronous meetings during class meeting times with requirements; links generated to Zoom to provide guidance; anything the University can do to set up an infrastructure
  - (2) Wu Nothing to add; meeting is next week for ASCSU
  - (3) Lee Outreach from ASCSU senate chair to provide examples of what we are doing (19-20 BEC 8) about how governance may shift to being online; desire for good models and leadership
  - (4) Smith Reading the CA Health Department guidance and we do not meet the criteria; concerns about rumors and share concern about what the next steps are; something should be said student disruption issues and students not showing up



- (5) Carpenter External pressures may force changes; Pearson shutting down teaching credential testing; concern about having spreak break a week early and a week longer
- (6) Glass SJ State canceled classes this week for faculty to have time to prepare then restarting online
- (7) Ganesh 50% students in class today; some had to take care of others and some are scared to come; looking for direction of what if, when, daycare closure, other concerns and a lot of uncertainty; good not to switch directly to online, some prepared and some not prepared; few days of lead time would be helpful
- (8) Mitchell Directs an online program and does not directly affect; reasonable and conscious decision; concern of lawsuits of people who said they got sick here
- (9) Morishita Unsure of litigation concerns about people coming to campus; not as concerned about legal issues as health and safety
- (10) Pollock In Art, started to prepare a while ago and have bleach wipes to wipe down work station in every class; went into effect on Monday; activity based work can assist in reducing anxiety and concerns; fire issues in the past with hy-flex (hybrid flexible) augmented with synchronous online presence; people can opt in and opt out; important model for life contingencies; model that we can look at and embrace in the future; can accommodate a heightened sense of anxiety; SF has a policy recommended that all events are canceled; 20 students in a classroom with computers; 3' distance between people implemented; 65 people in a room with 90 maximum; possibility of spread much greater; what can be canceled with engagement online via breakout rooms; trial runs this week to make sure students understand how to use technology
- (11) Lee Cancel means ending a class/events, versus changing a modality
- (12) Rippy Student concerns today about living in a multi-generational family house and sickening elder family members; concerns about equity for students who do not have laptops or internet availability
- (13) Lee CSUEB can be a sanctuary under the right control and circumstances; daughter's math class is canceled and unsure of context; in AGES tried to get ahead of things; asked the Online

Campus to create an organizational shell to help each other develop online coursework to assist others in moving to online if needed; can be creative and faculty can pool expertise in creative and positive way in response to the negative occurrences that may occur in our community

- (14) Newcomb Echo concerns about uncertainty; support needed for conversion; like the idea of stepping down to prepare; the Online campus is ready and prepared but not sure of the impact they will face; overall the level of external and internal uncertainty
- (15) Wu Is there a way for faculty/students to report they are being quarantined or report confirmed cases? Can assist with campus response
- (16)Morishita - When the announcements came out, there are disturbances to community colleges (CC) across multiple counties; conference call with 7 CC and are in the planning phases of what will occur; Chabot College is still having a symposium in Sacramento and will continue to meet; student concerns are secondary effects of exposure; wanted to have a reason to do something outside of sister campuses transitioning to online courses; would include 2-4 day period with continued online courses and a retooling period for courses that will go online. Cal Berkeley said that certain courses could not go online and require interaction which can still occur; advising can still occur via phone and Zoom. The campus would not be closed; no campuses are closed; staff will continue to be required and faculty can still be present on campus for office hours or teach online from their offices; changing the modality lessens the number of people on campus at one time; work will still be done online and some work can be moved online if its warranted; mitigating the interactions that occur and have containment in that way; part of rationale in future messaging; ASI meeting this morning - will not cancel all events but will be cautious; would not cancel Faculty/Staff Donor Lunch next week; what has troubled the most is the possibility that we might not be able to have commencement; what is the precipitating factor that causes this to end? Cases will continue to be identified and the numbers will go up; when will we return to "normalcy" since we are not driven by specific threats/concerns



- (17) Lee Message is consistent with understanding of keeping lids on situations of mechanisms; if triggering the instructional emergency allowing for a nuanced or triaged approach with different types of courses; with the message being aligned with reducing risk for our community; can control level of risk and collective behavior of the institution; university can still be a resource if their community is affected; students can still access campus, the library, and other resources; it would be rational, measured, and sending the right information to the community; would be helpful if external factors were to make the decision to transition to/from online only; would revise at certain milestone dates
- (18) Morishita System-wide guideline to have rolling milestones for assessment to determine if continuing with certain modalities; would likely need to be for the remainder of the spring semester
- (19) Lee As faculty, we can discover issues that may resolve; concerns with exams week online or in person; can be challenging for online exams
- (20) Morishita Systemwide contract with Respondus for exams
- (21) Lee Faculty may want some clear structure and instructions with guidelines; faculty like to have some choice to navigate things; will need railings/guides to work collectively with administration for guidelines possibly hy-flex or other models
- (22) Smith One related issue is still having staff and faculty here; if symptoms are present to send those with symptoms home; needs guidance for sending people home
- (23) Lee Respect people's privacy and help to provide information about sending people home; beneficial to community is note people to send guidelines; may not have family support; send to health services
- (24) Pollock Counter energy and systematically diminished as an issue; asymptomatic infection/incubation; transmission already occurred; a lot of people saying this is just a flu; may not
- (25) Rippy Some people may come into work because they do not have sick time
- (26) Morishita Topic of lack of sick time has been discussed
- (27) Lee Use of catastrophic leave to pool hours to cover pay



- (28) Lee Special reach out to those in different subgroups affected by campus transitions
- (29) Morishita Real pressure of 3 public institutions that have closed campus; frustrating that there is no rationale for closure of other campuses
- (30) Newcomb Behaviors and behavioral change is not easy to manage; decision will affect faculty and students; some students take on-ground courses because they like on-ground courses; transition needs to be for periods of time
- (31) Morishita 4-week cycle of review; will be made clear to all stakeholders
- (32) Glass Helpful to have guidance for the institution of percentage of time expected to be synchronous for office hours; office hours should continue as stated on your syllabus; students should have same message to get from their instructors
- (33) Mitchell For online program, Blackboard shell has Zoom link for online office hours and very easily accessible
- (34) Morishita 15% of faculty not on Blackboard
- (35) Dobb Less than 50 faculty did not have a syllabus online
- (36) Pollock Support Glass's comments; if we go off schedule all bets are off; should continue to have a schedule; should continue to be a norm and need to change the schedule to petition for change if needed; had a fully online session on Monday and students showed up; publish Google calendar with Zoom link and meeting room; can subscribe to
- (37) Morishita Concord campus can be available for people who live closer; and the Oak Center
- (38) Glass Should be a calendar with IT to assist with the transition
- (39) Smith Concerns of crashing the network
- (40) Morishita Working to determine ensure bandwidth is available
- (41) Glass Online campus links are helpful
- (42) Lee As faculty, we should look after ourselves and keeping a high quality and maintaining opportunities for success for our students as we transition to our modality of being socially distanced does not mean that we are in an asynchronous

correspondence course; classes take place as usual during normal class time; coming from all levels of the university and write into the language of the instructional emergency

- (43) Carpenter Instructional integrity and synchronous; concerned about how to message this with staff when staff are required to be present and faculty are not; can cause resentment with staff
- (44) Lee One can argue that unless we have a reason to be off campus, such as self-quarantined, we are serving the community and should be present
- (45) Glass Has said that the safety implications is due to gatherings of a large number of people; advising and other items do not meet the standard of limiting large gathering
- (46) Smith In this model, we have been discussing labs and activities can continue
- (47) Pollock When he was doing the session on Monday, think about the mode of instruction and what can be learned; thinking about beginning to embrace what this is versus castigating this process as a stop gap; can possibly do synchronous online activities during University Hour something outside of a panic move so it does not become a negative
- (48) Morishita Other part of faculty being successful in online work to assist other colleagues to make adaption and make as robust and engaged as possible
- (49) Lee Quick, rapid response where people are looking for information to share information about what people are doing in different departments to showcase the work being done
- (50) Mitchell Aside: Style of learning that we refer to closed matchbook learning before the match strike
- (51) Glass Whatever % of classes need to be held synchronous; what about students who do not have access
- (52) Pollock Reduction in numbers and the creation of distance; if you cannot access Zoom reliability, you can come to campus for the lab
- (53) Lee With days to prepare, we can address these issues and can predict 95% of questions and concerns
- (54) Pollock Italy is 1 meter distance

## c. Report of the Provost

- Inch Dobb and personnel working with students for educational needs; i.) synchronous courses and providing access to all students; petition students are circulating with 2000 signatures that they want the campus closed, likely means not coming to campus, the science tells us this is not a high risk area; Alameda County Public Health states it is reasonable to continue to have courses, not medically necessary to close campus; campus closure nearby amplified fear; because of fear our students are not opting to come to class without receiving access to material; CO confirmed health and safety of our stakeholders as well as receive quality education and allowing students to graduate on time; worse thing that could happen was a note from a student that people are just waiting to get sick to close campus; fear is palpable on campus; on the positive side there is an opportunity here; issues relating to fire, smoke, earthquakes in the future; notion of having a fall back to transition to attend to an alternative method to attend class and how to build the infrastructure; has been impressed with hour resilient our faculty and staff have been to help and not panic; first goal has been around students
- ii.) Glass Communication out to students and faculty or will faculty be asked to communicate with students directly
- iii.) Inch Obtaining information about courses that will need to change modality; in the notification will be a requirement for synchronous learning, will go out centrally and faculty should reinforce; Deans working with definitions; C1-6 are lecture and seminar; C7-11 are activity and may not easily be moved; supervisory courses cannot be moved
