### Notes:

- Involvement in training at the national and European level: recent developments
- DANS: focus on reusability of research data, including quality of scientific research
- Support: Dataverse platform, EASY platform, Narcis + training and consultancy
- EASY (long term archiving): for all disciplines/domains. 2022 launch of various data stations for richer metadata and better interactions with domain portals. Dedicated managers for each of these data stations
- Training activities: resources, courses, Europe
- 23 things for research data: new topics to the original RDA 23 things resources; for different audiences. The tool provides answers to many questions/includes many topics and audiences
- Training course: <u>Essentials 4 data support</u> Free online version available with extensive content or paid version with personal guidance and (online) training sessions. Bilingual.



- New module on GDPR issues; pilots were done last year (in Dutch first, English version planned); <u>materials</u> will be available soon
- <u>CESSDA DM expert guide</u>. Designed for social sciences, but is also relevant for a broader audience. The DMEG also has a train-the-trainer package with reusable materials: <u>www.Cessda.eu/ttt</u>

### Questions:

- Heleri (no question, just remarks): 23 things, Essential 4 data support and CESSDA materials are very good. I always consult them when writing my teaching materials. Helis Course was also one of my favourite courses on Data Management and in 2021 in general. If you have a chance, I recommend participating.

- Philipp: How do the DANS Data Stations relate to domain-specific repositories?
  - The data stations are domain-specific repositories using documentation
  - standards etc from specific disciplines
- DANS data stations: what happens with datasets crossing disciplines?
  - The data stations will facilitate findability in all relevant domain stations
- Do you have the specs of the new data stations or is it similar to EASY?
  - Next year, more focus will be on the data stations including training on how to use it
  - Data stations will be based on the Dataverse technology (open source, group)
     Features will be similar to EASY, but more tailored to each domain (e.g., in metadata fields available)

### Notes:

- Many resources on RDM, less so on GDPR
- Many institutions make their own, is it difficult to find other resources?
  - There are also already catalogues / toolkits to cluster resources
  - Teaching materials are often more difficult to find/reuse
- Dorien Huijser in chat: I'm not sure it can be prevented that institutes make their own information, since each institution may have different guidelines/policies and some disciplines may require tailoring of the general RDM information
- Fieke Schoots in chat: In the context of the Digital Competence Centers at The Netherlands, it has also been discussed to have this overview of training materials. It is essential to have good (FAIR;-)) metadata for the materials to make it really useful
- EOSC Future training
- Cees: More thematic initiatives are making training catalogues
  - Fieke: we need coordination on all these initiatives! +1 (Mijke: maybe via the upcoming thematic DCCs, as coordination is one of their important roles? Can we put that in their agenda, as well as on the agenda of RDNL?)
- Ilja: Working on a metadata schema on how to make (meta)data FAIR, but researchers are reluctant. They do find it important but not very rewarding
  - Ricarda: This should be done collaboratively in a broader context to lessen the burden on individual researchers. RDA groups, or EU projects. It's not only work for researchers/data stewards/universities, but archival knowledge and infrastructures also have responsibilities and should be included
  - Petra: LUMC uses Dublin Core, but are looking into moving to CEDAR template for some more information (and to comply with ZonMw requirements in the future) → https://www.gofairfoundation.org/m4m/
- Most upvoted note on missing: A full learning path for the data steward, to link competencies with courses that match those competencies
  - Is being worked on. The formalization of Data Stewards is work in progress in the Netherlands. (Project NPOS-F: <a href="https://www.openscience.nl/en/projects/project-f-professionalising-data-stewards-hip-competences-training-and-education">https://www.openscience.nl/en/projects/project-f-professionalising-data-stewards-hip-competences-training-and-education</a>)
  - Philipp: Comment on formalization: In Norway, we are currently working on a national skills framework for research data management



- Celia: What to do with international requests made to national initiatives to help in teaching data management and data stewardship? Maybe it's a possibility to use the DSIG group as a pool to reply to these requests? To dispatch members of this group with specific expertise to specific events/trainings
- ELIXIR is organising material generating hackathons in the near future, for instance on creating resources for deep dive into FAIR and also a Train the Trainer on FAIR. I will share them with you on the <u>slack channel</u>. Participation from Dutch partners (in various disciplines, also beyond the life sciences focus of ELIXIR) is very welcome, and of course you can also benefit from the outcomes and reuse teh om your own organisations


