We are preparing to start our next “Leawood Gymnastics Program”. We are excited to invite West Jeff students this year. We know it is a drive down the mountain, but it is such a great opportunity. Gymnastics is a sport that can help build strengths in many areas, as well as increase overall personal health and well-being. Our kids develop so much that it is really exciting to watch their success. Our schedule may need to change after the first or second week, because of numbers and/or safety. We usually have a very large number of participants, and we want to make sure all students have opportunities to grow and succeed. One of our coaches, Mr. Lupo, comes back every year to work with our gymnasts. He is very popular with our kids as he keeps us all very excited and we are always so thrilled to have him and his expertise to help our kids. We missed a year, so we will be playing catch-up in our skills and development.

If the schedule does not work for you because of other activities, let us know and we may be able to have your child attend a different session. Missed sessions due to school closures or holidays maybe be able to be made up with another grade level. This program will end with our last session on March 18, 2022. If your child shows advanced development, I may ask you to allow us to move them up to an upper grade level workout. As a reminder, all practices are held at Leawood Elementary, 6155 W. The fee for this program is \$35.00. We have been able to buy much needed equipment with these fees over the past years. Please have your child bring a healthy snack and water for each practice. Please have your child dress safely for these sessions: hair ties for longer hair, t-shirts, and no jewelry. For your convenience, you may pay online via Infinite Campus. Please save and follow the schedule attached. PM times are 4:00-6:00 pm. Students must be dropped off and picked up at the East gym doors at Leawood. Parents will not be allowed into the gym due to restrictions from our Covid situation. Students may not participate without a permission slip and proof of payment for the program.
