Coordinated and clear communication is vital to supporting a student/family in crisis. In the case of a student behavioral or mental health emergency, school staff should always first alert the site administrator. Typically the school social worker (SSW) and site administrator would work together to determine next steps including whether a Rlsk/Threat assessment is needed, whether outside agencies should be contacted for support, and when/how to communicate with caregivers.

- If a student is hospitalized or attends the Edgewood CSU program, usually the SSW or school psych coordinates with hospital staff, program social workers or guardians to obtain the discharge plan. The discharge plan may result in changes in the student's 504 or IEP.
- If the student has an ERMHS clinician, they should be alerted about any behavioral and/or mental health crises to ensure their treatment plan addresses the concerns. They also may opt to make referrals to Wraparound services.

Crisis Resources for Schools

Child Crisis

- 415-970-3800
- Provides a 24-hour, multilingual, crisis intervention and short-term stabilization program for families and children who are experiencing emotional distress related to family violence, physical or emotional illness, school truancy, behavioral problems and other crises.
- All staff are licensed clinicians or interns and can provide evaluation for 5150/5585 for hospitalization and set up referrals to Edgewood CSU or other placements for evaluation
- Child Crisis cannot provide in-person de-escalation services for crisis behaviors to schools or families (would refer to call 911)
- Schools or home-caregivers can call for 24-hour support

Seneca Mobile Response Team (MRT)

- 877-305-8989
- Seneca MRT serves a 90-mile radius and can provide intensive short-term stabilization with linkage; link to flier <u>HERE</u>
- MRT's trained counselors can provide phone in-person de-escalation services for crisis behaviors, but they cannot evaluate a child for 5150/5585 or refer for evaluation; sites would need to contact Child Crisis or direct call to Edgewood CSU

Wraparound Services

- Wraparound services can support students and families needing behavioral, mental health, and social services. Wraparound services are provided through the Department of Public Health (DPH). Agencies that provide wrap services are OTTP, Seneca, Edgewood, and Family Mosaic Project.
- How to refer? Referrals are made through Child Protective Services (CPS), Foster Youth Services (FYS), Probation, or through outpatient clinics. If a student has ERMHS, the provider can make a referral and presentation to the Risk Level 2 Panel. *In some cases*, a school social worker can make the referral.
- What are other short-term supports for families? In lieu or in addition to wraparound services, teams/providers (i.e., ERMHS provider and/or SSW) could make a referral to access mental health services, including:
 - Edgewood Therapeutic Behavioral Services (TBS) not a standalone service, so student needs ERMHS or outpatient services through DPH to refer; MediCal only (LINK)
 - Seneca Mobile Response Team (MRT) school social workers can refer directly (see above)
