

Tenant Fee Schedule

Below are the agreed upon tenant fees to offset the expense that each action may incur.

Should a court find any clause in this document unenforceable, the remainder of this document will not be affected and all other provisions in this lease will remain enforceable.

Lease Processing - \$229 one time

To prepare and facilitate the lease signing for all tenants. This includes a Move In & Move Out Property Condition Report with complete with Photos. Typically 50+ pages of photos depending on the size of the home.

Tenant Benefits Package - \$35 monthly

- Credit Building through Positive Credit Reporting
- Air filters for the entire home will be delivered on a set schedule.
- Lockbox Move In & Move Out. This allows you to access the keys AT the property and on YOUR schedule.
- Online Rent Payments via the Tenant Portal is Included
- Online maintenance requests are included
- Utility Concierge Service

Physical Check Payment Processing - \$5

Charged each time a payment is processed using a physical check or money order mailed into the office.

Pet Administration Fee - \$49 per pet or cage

One time fee per pet or cage added to the lease

Pet Rent - \$35 per Dog or Cat

Will be added to the monthly lease amount. This is to cover additional wear & tear caused by pets.

Lease Modification - \$49

To facilitate the communication and document prep in the event tenant(s) desire to change their lease, such as adding / deleting roommates, etc.

Stop Payment Fee - \$50

In the event a tenant requests Bluefax PM to stop payment and reissue another check due to no fault of Bluefax PM. Typically for lost checks, etc.

Tenant Fee Schedule

Certified Mail Fee - \$24

In the event Bluefax PM is required to send a 'Certified Letter' to the tenant, such as non payment of rent, failure to respond to Phone or Email communications within a reasonable time, or other negative reasons.

HOA Violation Notice Fee - \$19 (First notice is at no charge)

This fee is to be charged anytime Bluefax PM receives a notice from a Home Owner's Association about a rules violation. The most common reasons for receiving a notice are for not cutting the grass in a timely manner, weeds not being treated (different from not being cut) and trash cans / other items stored within public view.

Make Ready Documentation & Coordination - \$195

In the event property is returned not 'Rent Ready' and Bluefax PM has to document and coordinate the make ready/repair of the unit. Normal wear and tear alone will not trigger this charge.

Notice to Vacate (Eviction Filing) - \$79

Charged in the event we have to physically post a Notice to Vacate a property due to a Breach of Lease, such as non payment of rent. Owner reserves the right to seek all reasonable and necessary costs to evict tenant(s), including attorney fees.

Failure to Return - Keys \$25 / Garage Remotes \$49 ea / Gate Remote \$49 ea / Pool Card or FOB Cost + \$19 processing

In the event tenant fails to return the keys/remotes/pool cards to Bluefax PM at move out

Court Appearance - \$125

In the event BluefaxPM has to appear in court for any reason regarding your lease. This in addition to any associated court costs or other legal fees incurred.
