

FLIPPIN-RAD Terms of Service

Please feel free to reach out with any questions!

I've included a brief TLDR at the end but keep in mind that you are still bound by the terms regardless of whether you read carefully or not.

What I will draw

- Almost anything! Yes, even that kink. Unless your characters are underage or the prompt includes hate and/or explicit content of real people, groups or animals, I am happy to try it.
- Some things (like cityscapes, detailed mechanical characters or complicated clothing) may incur additional fees for complexity, but will be unlikely to be turned down on those grounds alone.

Submission guidelines

- **You MUST be 18+ to commission me, regardless of content.**
- By commissioning me, you are agreeing to abide by my TOS, regardless of whether you have read it fully or not.
- If you have a very specific pose in mind, please be descriptive in your submission form. If important details are omitted I am not obligated to change the entire piece. I will make larger changes in the sketch phase while we are working out a pose and will fix any mistakes caused by my own overlook of a prompt or ref. Other changes will be handled on a case by case basis but are not a guarantee.
- Sketch WIPs will be supplied on most commission types, though small items such as colored sketches or snack attack cards will be done in one go unless specified otherwise. Please ask if in doubt!

Refs/Character complexity

- Please supply a complete ref to the best of your ability. If you don't have a proper ref for your character, a collection of other pieces will be accepted so long as they are relatively consistent and you can clearly supplement any gaps in writing.
- If your character has many extra features (such as multiple heads or more than one set of wings) or extremely difficult patterns to replicate, I may charge a little extra. This can be discussed case by case for the time being.

Payment

- Payment is taken in USD via Paypal or Ko-fi only.
- I will invoice you, please do not send me money for a commission before the invoice, even if you already have my Paypal email and I have worked with you before. (Payment sent afterwards as a tip is welcome though of course <3)

Image rights

- You have the right to share and post your completed commission from the moment you receive the file.
- Credit is required if posted to a gallery.
- You may not remove my signature from the full image.
- I have the right to share commissioned pieces to my own online galleries and for use in my portfolio. If you want a private commission, please say so as early in the process as possible and we can discuss.

Right to refuse/refund policy

- I have the right to refuse or cancel any commission request at my own discretion.
- If I cancel a piece, a full refund will be given regardless of level of completion (EXCEPT for in cases of customer behavior. If there is harassment, scam attempts or any other forms of foul play, I will subtract time spent from the refund amount and blacklist the customer permanently.)
- If the commissioner requires a cancellation, I will determine how much is owed by how much work has been done on the piece as fairly as possible.
