Abstract The manuscript must have an abstract not to exceed 300 words. The abstract should ha the general objectives of the study, methodology description, highlights of the results discussions and concluding statement. It should be in a single paragraph without subheadings (Times Roman, 12)

Keywords: 6-10 keyword separated by comma; first letter should be capitalized keywords not in the title (Times Roman 12)

Introduction (Times Roma, 14, Bold)

The introduction should clearly state the essential background information (relevant literature), research problems, objectives, hypotheses, and purpose or impact of the study.

This should provide sufficient background information on the problem addressed, the current level of knowledge, the aims of the study, and the hypotheses tested. This is to allow the readers to understand the purpose and significance of the study. Cite references wisely to provide the most salient background rather than an exhaustive review of the topic. Avoid citing references that are difficult to trace. Use tab for indentation and not spacebar. (Times Roman, 12)

Methods (Times Roman, 14, Bold)

The manuscript should have concise but complete information about the materials, sources of materials, experimental procedures, data collection and type of analysis used. The experimental procedures should be clear and repeatable. It should be divided into several sections as subheadings.

In case of underage participants, details on the ethics and consent are required. For well-established methodology, cite articles where those protocols are described and include sufficient information to be understood independent of these references.

Provide sufficient detail to allow your work to be reproduced. Methods already published should be indicated by a reference: only relevant modifications should be described. (Times Roman, 12)

Results and Discussion (Times Roman, 14, Bold)

The significant results of the work should be presented in this section. Do not present the same data more than once (Table or Figure) and do not repeat the same information in the text. The relationship between and among data should be analyzed and synthesized. All findings should be integrated coherently and supported with relevant discussion.

Provide a comprehensive interpretation of the results and explanation of the implications of the findings to previous related studies and potential future directions for research. Avoid extensive repetition of the results or reiteration of the Introduction. Avoid extensive citations and discussion of published literature.

Present the results concisely as possible in either text, Table(s), or Figure(s). Figures and Tables should be numbered in the order in which they are cited in the text, and be sure to cite all Figures and Tables.

Resolutions of photos should be 300 to 600 DPI (dots per inch) for line figures/black and white images, mentio half-dozens/color figures. (Times Roman, 12)
