# Replacement & Professional Learning Hours Information Summer 2024

This document contains information and instructions for all professional staff regarding the fulfillment of 18 hours of contractual obligations (3 Contractual days equivalent) to be completed between **June 4 and August 16, 2024**.

#### Part 1: Replacement Hours (6 hours total)

All professional staff will receive credit for 6 hours of replacement time to complete classroom/workspace preparation for the 2024-2025 school year. **There is NO form required to document completion of replacement hours.** All professional staff receive credit for these 6 hours automatically. These 6 hours fulfill contractual time during the school year on the two "Summer Flex PL" days - November 27, 2024, and January 3, 2025 (3 hrs in AM each day).

## Part 2: Professional Learning Hours (12 hours Total)

All professional staff must complete 12 hours of professional learning through a combination of **PDE Mandatory Training Sessions** and **Self-Selected Professional Learning Options**. The specific amount of PDE mandatory training sessions and self-selected professional learning options needed will vary depending upon your grade level and/or role. These 12 hours must be completed between **June 4, 2024 - August 16, 2024**.

Upon completion of ALL 12 hours, teachers MUST submit the following form by **August 16, 2024**:

#### **PDE Mandatory Training Sessions (3-6 hours)**

All Professional staff are required to complete specific professional learning hours mandated by PDE. For all professional staff, some of these requirements will be fulfilled by completing specific courses provided by Vector Solutions (3 hrs). Additionally, some staff will also be required to complete specific courses in Structured Literacy (3 hrs) provided by Berks IU FLEX in accordance with PDE mandates (Act 55).
