



Hello, I'm Supernal. It's been brought to my attention of claims that have been made against me.

The main claim being that I actively defend grooming/paedophilia etc. This is not true at all and I do not stand for anything related to this.


One of my mistakes was not immediately removing Omni, the groomer in question and I have learned from sensitive situations such as this and would handle them differently today.


(Screenshot 1 & 2, Universities first conversation)

Later when screenshots and evidence were brought to my attention, I asked for it to be recorded just to validate that they were not fake.




(Screenshot 3, reason why videos were taken)

(Screenshot 5, Uni telling me to contact Necrophobee)


Necro then talked to me about what transpired, keeping this brief to protect their privacy, they informed me of what happened and the age gaps and the states that they both lived in. I could

see this growing in severity and I immediately mentioned at the start about reporting a situation of this magnitude to the police even before looking into it myself.

After the conversation finished, concerns of differing state laws and the grey areas started to rear their head not just for me but one of the people who contacted me as well.





I don't really know the legality or lack thereof for the 20 year old, so I won't make any comments about it
But even if it's legal for the relationship to happen in the real world, it still wouldn't be legal to have anything explicit or sexual stored, saved, sent, downloaded, etc.

This happened a bit later, though still important to the conversation at hand, as confusion on what the legalities were beginning to get to me as I wanted to make the right decision. I did confirm with Omni if he had anything stored, to which he said he did not.

Later as things got heated, I essentially concluded that it had reached a grey area and did not want to act as the situation I felt grew beyond me, ontop of this and omni seeking professional help (therapy) my only actions at that time was making sure he did not contact Leech or Necrophobe again, and informed Leech that if Omni *ever* said but a peep they should tell me and Omni would immediately be removed from the community. But I did not remove him from the community upon being met with his wrongdoings, which again is a mistake I would never repeat. Due to the grey area I concluded that their want to pursue legal action is preferable and also justified.



After that, the situation concluded. Recently it was brought to my attention that Omni had been lying about continuing therapy, and upon verifying this I immediately removed him from the community, which I should have done much sooner.
