

Summary Notice to Parents of Children Using Institutional Cuddy through their School

Introduction

We, at Cuddy Inc. ("we", "our" or "us") have developed and operate a web-based service that facilitate learning and practicing of code writing through a school environment ("**Institutional Cuddy**"). Use of the web simulator service outside of a school environment ("**Cuddy**") is subject to the general Cuddy Privacy Policy, available here <https://cuddy.tech/privacy>.

Your child's school, school district, school system, tutoring center or educational institution that purchased a commercial subscription for Institutional Cuddy pursuant to quotation or purchase order (collectively, "**Institutional Customer**") has contracted with us to offer Institutional Cuddy solely for the benefit of the students and the school system.

We are providing you with this summary notice as a best practice under the U.S. federal Family Educational Rights and Privacy Act (FERPA).

We limit the use of students' information via Institutional Cuddy to the educational context authorized by the Institutional Customer, and for no other commercial purpose. Since we provide Institutional Cuddy under an agreement with the Institutional Customer and we limit our use of students' information to the educational context authorized by the Institutional Customer, we presume that the Institutional Customer has obtained all appropriate and required consents prior to authorizing us to provide Institutional Cuddy. In other words, when we provide Institutional Cuddy to students, the Institutional Customer acts as your agent and consents on your behalf to our collection of your child's information.

Overall, the Institutional Customer retains direct control with respect to the use and maintenance of the student's personal information in Institutional Cuddy.

Personal information we collect

We collect the following types of information from students when they use Institutional Cuddy. The specific items of personal information are detailed in our Full Privacy Notice for Institutional Cuddy, available [here](#):

- Name and email address when registering to Cuddy
- Profile Photo and third-party user account name when registering to Cuddy through third party providers
- Interactions in Institutional Cuddy

How we use and share the personal information we collect

We use the personal information we collect in the school environment to provide Institutional Cuddy to the students, their teachers, and the Institutional Customer only.

We will share the student's information in the following instances, as further detailed in our Full Privacy Notice for Institutional Cuddy available [here](#):

- With the student's teacher and Institutional Customer, for their use in teaching and educating

the student.

- If we are required to do so by a judicial, governmental, or regulatory authority.
- If the student engaged in wrongdoing, we would share the student's information for the purpose of handling the wrongdoing.
- If the operation of Coddy Inc. is organized within a different framework, or through another legal structure or entity.

We do not use or share the student's personal information for marketing purposes.

Once the student stops using Institutional Coddy in a school environment, we will retain its user account personal information under the "Free" tier of Coddy, subject to the general Coddy Privacy Policy, available here <https://coddy.tech/privacy>. Each user may, at any time, terminate its user account and delete its personal information through the account dashboard at <https://coddy.tech/settings?p=preferences> or by providing us with a written notice of termination to info@coddy.tech.
