



UC Davis AB 540 & Undocumented Student Center

Dear community,

Today, the Supreme Court (SCOTUS) ruled in favor of all previous lower court rulings that the presidential administration violated the Administrative Procedure Act in its attempted rescission of DACA. Since the November oral arguments in the Supreme Court (SCOTUS), we have anticipated news of the Supreme Court decision on the *Department of Homeland Security v. Regents of the University of California* case surrounding Deferred Action for Childhood Arrivals (DACA). DACA is the hard-fought result of Undocumented communities' activism and labor with significant leadership from Undocumented youth enrolled in college. Be that as it may, we acknowledge that the program is a temporary support in lieu of a [clean DREAM Act](#) providing pathways to lawful residence status for our community. To see some of the implications of the Supreme Court decision, our partners at the UC Immigration Legal Services Center will be creating an FAQ guide. (Stay tuned for more details, as we will post them within this document.) The majority of Undocumented college students, including those at UC Davis, continue to navigate higher education [without DACA](#). Many of the resources we offer are not contingent on DACA eligibility.

Legal Support

- The UC Immigrant Legal Services Center ("UCImm") is committed to providing support and will be offering Q&A+informational webinars with the first iterations occurring **Friday 6/19 at 5:00pm PST and Monday 6/22 and Tuesday 6/23 at 12:00 pm PST**. - UCImm is currently hard at work exploring the possibilities of first-time DACA applications and Advance Parole being supported through their work. Stay tuned here and via our Center's social media for further updates with this.

Supportive California Laws and Policies

In-state tuition and financial aid

- Students who qualify for AB 540 under the CA education policy code will still be able to qualify for in-state tuition and financial aid. See the [Office of the Registrar](#) for any questions regarding residency eligibility.

MediCal

- Those eligible for the California Medical Assistance Program can access free or low-cost health coverage for children and adults ages 18-25 with limited resources,
 - Qualifications
 - Low-income adults
 - Families with children

- Seniors
- Persons with disabilities
- Pregnant women
- Children in foster care and former foster youth up to the age of 26

AB 21

- Mitigates the impact of potential federal changes to immigration enforcement policies like DACA by ensuring students have access to financial aid, legal representation, and their constitutional rights to privacy and due process

SB 1139

- Ensures all people, regardless of immigration status, have access to state scholarship+loan forgiveness programs for health professionals

SB 1159

- Ensures all people, regardless of immigration status, have the right to receive qualifying professional licenses/credentials

AB 60

- DMV: "Issues an original driver license to an applicant who is unable to submit satisfactory proof of lawful residence in the United States. Driver license applicants under AB 60 must meet all other qualifications for licensure and must provide satisfactory proof of identity and California residency."
