Parent-Teacher Conferences

Pond Cove teachers will host parent-teacher conferences this month. Although the afternoon of March 23 is designated for conferences on our district calendar, some teachers choose to provide meeting options before or after school throughout the month of March. This depends entirely on each teacher's availability and preference.

Classroom teachers have the option of offering parents a meeting via Zoom or in-person for spring conferences. Although many may be excited about the reinstatement of in-person conferences, some families and staff members will prefer to Zoom for a variety of reasons. Given the personal nature of these decisions, it is incredibly important for all of us to respect each individual's choice and level of comfort.

Masking Update

The Cape Elizabeth District Planning Committee met on Thursday, March 3. At that meeting, the committee agreed to recommend an optional masking policy for students and staff starting Monday, March 14. This will be voted on at the School Board meeting next Tuesday. In the meantime, we will forge ahead to prepare for the policy adjustment.

We recognize that this news may come with mixed emotions for families and staff. We ask all within our community to be respectful of each individual's personal choice. While masks will be optional beginning March 14th, it is important to keep in mind that there may be special

situations where individuals will still be required to wear a mask in school. Specific information will be forthcoming from Superintendent Record.

Starting Wednesday, March 9, staff will begin conversations with students about the change from required to optional masking. Our message to all children will center on showing respect and acceptance for others' decisions and how to be safe, respectful, and kind. Resources and talking points for parents will be shared as well.

Thank you for your continued support and flexibility as we navigate our next steps during the Covid-19 pandemic.

Recess Adjustments

We will soon provide students with more opportunities to engage with grade-level peers, as well as access more areas of the playground during recess. This means that students will have access to play in more than one zone of either Little or Big Adventureland, depending on their grade level, and with any classes who are also outside during their recess period.

We will allow time for students to learn expectations for playing with other classes, and provide our counseling team and teachers sufficient opportunity to provide guidance and support. To accomplish this, we will follow a two-week roll out: second, third, and fourth grade students will begin playing with other classes the week of March 7; kindergarten and first grade classes will begin mixing cohorts on the playground the week of March 14.

Kindergarten Registration

Our office is now accepting kindergarten registrations for the 2022-2023 school year. If you have a child turning 5 on or before October 15, 2022, please click here to begin the pre-registration process. Also, please help spread the word to other Cape families who may be interested in registering their children for kindergarten next year.

Once your kindergartener's pre-registration has been approved by our office, you will receive a detailed email guiding you through the enrollment process via the PowerSchool portal. Upon form completion, you will need to upload the following documentation:

- 1. Child's birth certificate
- 2. Proof of immunizations
- 3. Proof of residency
