All prices are in USD and may shift here and there based on availability.

There will only be 2 slots open for Individual Drawings and Character Assets; however, sprite sets only have a total of 3 slots open. This totals in 5 commission slots. However, this slot average can be negotiable on both sides and may depend on what is planned or any payments that need to be made.

Once all 5 slots are taken up, commissions will be considered closed until further notice.

For items such as Individual Drawings or Sprite Sets, half of your payment is required upfront and half is required after the commission is completed.

## Terms of Service

- 1. I retain the right, for any reason and at any point, to refuse or cancel a commission.
- 2. If you are not comfortable with my Terms Of Service and/or are not willing to agree to the conditions, you may not request a commission.
- 3. Half payment for commission is required once first sketches or progress is shown and approved by you. The rest is required at the time of the finished commission.
  - a. In the time between the first sketch and the finished product, progress shall be shown and changes are able to be made, if requested, without any extra payment required.
  - b. Once the final product is done and all payment is sent over, that is the final product. Any request for extra changes or edits afterwards may cost you.
- 4. Do not edit a commissioned piece of mine without my permission. You may simply ask for edits done, I typically send progress along throughout the commission progress.
  - a. For collabs, typically payment isn't expected but is appreciated and still falls under the ruling of all payments given. All that is asked is that the purposes of the collab and the commissioned art piece are made clear and any edits are conveyed to me before they are applied. In addition to this, please add a signature or some indication that the art used, the art I worked on, in the collab if I do not add it myself.

- 5. You may not sell a commissioned piece of mine without my permission.
  - a. We can negotiate some terms if I am asked. Perhaps if you are a video creator or a part of a larger conglomerate, then I would be fine with preemptive chats about genuine payment for my work as it is used on your platform.
- 6. I **do not** allow my art to be used for AI purposes and alike. Please do not upload it to any AI sites as this could compromise my artwork.
- 7. NFT usage (or creation) is **strictly forbidden**.

- Please only upload the smaller file publicly unless otherwise discussed.

- By commissioning me, you are purchasing my service as an artist only.
- I reserve the right to post your finished artwork in my gallery for any reason.

#### COMMERCIAL USAGE AGREEMENT

- If you, the Client, wish to order a commission for Commercial use, the total price of the commission, as well as any other royalties, will be agreed upon upfront.
- The minimum price increase 100% of the original price, meaning double the end sum. However, I reserve the right to charge more if I deem fit.

#### **COPYRIGHT**

- I reserve the right to sign and/or watermark my own work. I will send you a full resolution image (by email or via google docs or within the various messaging platforms noted), but my signature will remain on both the full resolution and smaller versions of the Artwork.
- You are responsible for protecting your ownership over rights to a character design made by me by creating a copy image with your name added as well (ie. through a watermark) when uploading on external sites.
- I retain all copyright over my work, which includes the right to redistribute, reproduce, or use the image as a sample for sales or self-promotion unless otherwise agreed upon. In the case of a Public Commission, I may do whatever I wish with the art (eg. post it to other sites such as Instagram) but will give proper credit to you for ownership of the character's design.
- In the case of a commission, I will not claim the rights to a character design unless it was one of my own designs. Therefore I will not reuse/resell the Artwork for personal or commercial projects unless agreed upon.
- In the case of an adoptable design, I will not reuse/resell the rights to the design once ownership is transferred to you, the Client.

#### NDA - PRIVACY REQUEST

- If you wish for your request to be private, it must be stated during the ordering process.
- I reserve the right to charge a fee if I deem fit.
- The privacy request entails that I am not allowed to share any WIPs on social media, nor am I allowed to stream the process of the commission anywhere.
- However, this also means that you must refrain from sharing any such spoilers yourself.
- This is especially important to consider if you are a Vtuber and want me to keep assets private until your debut.
- The NDA fee usually starts at +5% of the total quote, but it might differ. The bigger the project the bigger the fee.

# I Do Draw:

- Fanart.
- Anthropomorphic characters, animals, humans and/or humanoids.
- Some forms of machinery, this includes metallic arms and small droids with little detail, but the actual intricacy of these machine parts are also negotiable. Reference required.
- Most forms of nudity or softcore NSFW. This requires reference and description.
- Memes (so long as they are not intentionally commenting on a race, culture, group, etc. with the intent to harm or cause grief)
- Icons, emotes, stickers and profile pictures.
- Reference sheets.

# I Don't Draw:

- Gore. Small to middling amounts of blood are fine and are negotiable, but need to be
  discussed and I require reference so as to not make myself uncomfortable or make
  those buying my art uncomfortable and to ensure proper results.
- Large machinery (vehicles, large robotics and large robots, etc.)
- Anything commenting on a race, culture, group, etc. with the intent to harm or cause grief.
  - Basically anything with hate speech or intentionally harmful messages behind it. I will *immediately* decline your commission and you will be barred from further commissions from me, depending on what was asked of me.
- Vents. That puts me as the artist in a really weird spot and I would rather not do any of that.

Failure to comply with any rules or disclaimer may earn you a ban from commissions going forward.

- Expressions are completely negotiable and any changes or additions are also negotiable.\*
  - \*Provided the requests are followed by patience, understanding and are at the appropriate times and followed up with appropriate payment, if required.
- My sprites will not be given any sort of detailed shading, the most is going to be shades over the face to indicate a menacing tone or a body overlay. Or shading/lighting in glasses to indicate depth.
- My sprites will not be given any lighting aside from glowing portions or additions. Aside from metallics, but of course, that will mostly be done based on request if the reference provided does not adequately show the appropriate lighting.

#### One Pose, One Use —

- \$25 \$20
- Ex: Different forms for transformation Quirks.
  - o DERGUNS. MINI FORMS. ANIMAL FORMS??? OBJECT FORMS?!
- This is for sprites that are one expression, one clothing option and one accessory. They are mostly to show off a form rather than any expressiveness.

# One Pose, Multi Use—

• \$30 \$25

(This is one pose with multiple expressions, one clothing option and one accessory. This essentially mixes the One Pose, One Use and the Basic Set options, providing a middle ground for those who just need the one pose.)

- 1 pose, multiple expressions.
- One clothing set. One weapon. One accessory.
  - Separated out into multiple layers because sometimes you're gonna want a shirtless hottie to make everyone simp.
- Additional clothing sets, accessories and weapons/props are \$5 \$2 each.
- Minor changes to the base are \$4 each transaction.
  - This means scarring, bruising, minor bandaging, small wounds like stabs and bullet wounds. Very small things I can add at a moment's notice.
  - I do cluster changes so multiple scars/bruises/bandages/wounds being added at one time will not incur charges.
- Major changes are at least \$4-8 \$6 each.
  - That tends to be changes to limbs, prosthetics, anything that would change the base drastically enough that it would change outfitting.

#### Basic Set —

• \$<del>45-55</del> \$35-45

(This is based on how many poses you require or wish for. 45 35 for 2 poses, 55 45 for 3 poses all prices aside from that are non-negotiable.)

- 2-3 poses, multiple expressions.
  - Typically, and for your consideration, the secondary pose is reserved for fights and actions where the character will be battling. Third pose may also be for something similar or could be a weapon-holding pose.
- One clothing set. One weapon. One accessory.
  - Separated out into multiple layers because sometimes you're gonna want a shirtless hottie to make everyone simp.
- Additional clothing sets, accessories and weapons/props are \$5 \$2 each.
- Minor changes to the base are \$4 each transaction.
