**Discussion of Board related to Petition – Detailing Steps and Forthcoming**

The Petition states: Warn a Special Meeting for the legal voters of the town of Danville to vote on closing the existing high school by ceasing to operate grades 9-12 as of June 30, 2026 and thereafter provide for the education of students in those grades by paying tuition to a public or approved independent school.

There are 1,871 registered voters in Danville. There needed to be 94 signatures for this petition. The confirmed signature count is 124.

Clayton proposed the date of the Special Meeting to be December 6, 2025, at 3:00pm. This is within 60 days, and on a Saturday afternoon, which would not interfere with school operations and provide opportunity for voters to be present. This must be an in-person vote. Between now and then, there will be two informational meetings.

How will this upcoming vote be shared out to the public? The Board will warn the meeting, have informational meetings, put a notice in the paper, have the school put out an email blast.

Can this petition's wording be amended? The board can't amend the wording of the petition and the petitioners have submitted the question they wanted asked. At a town meeting, the wording of articles can be amended, if there is agreement of the voters.

**7. Board Business:**

- **CBA Teacher Contract FY26-FY28 (Discussion/Proposed Ratification/Possible Approval)**

Clayton reviewed the chain of events leading up to saying that currently the CBA is in ratification, and now is asking the board to approve the CBA for Danville School.. Matt shared the financial impact of the CBA updates agreed to by the negotiating council and the CCEA/ Cabot Union delegates. that showed base increases and salary scales. Clayton reviewed the three year proposal which will allow for streamlining in compensation and responsibilities across the districts.

MOTION: To approve the CBA Teacher Contract FY26-FY28. Dave abstained. Eric moved to approve, seconded by Tim. All others in favor. Motion carries.

- **Early Retirement Option Decision in accordance with 17.1 B of CBA (Discussion/Board action)**

No one indicated an intention to pursue this option. No further discussion or action taken.

- **Policy [C28 - Transgender and Gender Nonconforming Students](#) (Recommended). An update to existing policy that ensures a safe and inclusive learning environment for all students, protecting them from discrimination based on gender identity or expression. It affirms students' rights to privacy, the use of their preferred name and pronouns, and access to facilities and activities consistent with their gender. Schools must maintain confidentiality of transgender status, comply with legal requirements for student records, and provide reasonable accommodations for privacy when requested (Discussion/Possible Action)**

This is a recommended policy by the state, and needs to be approved at the local level. It was recommended for approval by the CCSU board at a recent meeting and referred locally. The update revises the terminology to ensure it aligns with current federal and state guidelines.

MOTION: To approve Policy C28 for the Danville School District. Dave abstained. Tim made a motion to approve, seconded by Kay, all others in favor.

- **Finalizing Position Letter for Redistricting Task Force (Discussion/Possible Action)**

Clayton and Eric have been working on the draft version of the position letter. Eric read the letter aloud for the audience. The board and audience discussed what changes they would like to see in the letter, and created the [Edited/Finalized Letter](#).

MOTION: To approve the Finalized Position Letter be sent to the Redistricting Task Force. Tim motioned to approve, Kay seconded, all in favor. The letter will be signed by all board members and be sent tomorrow.
