Privacy Policy

Bluefire Ltd. ("we" or "us") respects the privacy of its users ("you") and has developed this Privacy Policy demonstrate its commitment to protecting your privacy. This Privacy Policy describes the information we collect, how it may be used, with whom it may be shared, and your choices about such uses and disclosures. We encourage you to read this Privacy Policy carefully before using our application(our "Software" or "App") or services (our "Services"). By using our Service, you are accepting the practices described in this Privacy Policy. IF YOU DO NOT AGREE TO THE TERMS AND CONDITIONS SET FORTH HEREIN, PLEASE DO NOT USE THE SOFTWARE AND SERVICES.

This Policy applies only to information we collect in our App and in email, text and other electronic communications sent through or in connection with our App. This Policy DOES NOT apply to information that we collect offline, information collected in other apps or websites (including third party websites you may access through the App), or information collected by any third party. These third parties may have their own privacy policies, which we encourage you to read before providing information on or through them.

1. What kinds of information we collect from you?

There are two general categories of information we will process:

1)Information may be automatically collected

when you use or access the Software and the Service, some information about you may be automatically collected as follows:

We may use APIs provided by IOS and third-party automatic data processing technologies to collect the technical information from your browser or device when you visit our Service. This information could include the type, name and version of operating system:(i) Your configuration and settings of the Software and Services, version of the Software and Services; (ii)ISP (Internet Service Provider), Internet protocol (IP) address, Media Access Control (MAC) address, anonymous user identifiers, device configuration and identifiers; (iii)Advertising ID; (iv) location; (v) Apple ID.

We may use APIs provided by IOS, Google FireBase, Twitter Fabric or Kochava to collect certain usage related information regarding your use and interaction with your device, including the Software and Services and Other Software, such as when and how you use the Software and Services and Other Software, how you use your internet browser and internet search related applications, the web pages you visit and the content you see, access and utilize on such web pages; for example, offerings and advertisements that you view, use and access, how you use them and your response to them, how frequently you use them, your search queries and the time and date of your searches.

We may use APIs provided by IOS to collect information about your subscription orders, such as purchase items, subscription time, order status, payment time. We do not collect and we are not responsible for the collection or security of payment details. Payment information is processed and stored using third-party companies (such as Apple). These companies can be contacted through their websites: https://www.apple.com. Before

entering your personal payment details, we suggest that you read and become familiar with the privacy policy of these third-party companies.

2) Information that you provide to us

When you use the Software, you may voluntarily fill in your birthday to the Software. Support Related Information. If you communicate with us via our support section or via email, we may collect your email address voluntarily submitted.

Camera, Photos and Facial Features Information. In order to use some of the features of the Software, you may voluntarily grant us the permission to access to the camera or photo album to obtain photo in your mobile device. Only if you confirm the permission, will we gain access to your camera and album. When you use certain face recognition functions including but not limited to Exotic Beauty, Baby Prediction, Time Magic, we will use the sdk provided by third parties to analyze the facial features information, automatically capture the position and shape of the five sense organs in the photos, and process the photos, feedback the effect drawing to you. We capture the facial features information only for operating the face recognition functions and providing better effect drawing for you. For such photos, facial features information and effect drawing, we will neither store nor share them with any third parties after processing.

Camera and Photos. In order to use some of the features of the Software, you may voluntarily grant us the permission to access to the camera or photo album to obtain photos in your mobile device. We may send such photos to the third party service provider to process the photos and analyze the data. The conclusion or feedback will be provided to us after such analyzing.

2. How we use your information?

1)The main reason we use your information is to deliver and improve the Service. Read on for a more detailed explanation of the various reasons we use your information: to operate and update the Software and the Service, and provide you with existing and new functionality and features;

to improve and customize the Software and the Service;

to maintain, test, monitor and improve the quality and operation of the Software;

to provide you with support and handle your complaints and/or feedback;

to take any action in case of a dispute involving you in connection with the Software and the Service;

to comply and satisfy any applicable law regulation, legal process or enforceable governmental request.

2)If any new purposes for processing your information arise we will let you know we start to process information on that other purpose by introducing the corresponding changes to this Privacy policy.

3. Sharing Information with Third Parties

We will not share any personal information that we have collected from you except for the following events:

(1) If we are required by law to disclose your information, we may share your information with law enforcement or other competent authorities and any third party, as may be

required (e.g., to detect, prevent or otherwise address fraud, security, or technical issues; to respond to claims or satisfy any legal process, subpoena, or governmental request; or to protect the rights, property, or personal safety of our users, its partners, or the general public);

- (2) In the event we go through a business transition such as a merger or acquisition by another company, consolidation, change of control, reorganization, or sale of all or a portion of its assets, your information will be among the assets transferred;
- (3) We may share your information with certain third parties (including, without limitation, search engines, content providers, and advertising networks and platforms) that provide various services (such as advertising, marketing, analysis, content, and search) in connection with the Software and the Service. We take appropriate measures to ensure that no user can be individually identified from the disclosure of such information, and we require these third parties (i) to keep the data secured, (ii) not to use the data for any other purpose other than to provide us with the Service; and (iii) to use the data solely in compliance with the applicable data protection laws and this Privacy Policy. We would try our best to notify the third party of deleting the relative personal data, but no warranty as to the deletion is made by us.
- (4) We may also share personal information with our subsidiaries, affiliated and parent companies but their use of such information must comply with the applicable data protection laws and this Privacy Policy.

4. Transfer of data outside your territory

- 1)We work in the international space and provide the Software to our users around the world. We and third-party organizations that provide automatic data processing technologies for the Software or our third-party advertising partners may transfer the automatically processed information across borders and from your country or jurisdiction to other countries or jurisdictions around the world.
- 2)Where you located in the EEA, as required by law, you hereby provide us with your express consent to transfer your data to where may be outside of EEA once you use the Service. You may withdraw your consent at any time.

5. How long we maintain your personal information?

We generally retain your personal information for as long as is necessary for the performance of the contract between you and us and to comply with our legal obligations.
