DRESSING ROOM

1. Purchaser to provide clean dressing rooms for three (3) or four (4) that are well lit, well ventilated, capable of being locked and equipped with full-length mirrors and restrooms for the exclusive use of the artists.
2. Dressing rooms should be supplied with the following items, at Purchaser's sole cost & expense, at least 60 minutes prior to show time:
 - a. At least 4 towels
 - b. An adequate quantity of diet sodas, assorted fruit juices, sparkling and non-sparkling water, ice and glasses
 - c. Assorted teas, coffee, cream, milk, honey and sugar
 - d. Veggie tray with hummus; Sandwiches – vegetarian & non-vegetarian; unsalted nuts

ACCOMMODATIONS

1. Purchaser agrees to provide and pay for up to four (4) Hotel rooms at, adjacent to, or near the performance venue for up to two (2) nights (to include the night prior to and the night of the performance) at a hotel that is rated at least 3 stars by travel websites or the AAA.
2. If the hotel is not onsite, ground transportation from the hotel to the performance venue and back to the hotel must be provided at the Purchaser's sole expense.

AIR & GROUND TRANSPORTATION

1. Purchaser agrees to provide ground transportation to and from airport, venue and any and all promotional activities.
2. Artists will make their own airline arrangements and notify purchaser of arrival times for airport pickup.

LIGHTS, SOUND & STAGE EQUIPMENT

1. An adequate sound system consisting of at least two (2) microphones (at least one (1) for backup) either Shure 58 or comparable quality, with long cord (or wireless) and removable heads. One adjustable single microphone straight stand with round or rectangular metal base (no legs) plus two (2) stage monitors.
2. Complete set of side wash stage lighting (preferred - not mandatory).
3. One (1) follow spotlight with experienced spotlight operator for each artist's performance.
4. One (1) black 30" high wooden backless barstool with no pad; Up to three (3) additional stools may be needed at the end of the show so all Performers may sit on stage.
5. Projector and screen for WOACA Logo (preferred – not mandatory)
6. Small table with bottled water or a second black 30" high wooden backless barstool with no pad.

BILLING

1. FUNNY WOMEN OF A CERTAIN AGE shall receive 100% billing with each artist's photo and name appearing with the show logo - wherever possible - in all advertising and promotion, including, but not limited to air time, social media posts, newspaper and trade ads, flyers, posters, billboards, marquees, etc.
2. Artist shall have the right of approval of all press and publicity regarding this engagement.

RECORDINGS

1. No portion of the performance may be broadcast, recorded, filmed, taped, or utilized in any form for any purpose of reproducing such performance, and purchaser agrees that it will not authorize any such recording.
2. Purchaser will ensure that the audience does not take any videos or sound recordings during the performance.

FORCE MAJEURE

1. Artist's obligation is to furnish the entertainment referred to herein subject to the detention or prevention by sickness, inability to perform, accident, means of transportation, act of God, riots, strikes, labor difficulties, epidemics, and any act or order of any public authority or any cause, similar or dissimilar, beyond Artist's control.
2. Provided Artist is ready, willing, and able to perform, Purchaser agrees to compensate Artist in accordance with the terms hereof regardless of an act of God, fire, accident, riot, strike or any event or events of any kind or character whatsoever, whether similar or dissimilar to the foregoing events which would prevent or interfere with the presentation of the show hereunder.

INCLEMENT WEATHER

1. Notwithstanding anything contained herein, inclement weather shall not be deemed a force majeure occurrence, and the Purchaser shall remain liable for payment of the full contract price even if the performance(s) called for herein are prevented by weather conditions. Artist shall have the sole right to determine in good faith whether any such weather conditions shall render the performance(s) impossible, hazardous, or unsafe.

MISCELLANEOUS

1. The specific capacity, gross potential, and ticket price breakdown of the facility where Artist is to perform under this agreement must be clearly printed on the face of the contract that this agreement is attached to.
2. Purchaser shall not commit Artist to any personal appearances, interviews, or any other type of promotion without the prior written consent of the Artist or Artist's representation. There shall be no press parties or appearances before a special group set up without the expressed permission of the Artist.
3. Artist shall have the right, upon forty-five (45) days notice, to substitute a performer, or performers, of equal marquee value for any performer in the Tour who has been retained to appear in any motion picture, television series, or special, and/or any Las Vegas, Tahoe, Reno, or Atlantic City type engagement as a solo artist.
4. Artist is to receive up to twenty (20) complimentary tickets. Any unused tickets will be returned to Purchaser's sellable inventory prior to the performance.

5. Corporate Identification/Corporate Sponsorship may not be displayed in any manner without prior written approval.
6. Absolutely no advertising may be initiated until a fully executed contract and rider have been returned, and the Purchaser has provided a date as to when the agreed-to deposit will be sent.
7. Purchaser must start advertising this engagement no less than forty-five (45) days prior to the show date.
8. No intermission is required. If Purchaser requests an intermission, it should be discussed with Artist's representation.
9. Purchaser shall insure proper backstage security for Artist and will insure that any disturbances in the audience (heckling the performer, talking that disturbs other patrons or is noticeable to the performers, etc.) will be dealt with swiftly and professionally so as to allow minimal show disruption.
