

Privacy Policy Notice

I. Personally-Identifiable Information and Non-Personally Identifiable Information.

Andrea Ivanka Enterprises Inc (also referred to herein as “Andrea Ivanka Enterprises”) may collect two different types of information, Personally Identifiable Information (“PII”) and Non-Personally Identifiable Information (“Non-PII”).
