EXECUTIVE ORDER № 61
FREE PRESCRIPTION EYEGLASSES FOR THE PRESIDENT

To the People of Sierra, Greeting:

WHEREAS, the President of the United States is under the bizarre and utterly unexplainable perception that the New Sierran Republic, a loyal state of the United States, has declared its unilateral secession from the United States of America,

WHEREAS, this assertion could not be further from the truth as the New Sierran Republic continues to show its adoration for the United States through State-sponsored events such as patriotic, pro-American flag burnings and the performance of patriotic, pro-American songs such as Born in the USA and the Internationale,

WHEREAS, absolutely nothing in Executive Orders 59 and 60 hinder the enforcement of Federal law in the territory of the New Sierran Republic,

WHEREAS, the Tenth Amendment to the United States Constitution clearly gives me the power to change my title and the official name of the State of Sierra in executive branch documents to whatever I want,

WHEREAS, the President's inability to grasp the purpose and plain meaning of the aforementioned Executive Orders could be due to poor eyesight,

WHEREAS, the New Sierran Republic was the first jurisdiction in the United States to cover free eye care and eyeglasses prescriptions for all its citizens through the Covered Sierra program,

WHEREAS, the New Sierran Republic stands ready to assist any American who does not benefit from the high-quality universal coverage of Covered Sierra and thus cannot afford to purchase prescription eyeglasses,

NOW, THEREFORE, I, HURRICANEOFLIES, Governor of the State of Sierra and President of the New Sierran Republic, in accordance with the authority vested in me by the State Constitution and statutes, do hereby order as follows:

- 1) The Secretary of State shall send a missive to the President of the United States to request his most recent prescription for eyeglasses.
- 2) Upon receipt of the prescription, the Secretary of State is ordered to go to the nearest “LensCrafters” store and purchase a fashionable frame and lenses of appropriate prescription. Funding for the purchase shall be disbursed from the discretionary budget of the Executive Department.
- 3) The Secretary of State shall deliver the eyeglasses to the President at the earliest date practicable in a gift box wrapped with a nice ribbon fashioned into a bow.
