

#RAJALIBASCHALLENGE Terms & Conditions

1. Eligibility

1.1 The #RajaLibasChallenge ("Campaign") is open to all individuals residing in Malaysia.

1.2 Participation is free and no purchase is necessary.

1.3 Entries must be submitted during the official Campaign period. Entries submitted after **11:59 PM (MYT) on 31 August 2026** will not be considered.

2. Entry Requirements

2.1 To participate, entrants must:

- Record an original libas kick or pose.
- Post the content on Instagram or TikTok.
- Tag **@abaroshoes**.
- Include the hashtag **#RajaLibasChallenge**.
- Send the word **"LIBAS"** via Direct Message (DM) to ABARO's official Instagram or TikTok account to validate the entry.

2.2 Each valid social media post constitutes one (1) entry.

2.3 Participants may submit multiple entries, provided each submission is original and different.

2.4 Participants' social media accounts must remain **public** throughout the Campaign period until the winners are announced.
