Dear Coach,

You and your team are cordially invited to attend the Kickapoo/ Parkview Invitational and Debate Tournament on November 18 and 19, 2022.

The Kickapoo Varsity Tournament will offer varsity and JV division for Policy Debate, Lincoln-Douglas Debate, and Public Forum Debate. The Parkview Novice Tournament will offer Policy Debate, Lincoln-Douglas Debate, and Public Forum Debate. Both tournaments will offer International Extemporaneous Speaking, United States Extemporaneous Speaking, Original Oratory, Informative Speaking, Humorous Interpretation, Dramatic Interpretation, Program of Oral Interpretation, Duo Interpretation, and Radio Speaking. Congress will also be offered at KHS. An addendum with specific wording about congress procedure/legislation and the November topics will come out by mid-October. All details will also be uploaded on kpi.tabroom.com. If there is a conflict, the wording on kpi.tabroom.com will be used.

Here is the short version:

- All registration/ scheduling/ etc. will be through kpi.tabroom.com. Entries not entered through tabroom will not be accepted. Please make sure students are entered in the correct event, division, etc.
- We will waitlist students when they are first registered. We will guarantee 3 entries per event and open up other entries the week of the tournament.
- All events will be charged \$10 per entry and will include pizza for all competitors on Saturday. We will provide a vegetarian, gluten sensitive, and omnivorous options. If you need other accommodations, please let us know when you submit your entries. For ease of payments and scheduling, all checks should be made to Kickapoo. We will sort out the money after the tournament. The invoice, etc. will be able to be printed from within tabroom.
- 2 After quarterfinals of debate at Parkview, all students should come to KHS for the awards ceremony, semifinals of debate, and finals of debate.

All entries must be received by 3:00pm on November 9th. Please submit as soon as possible. Extra entries will be granted as space allows and confirmed after the entry deadline.

GENERAL RULES

1. Each school must be registered by an adult sponsor prior to competition. Schools must provide one judge if they have 50 or fewer entries, but one additional judge (for each 6 entries) above 50.(2 judges covers 56, 3 covers 62, etc). These judges should be included on tabroom. At Parkview, each school must provide one judge (may be an advanced student) per two debate-entries (all divisions). Failure to meet judging assignments will result in the forfeiture of one of the school's teams for that round.

- 2. A school may enter two contestants in each event.
- 3. A student may enter two speech events and debate, with the following exceptions:
 - a. A student may not enter both divisions of extemp.
 - b. A student may enter only one category of debate: Policy, Lincoln-Douglas, Public Forum.
- 4. A novice shall be defined as a student in their first year of interscholastic competition. A JV student will be defined as a student in their first or second year of competition. Based on numbers, we may choose to collapse varsity and JV into one division.
- 5. Awards will be presented for first, second, and third place in sweepstakes for each tournament. Additionally, awards will be presented for competitors placing in the top six in speech Events, debate competitors advancing to quarterfinals and beyond will be presented with awards, and the first place, overall, Kickapoo-Parkview sweepstakes will be presented with the Bill Jordan traveling trophy.
- 6. Fees are due for cancellations made after the entry deadline. Please note additional fees for drops during the tournament.
- 7 All efforts will be made to have wifi available to all students in all events. Use of internet connected devices during rounds IS allowed for evidence retrieval purposes including doing research. Use of devices to connect to people outside the room (e.g. coaches, etc.) will result in immediate disqualification of students found in violation.
- 8 All evidence must be available to any competitor or judge in the room who requests it for any reason after it has been read. The evidence should be marked to indicate which parts of the evidence were spoken out loud and the full evidence (tag, cite, evidence) must be provided in an accessible way to the requester. A competitor does not need to ask for each piece of evidence specifically, just asking "can you please flash/ email/ speech drop all your evidence to me?" is sufficient and must be met with the provision of said evidence. Any time used to send this evidence after the speech should be counted against the prep time of the team who read the evidence as long as the request is made during cx.

SWEEPSTAKES RULES

- 1. Only a school's best two entries in each event earn sweepstakes points.
- 2. 5 points for each preliminary debate round win.
- 3. 15 points for qualifying for quarterfinals in debate.
- ${\bf 4.\ 5\ points\ for\ qualifying\ for\ semifinals\ in\ speech\ events\ \&\ Congressional\ Debate.}$

- 5. 10 points for qualifying for finals in speech events & Congressional Debate.
- 6. 5 points for third place in speech events & Congressional Debate.
- 7. 10 points for second place in speech events & Congressional Debate.
- 8. 15 points for first place in speech events & Congressional Debate.
- 9. There will be a 10 point sweepstakes penalty for each dropped entry on the day of the tournament.

SPEECH EVENT

- 1. Extemporaneous Speaking: For preliminary rounds all students will select ONE topic from a list of topics distributed on Monday morning. They should take up to 30 minutes to prepare a 7 minute speech and record it. For finals Drawing will be conducted at five minute intervals with thirty minutes preparation time. Topics will be based on current events. Consultation during prep. time is prohibited. Excessive use of notes will be penalized. Time limit: 7 minutes, maximum.
- 2. Oratory and Informative: The speech must be the original work of the contestant. Not more than 150 words may be a direct quotation. The presentation must be memorized. Time limit:10 minutes, maximum. For Informative: Audio/visual aids may or may not be used to supplement and reinforce the message. During the presentation, no electronic equipment is permitted. The use of live animals or any additional people as visual aids is not allowed during the speech. Items of dress put on and removed during the course of the presentation are considered costumes and may not be part of the contestant's presentation.
- 3. Interpretation (Humorous, Dramatic, Duo, & POI—NSDA rules apply): Selections may be taken from any published novel, play or short story. Selections must possess literary merit. An adequate introduction should be provided. Off-stage focus for Duo. No properties may be used. Selections must be memorized. Time limit: 10 minutes, maximum.
- 4. Radio speaking will follow MSHSAA rules. It will be a 5 minute speech consisting of news, sports, weather, etc. No ads should be used.
- 5. According to MSHSAA rules, a student who performs in the wrong room will be ranked last in that section.

STUDENT CONGRESS

- Session one and two will convene during round one and two of individual events. Supersession will convene during I.E. semifinals and finals.
- Students entered in Student Congress may not be entered in any other IE event.
- The contestants in each chamber will elect a permanent Presiding Officer for their chamber after a 10-minute trial period. There
 will be another election for Presiding Officer in Supersession. In Novice Student Congress, a permanent presiding officer will be
 assigned to each chamber.
- Coaches may be used as scorers.
- Please keep in mind that Presiding Officers are trusted to honor parliamentary procedure and award speeches according to
 precedence. Enter your students in Congress with the knowledge that <u>human error does occur</u>. Please do not complain to the
 tournament personnel about errors beyond their control.

POLICY DEBATE RULES

- See Novice policy rules below. Novice Affirmative teams are limited to the attached case areas list (listed below)
- Novice teams are not to use kritiks or counterplans.
- The resolution shall be the NSDA national topic: Resolved: The United States federal government should substantially increase its security cooperation with the North Atlantic Treaty Organization in one or more of the following areas: artificial intelligence, biotechnology, cybersecurity.
- Policy format of 8-3-5 will be used. Prep time: 8 minutes per team.
- Contestants more than ten minutes late to a round, through no fault of the tournament, will forfeit.
- Failure to meet judging assignments may result in the forfeiture of the offending school's teams.
- In case of a forfeit, the winning team will receive speaker ranks of 1-2.
- Team personnel must remain consistent throughout the tournament.
- At the end of preliminary rounds, the top teams will advance to quarterfinals. Speaker ranks, the win-loss record of the team to whom the prospective quarterfinalist has lost, speaker points, and total opposition records will be used to break ties.

NOVICE POLICY DEBATE RULES

- Affirmative cases are to be limited to the case areas as suggested by the NFHS and plan texts as completed by the MSDI.
 Remember, the point of novice debate is to help them develop skills and learn. Educational and meaningful debates are the hopeful outcome.
- Here are the affirmative cases that may be run (you may click on hyperlinks to download the evidence for free):
 - 1 <u>MSDI Vaccine Funding</u> The United States federal government should substantially increase its security cooperation with the North Atlantic Treaty Organization in biotechnology through a vaccine research program emphasizing biosafety, resilience, foresight, and experimentalist governance.
 - 2 <u>MSDI Human Germline Research</u> Plan: The United States federal government should substantially increase its security cooperation with the North Atlantic Treaty Organization in the area of biotechnology by banning the use of germline genetic engineering in humans.
 - 3 <u>MSDI Ban Offensive Cyber Operations</u> The United States federal government substantially increase its security cooperation with the North Atlantic Treaty Organization in the area of cybersecurity by banning offensive cyber operations.
 - 4 <u>MSDI Lethal Autonomous Weapons</u> The United States federal government should substantially increase its security cooperation with the North Atlantic Treaty Organization by banning Lethal Autonomous Weapons Systems.
- Novice teams are not to use kritiks or counterplans. Novice teams are encouraged to read disadvantages, make case arguments, etc.

Lethal Autonomous Weapons

- Students are not restricted to using only evidence from the MSDI files. Feel free to cut new or additional evidence to supplement these files or to access the NDCA novice evidence packet or the open evidence project for additional evidence. It is only the plan text and advantage areas that must remain the same as listed above.
- Please feel free to allow novice students who feel like these guidelines are too restrictive to enter another division. Open or champ divisions will not follow these specific restrictions.
- Judges will be instructed about the case area limitations and the restrictions on counterplans and kritiks.
- If a team believes their opponent has violated the rules listed above, they should:
 - o a. continue to debate the round,
 - o b. inform their coach immediately after the round,
 - o c. the coach should immediately inform the tournament director.
 - o d. all final decisions will be made by the tournament director.
 - e. teams found in violation will receive a loss with speaker ranks of 3-4.

LINCOLN-DOUGLAS DEBATE RULES

- The proposition shall be the NSDA November/ December Topic: TBA on October 1st
- Lincoln-Douglas rounds will run at the same time as Policy Debate, so two Lincoln-Douglas Debates will take place during one Policy Debate.
- Lincoln-Douglas format of 6-3-7-3-4-6-3 will be used. Prep time: 4 minutes per debater.
- Contestants more than ten minutes late to a round, through no fault of the tournament, will forfeit.
- Failure to meet judging assignments may result in the forfeiture of the offending school's entries.
- At the end of preliminary rounds, the top contestants will advance to quarterfinals. The win-loss record of the debater to whom the prospective quarterfinalist has lost, speaker points, and total opposition records will be used to break ties.

PUBLIC FORUM DEBATE RULES

The proposition shall be the NSDA November/ December topic: TBA on October 1st.

- Public Forum rounds will run at the same time as Policy debate, so two Public Forum debates will take place during one Policy debate.
- Public Forum format of 4-3-3-2 will be used. Prep time: 3 minutes per team.
- Contestants more than ten minutes late to a round, through no fault of the tournament, will forfeit.
- Failure to meet judging assignments may result in the forfeiture of the offending school's teams.
- In case of a forfeit, the winning team will receive speaker ranks of 1-2.
- Team personnel must remain consistent throughout the tournament.
- At the end of preliminary rounds, the top teams will advance to quarterfinals. Speaker ranks, the win-loss record of the team to whom the prospective quarterfinalist has lost, speaker points, and total opposition records will be used to break ties.
