Manuscript margins must be set at 4 cm for the left, and 3 cm for top, bottom, and right margins. For articles written in English, only abstracts in English is required.

Introduction

(Times New Roman 12 pt, single spacing, no subheadings)

The introduction outlines the background of the problem being addressed, issues related to the problem, an overview of real-world phenomena concerning the research topic, and the urgency of conducting the study. It also presents the research questions to be answered, the research objectives, and the significance of the findings. Each paragraph must be indented 1 cm.

All included tables and figures must be numbered, with the number appearing on the same line as the title. Tables and figures should be placed within the text. Figures and charts must be analyzed and shown to be relevant to and supportive of the topic's clarity. Table titles are placed above the table, while figure or chart titles are centered below the image. The source of the table or figure is cited at the bottom left.

The methods section should outline the stages of the research implementation and provide detailed explanations. This section also covers the analysis performed as part of the implementation process.

Results and Discussion

(Times New Roman, 12-point font, single spacing)

The discussion of the research results is presented in a detailed narrative. The discussion must present the findings in a systematic and logical matter. Research results may also be displayed using graphs, figures, or tables placed within the text. The presentation of graphs and tables may follow the format below.

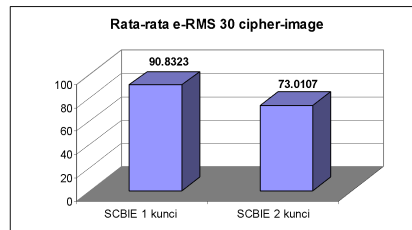


Figure 2. XXXXXXXXXX (12 point)

Acknowledgments may be addressed to sponsors or research grant providers (if any), institutions, or respondents who significantly contributed to the research conducted.

References must be compiled using the Mendeley reference management tool with the APA 7th Edition citation style. Format:

NOTES

- 1) The bibliography must include all references cited in the manuscript.
- 2) If there are three authors, all their surnames must be listed. Use et al. for author teams of four or more.
- 3) The total article length should be 4,000–7,000 words or 10 –15 pages (single-spaced, A4 paper, Times New Roman 12 pt, one-column format).
- 4) Articles undergo a screening process prior to review; articles that do not adhere to the template will be returned to the author for revision.
- 5) A minimum of 10 references published within the last 10 years is required, or 80% of references must come from accredited scientific journals.
- 6) The bibliography must be compiled using the Mendeley reference management tool with the APA 7th Edition citation style.
