



### **Foster Family Female Agreement**

The following document is a contractual agreement for dog fostering services. The term “guardian family” as used in this document, will refer to \_\_\_\_\_ and \_\_\_\_\_. The term “owners” will refer to the proprietors of Picture Perfect Doodles, specifically, BRANDON J. COMSTOCK, and CARLEEN CHENEY COMSTOCK. The animal in question for this contract is AKC Toy Poodle from Picture Perfect Doodles.

### **Guardian Family Responsibilities**

The primary responsibilities of the guardian family are: 1) provide quality care and training for the animal in question, and 2) transport and deliver the dog to the breeders, or owners of the dog at the appropriate time.

Specifically, the responsibilities of the guardian family regarding proper care and training include the following:

1. Ensuring that the dog is provided proper grooming including but not limited to the trimming of hair and nails, the cleaning of ears, and reasonable dental care.
2. Ensuring that the dog is adequately fed and hydrated.
3. Ensuring that the dog receives proper exercise, including regular outdoor activity.
4. Trips too, and payment for, any veterinarian visits that are not directly related to reproductive health, including yearly vaccinations and scheduled check-ups.
5. Training the dog to respond to basic commands including sit, stay, come, and lay-down.
6. House-training the dog.
7. Any and all repairs, damages, or injuries that are necessitated by the actions of the aforementioned dog.
8. Responsible for payments for any veterinary appointment caused my accident or injury.
9. All other care that would be considered reasonable and prudent by a typical owner.
10. Reporting the results of any health concerns, including injuries, veterinarian visits, and the beginning of heat cycles, to the owners within 24 hours.
11. Delivering the dog to the owner’s home for delivery of puppies.
12. Transporting the dog to veterinary appointments related to reproductive tests (health testing, ultrasound, x-ray, progesterone testing) and Stud services.

### **Owner Responsibilities**

The primary responsibilities of the owners include: 1) purchasing the dog and breeding rights, 2) arranging for any and all breeding services, 3) arranging and paying for any health testing associated with breeding, and 4) overseeing the delivery and whelping of all litters.

Specifically, the owners agree to the following:

1. Financially provide for all health and DNA testing.
2. Financially provide for all veterinary appointments related to reproductive testing.
3. Provide housing for the dog for up to ten days before the expected delivery of a litter until up to eight weeks after the delivery of a litter (to provide adequate time for nursing).
4. Locate and schedule a stud service on the appropriate day.

5. Assume the responsibilities of reasonable health care for the dog during the period which the dog is residing with the owners.
6. Provide the guardian family with a \$100 bonus upon successful delivery of each puppy sold from the dam.
7. Provide the guardian family with a \$250 bonus towards spay of female before permanent transfer to guardian family.

#### **Duration of Contract**

It is anticipated that this contract will be effectual until one of the following occurs: 1) the aforementioned dog delivers her third litter, 2) the aforementioned dog matures to the age of six years old, or 3) the owners determine that the health of the aforementioned dog renders it unable to continue serving as a dam. Upon reaching one of the aforementioned scenarios, Owner will have the female spayed and ownership of the dog, along with all financial responsibility, will be permanently transferred to the guardian family and all previously agreed upon terms will be rendered void.

In the event that the aforementioned dog dies, or is rendered incapable to reproduce as a result of negligence on the part of the guardian family before the designated duration of the contract is complete, the guardian family agrees to compensate the owners of the dog, up to the original value of the dog which was \$3000. For the purposes of this contract, the word negligence refers to events that could reasonably have been avoided with greater care from the guardian family. Examples of events that would be deemed negligent include, but are not limited to: ingestion of substances that are harmful to the health of the dog (including blockages), being struck by a motor vehicle, being left inside a hot car etc.. If the guardian family decides they would no longer like to be a guardian home, Picture Perfect Doodles will take personal ownership and possession of the dog. The guardian family has the option to purchase the dam for the price of \$3000 under a strict spay contract *before* the age of 18 months.
