Gao Zhisheng who is one of the most respected human rights lawyers in China. On August 13, 2017, Gao Zhisheng's wife Geng He, who fled to the United States in 2009 after repeated instances of harassment and abuse by Chinese authorities, posted on Twitter that Gao was not answering his phone. The family subsequently learned that he had been taken to Beijing, but they have not received any further information about his whereabouts or condition. The manner in which Gao Zhisheng vanished without a trace and was subsequently found to be held under incommunicado detention is characteristic of a larger pattern in which Chinese authorities round up outspoken or dissenting voices.

EGYPTIAN-TURKISH POET FORCIBLY DISAPPEARED [UAE 13.25]

Egyptian-Turkish poet Abdul Rahman Al-Qaradawi has been forcibly disappeared since his extradition from Lebanon to the UAE on January 8, 2025. He was arrested by Lebanese security on December 28, 2024, at the Masnaa border crossing on charges of spreading “fake news” and “disturbing public security” related to a critical video he posted about Egyptian, Emirati, and Saudi authorities. Concerns for his safety are growing as his family has not received any information about his fate or legal status, and he has been denied consular visits by Turkish authorities.

Call on the President of the UAE, Sheikh Mohamed bin Zayed bin Sultan Al Nahyan, to immediately disclose the fate and whereabouts of Abdul Rahman Al-Qaradawi, allow him to communicate with his family and lawyers, ensure he has access to adequate healthcare, and is granted a consular visit from the Turkish authorities.

Iran: Six Men at Risk of Execution After Grossly Unfair Trial

Six men – Abolhassan Montazer, Akbar (Shahrokh) Daneshvarkar, Babak Alipour, Mohammad Taghavi Sangdehi, Pouya Ghobadi and Vahid Bani Amerian- are at risk of execution in Iran. In October 2024, Branch 26 of the Revolutionary Court of Tehran convicted them of “armed rebellion against the state” (baghi) and sentenced them to death following a grossly unfair trial marred by allegations of torture and other ill-treatment to extract forced “confessions”.
