Some of the Resolutions We, the Consultation, are Supporting

If you haven't done so, please take time to read [The Report of the Presiding Officers' Working Group on Truth-Telling, Reckoning, and Healing](#). Racial equity and justice continue to be the pre-eminent struggle for our times. The report contains excellent guidance for parishes, dioceses, and the wider church as well as seven important resolutions, all of which we support, but we need to highlight [A125](#). The resolution would establish an independent body, akin to ERD, the Coalition for Racial Equity and Justice, which would continue the work of this group indefinitely.

In this era of violence and legislation affecting our transgender brothers and sisters, we commend [D030 Develop Resources and Training for Welcoming and Supporting Transgender and Non-Binary Persons and Families](#). This resolution would direct the Church Center to develop multilingual, multicultural churchwide resources and training to support our dioceses, provinces, churchwide leaders, and congregations in living into our commitments to welcome and support people and communities of diverse genders, including transgender and non-binary.

We face a transformation in the way our Church functions with changing patterns of leadership. Resources are needed to empower the laity. [A104/A085](#) (duplicates) *Creation of a Digital Hub for Formation Resources* would help and would be available in English, Spanish, and French/Creole.

Resolution [A059 Amend Article X of the Constitution of The Episcopal Church](#) states "The Book of Common Prayer is understood to be those liturgical forms authorized by the General Convention as provided for in Section 2 of this Article." Section 2 specifies passage at two consecutive General Conventions. This provides what has been discussed for years in the Church, modifications/additions without creation of an entirely new BCP.

Another key resolution in our continuing quest for reconciliation with those our society and church have abused is [D004 Continued Funding of The Beloved Community](#), which seeks \$2 million to continue funding for ministry of racial reconciliation at the local level. Discussion of this resolution will happen in concert with consideration of A125, as described above.

Conditions imposed by Israel on Palestinians meet multiple legal definitions of apartheid and are documented by reports from multiple international justice and human rights organizations. This is acknowledged by Resolution [C025 Recognition of Apartheid in Israel/Palestine](#).

An as-of-yet unnumbered resolution will push the church to rethink funding models that keep missional ministries—urban, rural, immigrant, communities of color, college, youth and young adult—deeply under-resourced.
