We use your information to:

- Display your member profile within the community
- Process event registrations
- Send announcements, newsletters, and updates
- Respond to questions and support requests
- Improve our services
- Protect the security of the App
- Comply with legal obligations

3. Member Directory

One of the purposes of the GWiB App is to foster networking and collaboration among members.

If you create a member profile, certain information you choose to provide—such as your name, business name, profile photo, business description, and contact information—may be visible to other registered members through the member directory.

You are responsible for the information you choose to include in your profile.

4. Communications

We may send you communications related to:

- Membership
- Events
- Organization updates
- Networking opportunities
- Community announcements

You may opt out of non-essential communications where available, although we may still send important administrative messages regarding your account or membership.

5. How We Share Information

We do not sell or rent your personal information.

We may share information:

- With trusted service providers who help us operate the App (such as our app platform provider)
- When required by law
- To protect the rights, safety, or property of GWiB, our members, or others
- With your consent

6. Data Security

We take reasonable administrative, technical, and organizational measures to help protect your personal information.

However, no method of electronic storage or internet transmission is completely secure. While we strive to protect your information, we cannot guarantee absolute security.

7. Your Choices

You may:

- Update your profile information
- Correct inaccurate information
- Request deletion of your account (subject to applicable legal or organizational recordkeeping requirements)
- Adjust your communication preferences where available
