### Athletic Handbook

Moved by Mr. Adair, seconded by Mr. Galbreath, to adopt the following changes to the athletic department Participation Agreement now known as the Athletic Code of Conduct:

1<sup>st</sup> Offense – The student athlete will be dismissed for \*10% of the season in which the infraction occurred. In addition, the student athlete must show proof of a clear chemical assessment before he/she will be permitted to compete.

2<sup>nd</sup> Offense – The student athlete will be dismissed for \*50% of the season in which the infraction occurred. In addition, the student athlete must show proof of a clear chemical assessment before he/she will be permitted to compete.

3<sup>rd</sup> Offense – Denial of participation in all Lakeview Athletics for one (1) calendar year to commence on the date the infraction occurred. In addition, the student must show proof of a clear chemical assessment before he/she will be permitted to compete.

4<sup>th</sup> Offense – Dismissal from the team immediately and prohibited from participating in any athletic activity for the remainder of their time in Lakeview Athletics.

\*If an infraction occurs too late in the season for an athlete to complete the suspension penalty, the remaining suspension will be served in the athlete's next season.
