


Hey,


I already sent a couple short emails from my chores/errands email, and tried to keep it a little less specific. I have had a lot of bad experiences with Sean Chiplock / sonicmega. He went out of his way to victimize me when I wanted nothing to do with him (and in fact tried to avoid him / forget about dealing with him). Since talking about it, another one of my friends has come forward to tell me about Sean trying to push boundaries and make advances, which happened years before I knew this friend. Sean showed bizarre and extreme displays of malice at me, because of running a chat room in a way that removed people for sexism etc with less leniency than you would have found elsewhere online in 2013. I've found the full thread and also logs where he was malicious, and I'll go into detail shortly.

This was the first time I was actually targetted by someone specifically. Sean started the harassment that actually got thousands of people calling me a pedophile. Last year I had a nervous breakdown because of it. I have a 1200 page thread on a harassment site because of what he started. I am so incredibly frustrated that he uses his position in order to terrorize anyone at all.

I'd made a Tumblr post back in Dec 2013 about frustrations I was having with my marriage. Through harassment from Sean and the thread he pushed very hard, it drove me away from getting help I needed.



Here were some quotes:



"I just want to know how long is left until the stress/persecution complex finally gets to PK enough and degrades her work ethic/quality to the point where Onta says "shape up or you're out of WetBlush". Or just removes her altogether.

I wonder how that would look, knowing you got both kicked out of an art university for spending all your time drawing furry porn, and then got kicked out of a porn paysite for NOT spending enough time drawing furry porn."

I'd recently started doing some adult work for a furry site. He started spreading the idea that I'd been "kicked out of an art university for spending all your time drawing furry porn", even though this had not happened and he knew it. I had logs of him from May 2013 (half a year or so prior) being malicious to me in PMs on my IRC channel.

" 13[18:36] <PK> going ~I chose not to bring up these awful things from your past~ is lording it whether you believe it is or not

[18:36] <PommyN64> But I chose to ignore it because honestly you were a pretty nice individual when we spoke.

13[18:36] <PK> from the very start

13[18:36] <PK> what made you think period jokes and pms jokes were funny???

13[18:37] <PK> ha ha women and their irrational moods lol!!! sort of thing"

" 13[18:37] <PK> you constantly made sort of little jabs at my direction when i had not even really been doing much

[18:37] <PommyN64> THAT'S what I was concerned about, what I was expressing to you!

13[18:37] <PK> did you not stop to think "maybe this isn't a nice thing to do"

13[18:38] <PK> "maybe joking about women isnt funny"

[18:38] <PommyN64> Did you not stop to think "This bothers me, I should PM him and inform him"?

08[18:38] <PommyN64> Communication, PK. That's all Inline Wanted.

13[18:38] <PK> I had no desire to talk about things, and by the time you finally left that was it"

There was never any acknowledgement that his sexist jokes weren't funny and were making other people uncomfortable. He came into my channel with preconceived notions elsewhere and acted elusive about "dirt". I had no idea what he was talking about. He refused to answer when it came up.

"[18:40] <PommyN64> But there a lot of people who don't want to deal with this bullshit to begin with, and I know I'm not the only one you've done this with.

13[18:40] <PK> and i cannot believe you bought into the "dirt"

13[18:40] <PK> "done this with"

13[18:40] <PK> what the hell is that even supposed to mean

13[18:40] <PK> you mean, that I might be mistrustful of someone who I think is buying into crap that isnt true?

[18:40] <PommyN64> Banning out of avoidance, the arguments in chat, the heel-face turns emotionally.

13[18:40] <PK> banning out of avoidance, are you kidding

13[18:41] <PK> more like banning out of is being an asshole?

[18:41] <PommyN64> I don't think you trust anyone besides Marl or Eevee because they're the only ones who pander to every little thing you want. Everyone else you keep at arm's length with a courteous smile.

13[18:41] <PK> or is causing problems?

13[18:41] <PK> I think you can continue to make more statements that show you know very little about me

13[18:41] <PK> but it doesn't really do anything

[18:41] <PommyN64> There's no point to it. We can agree to disagree all day long.

[18:42] <PommyN64> But the original point is this. You've removed your 'problem'. Now give access back to the person who isn't.

[18:42] <PommyN64> Your beef is with me and me alone.

13[18:42] <PK> he already has his access back

13[18:42] <PK> i think you ought to think very hard about mindlessly believing incredulous things about people

[18:43] <PommyN64> I don't see why you'd be so eager to know about the 'dirt' people have on you if it was so unbelievable.

[18:43] <PommyN64> Why you would let it even matter.

13[18:43] <PK> because I like to know what rumors will come from whom"

I was really frustrated. He was not being straightforward about anything. Everything was a game of toying with me, and getting upset at me for banning people from my chat for conduct that was not appropriate and was against the rules. I had a rule of "no drama", where people weren't supposed to bring up random hurtful rumors, and he was getting on my case about that. And also, calling into question everything about how believable I was, etc. It was maddening.

" 13[18:44] <PK> you ought to think very hard about this in the future though

13[18:44] <PK> it's incredibly shitty to believe rumors like that and to bring them up at all if you say you're giving benefit of the doubt

08[18:45] <PommyN64> You're one to talk, PK. You are fortunate in that you hold a position of power where you can pretty much move things along as you please.

[18:45] <PommyN64> I'm not about to change that nor could I ever.

13[18:45] <PK> I've not been acting on rumor, however

13[18:45] <PK> rather, on things that have actually been said to or around me

[18:45] <PommyN64> But your reputation and your attitude do precede you. Even if those rumours aren't true, your mentality is shit. It's what you're known for.

[18:46] <PommyN64> I'm just the only one with the gall to say something on it.

13[18:46] <PK> my attitude is intolerant of bullshit

13[18:46] <PK> and there happens to be a lot of that in the community that i left behind"

I was losing my mind. I was intolerant of sexism, racism, gender discrimination, rumormilling, etc, and that is largely why I would remove someone from the chat. Sean was tut-tutting me because of removing someone acting in this way, because it made someone else upset. (I did not care.) Everything became a twisted game of not at all caring why I took any of the actions I did, only caring about how to come at me as aggressively as possible over it. It was somewhat surreal.

" 13[18:50] <PK> there's not really anything of use to be learned from someone who will just believe made up exaggerated garbage
 08[18:50] <PommyN64> I really do hope those rumours aren't true, PK. You're the only one who knows that for sure. Because if they are, they will never stop following you, and there's nothing either of us can do about that.
 [18:50] <PommyN64> But that's your burden to bear.
 13[18:50] <PK> I'm not the only person who knows that for sure
 13[18:50] <PK> the entire fucking school knows it
 13[18:51] <PK> I LEFT SCHOOL even after the guidance lady ASKED ME NOT TO and tried to get more scholarships
 08[18:51] <PommyN64> There's no point to explaining that to me PK. Whether you're lying or not is only known to you.
 13[18:51] <PK> because of MONEY
 13[18:51] <PK> I cant even fucking believe this though
 13[18:51] <PK> this is what got me frustrated
 13[18:51] <PK> this is what got me upset
 13[18:51] <PK> I dont lie
 13[18:51] <PK> I dont fucking LIE
 13[18:51] <PK> I DONT MAKE UP THINGS
 [18:51] <PommyN64> Have you considered that maybe people don't believe you when you say that because of how you act/"

Keep in mind, this was some half a year before he was pushing the idea in the thread that I was "kicked out of art university". I straight up told him, in my frustration, what happened with art school. I left for money reasons. I don't have a lot of it. I thought I could do better on my own, doing my own thing. Talking to him here felt so bad, because there was 0 empathy in it. Just, I explained my situation, and he flat out tells me there's no point explaining it to him, and that whether or not I'm lying is "only known to me". It was appalling.

The conversation was extremely difficult, and I still feel myself getting upset rereading the log. I get angry when people don't believe me, and I was LIVID in this conversation because of how nasty he was about it. And then he turns around and paints my anger like it's an unreasonable response to how he's treating me, in an act of victim blaming that continues to this day.

" 13[18:55] <PK> it's just eternally frustrating
 13[18:55] <PK> why would you think it's ok that people spread lies

13[18:55] <PK> because someone didnt like my attitude once? why is that okay then?

[18:55] <PommyN64> But how many people has that 'once' happened to? People will usually spread info to inform or warn others. If you piss off a lot of people, at some point those feelings are going to converge.

He tells me that it's ONLY ON ME that people mistreat me, or lie, despite him not listening to me telling him the truth. The whole conversation made me feel so queasy. He says "And in 3 years you've provided nothing for people to use against it" as if it's my fault for not proving rumors /false/. When, earlier in the same conversation, he shows he has no interest in learning the truth from me.

And then, immediately after,

"[18:58] <PommyN64> Well I'm not the one who spread it. And to my knowledge nice artists don't get smear campaigns that last 3 years. Furries don't stay interested that long.

13[18:58] <PK> am i supposed to dig up school papers, where i willfully resigned?

13[18:58] <PK> that's

13[18:58] <PK> such

13[18:58] <PK> a liar

13[18:58] <PK> lie**

13[18:58] <PK> all of this

[18:58] <PommyN64> Well, truthfully, unless you did no one has any reason to believe you. And with your attitude, they probably wouldn't want to."

He had been participating in the smear campaigns. He refused to listen to the truth, from me. The victim blaming was getting more unbelievable.

"[18:58] <PommyN64> It's like Obama's birth certificate in a way.

[18:59] <PommyN64> Except he eventually did that and it shut most of them right up.

[18:59] <PommyN64> So who knows? Maybe that's one of your few options left to quell this beast you've been dealing with for years now.

13[18:59] <PK> that's so fucking stupid though

08[18:59] <PommyN64> THat's not for me to control, PK. I have no choice in that.

13[18:59] <PK> it doesn't even matter except when people come in going Heh well I chose to not care about your.... "history."

13[18:59] <PK> yes, you kind of did

13[18:59] <PK> in bringing it up

13[18:59] <PK> at all

13[18:59] <PK> and lending any credibility to it in your own goddamn head

[18:59] <PommyN64> Well let me put it this way

[19:00] <PommyN64> If someone were to come to me, right now, saying they were thinking of commissioning you but heard I knew about you and wanted my thoughts.

[19:00] <PommyN64> What do you think I would do?

13[19:00] <PK> I don't care what you would do

13[19:00] <PK> that's why i left the furry community"

A weird veiled threat...? About spreading not to commission me, I guess? And then saying he has "no choice" in if people believe me over it or not.

"[19:03] <PommyN64> I know more than you think. It's not hard to figure out.

[19:03] <PommyN64> I've had to deal with the bullshit myself.

13[19:03] <PK> it is, apparently, because you've been wrong about a great deal so far

[19:04] <PommyN64> As you say. We're coming full circle again.

[19:04] <PommyN64> Only you know for sure. And only you live with the consequences.

13[19:04] <PK> might you reason, perhaps, that why I am so frustrated is that: I do know for sure, and so I know any "dirt" will be a lie?

13[19:05] <PK> so the fact that "dirt" exists when i am super open to people who ask things and are curious about stuff... and that I share a great deal of my life and feelings...

13[19:05] <PK> might be a little distressing?

08[19:05] <PommyN64> Here's the part you're missing PK. Regardless of if it's a lie, many people believe it is true. And as those many people share it, more will come to believe it because "how could so many people be wrong"?

13[19:05] <PK> when i know it cannot possibly be true?

[19:05] <PommyN64> This is basic psychology.

[19:05] <PommyN64> Even if YOU know it isn't true, THEY believe it is.

13[19:05] <PK> why would you actively participate in that

[19:05] <PommyN64> *Well, frankly, because you're not a very nice person and I don't care what happens to you as a result."*

Here is the part with the open malice. This was in 2013, May. Last year, 2018, April, I had to deal with a smear campaign where thousands of people spread that I was a pedophile, because of... I still don't even quite know why. I've had to deal with accumulating bullshit ever since Sean stoked the flames and kept encouraging people to harass me. It's gotten worse and worse. And he literally outlined the phenomenon here, which shocked me and left me feeling like he was a very dangerous person. " *Here's the part you're missing PK. Regardless of if it's a lie, many people believe it is true. And as those many people share it, more will come to believe it because "how could so many people be wrong"?"* This was **extremely frightening**. Because he had shown he had no interest in the truth, and had shown that he understood how crowd manipulation worked. I was having trouble comprehending that an actual human being could function like this. I wasn't sure if it was just trolling, or what, but it turned out not to be. I'll go into detail about the smear campaign later, because it's relevant to the reason that I'm really, really wary about him at the event.

"[19:06] <PommyN64> *I've decided, through my experiences with you*

[19:06] <PommyN64> *That you are a terrible individual.*

[19:07] <PommyN64> *And while I will not proclaim it loudly*

[19:07] <PommyN64> *If I am asked*


[19:07] <PommyN64> *I will share that."*

This is basically standard harassment I've come to expect. Which, whatever, sometimes people have disagreements and share that, right? But in this case, I tried very hard to talk with him and explain things. He shut me down at every chance, in order to push how the rumors were going to spread whether I wanted them to or not. I was shaken, but tried to move on. I didn't think it would have much impact.

About a month and a half later, after making me feel very unsafe in that conversation, he actually showed up to harass me IRL at Anime Expo. At the time, I was with someone with extreme anxiety, who had been present for the horrible conversation with this guy. We were both scared of him, because he gave off the air of "will hurt anyone he doesn't care about". He showed up at the table, and I didn't know who he was at first. He spoke in a very over friendly tone, and started complimenting only all of the voice work he did for my project (the project that he was in my chat for). I deflected, because I didn't want to spread bad feelings about him, and didn't want to be rude to a random stranger. Then after complimenting himself for a while, he left, and left a business card with me. I think he was trying to catch me in a trap of saying something bad about him, but I honestly just wanted nothing to do with him. I had no desire to start any fights.

The business card fell over and revealed his name. He specifically wanted me to know he had been there. I was frightened that he might come back and do something. I was really unsure of if he would want to hurt me or not, because of how malicious the conversation had been when we last spoke in PMs on the IRC channel. Security at AX didn't do anything about it, despite me having the business card. I felt really scared and sad at the time, because no one had taken the harassment seriously. No one took the time to understand why it was frightening, and I knew it sounded silly from the outside. Someone came to my table and complimented themselves for a few minutes? I know that sounds ridiculous, but the chats with him combined with him pulling this to try to "trick" me left me really shaken and feeling unsafe. It was a kind of harassment that was designed specifically to be hard to do anything about, which is what made me feel worse. He picks forms of hurting others that are very difficult to punish or call attention to, because on the outside, it doesn't look like much without a lot of context for why it would be hurtful or threatening. This is part of why I'm really concerned about him being at the event. (I'm really sorry there's so much to read, here. I just know that without context, it doesn't make as much sense.)

Do you happen to know the actual reason then? Even if it makes it unusable as ammo, I'd rather be informed about the real facts all around than have some truthful evidence and some fake. Would strengthen my argument overall.

Here is him, in Dec 2013, some 7 months after the conversation, believing a random stranger that I wasn't kicked out of art school. He then states he wants "truthful" ammo. AMMO. This was after he scared me at the convention, and after the malicious final conversation. I had done my best to not pay any attention to this guy. I didn't even post about the AX event at the time, or that he came to my table. I was trying very, very hard to ignore the harassment.

Here's what he currently had to say about it, as far as I'm aware, in February this year. It was frustrating because it's an extreme misrepresentation of what happened. I had removed people from being sexist and for discrimination, as the logs show. Here he is, painting this as being "a personal witness to their horrendous mistreatment of the VERY SAME PEOPLE they'd just enlisted to make their personal project a reality." Nothing about this was true. The couple people who got removed were violating boundaries, and weren't even part of the project itself. The project was basically a roleplay group, and I would make huge "prompts" for people to fulfill. The people who were removed weren't part of the creative staff, but were people who showed up to fulfill the prompts.

He says he "never" did things on the level that was suggested, but this is frustrating. He sexually harassed a 15 year old, and that was one of the things I talked about. They came to me personally, and they made a journal about it after I encouraged them to share their experiences, because I was concerned that Sean had gone after more people, in the meantime.

In the 2nd to last tweet, he paints my actions as trying to get him blacklisted. He talks about them as if they are fabricated accusations, but they are not. I will go into detail using the thread exactly what I talked about. It was not an accusation so much as doing the documentation of how I felt about his harassment.

I actually do owe him an apology for being unnecessarily harsh to him a good while ago, as I now realize he was less of a willful enabler and more of someone caught up in PK's agenda but unsure of what to do about it, as I'm sure anyone within her physical presence would hesitate to decide on.
So Marl, if you do see this, I'm sorry. You probably don't know my other identity, but if you think of 'that IRC' you'll probably guess it within a couple of minutes.
Your (ex?) fiance is still a total tool, though.

Here's a strange remark to my ex husband, who had cheated on me at the time, and that's what everyone was making fun of in the thread. I had posted about it and was upset, and Sean was in the group of people making fun of me for what my ex, Marl, had done.

I started documenting his harassment publicly, finally. This got people in the thread upset. But Sean didn't seem concerned, at first.

"Hi I'm not someone even remotely related to your industry but this dude called out my internet friend for cheating on someone in their relationship so don't hire him okay"
This will be fun to see, because last time I checked recording studios don't give a shit about your outside life unless you're dragging your issues into the recording booth. There are plenty of stories of talents being preferential over more talented ones simply because they get shit down and don't bog down production.

And then what happened was that a friend of mine who'd I'd fallen out of contact with... was contacted in order to ask them to provide my address. So that someone could kill my cats for trying to "ruin" Sean's career, for documenting the harassment. Yes, you read that right. So that's what I talked about in my posts - how scared I was of people trying to do this, because they were upset that his CAREER might be hurt if people found out about what he did. (As you can see, this didn't matter at all, because he got to voice in Breath of the Wild. I had very little impact on his career by talking about his harassment of me, with that as the metric. Conversely, my income has overall lowered about a third after the harassment ball he started rolling hit full momentum.)

I didn't even think about career stuff at the time of posting it - I just wanted it to STOP. I was so tired of the harassment. I was so tired of him spreading lies. I was so tired of how I would just have to accept feeling unsafe at conventions, where I made my money. I was so exhausted by

the whole thing. It wasn't supposed to be about his career, it was supposed to be about "this person will not stop harassing me even though I want nothing to do with them."

Around this time frame, maybe a couple months later, I had a 15 or 16 year old approach me to talk to me about Sean. I had no idea anyone was going to come forward, and it kind of shocked me when they did.

This journal is accurate to my memories of the Skype convo I had with this kid at the time, of them going over inappropriate ways Sean talked to them. I felt a little ill about the whole thing, and had no idea what to do except encourage them to talk about it. I didn't want to discourage someone who had been victimized from talking about their experiences, and I thought maybe Sean could learn to be more careful about who he talked to about what.

This was after I started teasing one of them half-assedly and the other was getting mad that I was being detailed with only that person. 2:50 AM

This is an inappropriate voice recording he made, that he sent to the 15 y/o, about arousing gay people for fun, even though he's straight. (As an aside, part of what made me uncomfortable with him in my chat were the undercurrents of making fun of sexism and making fun of gay

people / women. I didn't realize it lined up with how he acted at other people. I hope it's different now.)

There wasn't even any asking if the topic was okay, which made them uncomfortable. The whole experience was uncomfortable, and the individual stopped talking with him after the breach of boundaries.

So, here's how he refers to my involvement to others:




Did you ever apologize to purplekecleon/glitchedpuppet for harassing them a few years back? I know people change over time but it's hard to support you while remembering that happened :/

I owned up to it years ago, and continue to acknowledge my half of the situation whenever the topic is brought up.

That being said, it was definitely a two-way street of inappropriate behavior - not that it excuses any of my own - and I wish that those who were (and/or continue to be) affected by her own behaviors and choices would receive the same courtesy.

It makes me frustrated. Every single time he talks about me, it's as if we had equal involvement in harassing each other. I never wanted anything more than to be left alone. I only took action at the last possible opportunity. I suffered alone for most of it, because I thought it sounded too absurd to talk about. In the end, this gave him free reign to stomp all over my reputation as he pleased. I tried, I sincerely tried, to not make this a big deal.

Regardless... Not long after the messages from the 15yo, I got an email from a VA he worked with on the Dangan Ronpa games, and this person was very apologetic to me for Sean. He said he talked to Sean about his actions/conduct, and hoped things would pan out better. I was satisfied. I don't remember the timeframe, but there was a public apology from Sean, and he said he would drop it if we did.

As you can see from some of the other things I've pasted, with recent years timestamps, he has not dropped it. I'm just... frustrated. I tried very hard not to mention this dude at all. I really wanted him out of my life. But, it pains me to watch SGDQ with him in a position that's very easy to abuse - especially considering he had never taken full responsibility for things he said or did. He doesn't acknowledge the ways he hurt me, at all. He made it very clear that he would continue to hurt me for as long as he felt like it, simply because he didn't like me.

I'll go into the smear campaign a bit, now.

There's a site called Kiwi Farms, which regularly drives people who have threads there into suicide. Sean is an avid follower of my thread there, and links it whenever he can. It is explicitly full of people with the same mentality as him, who want to see me dead. It is the site that drove me into a nervous breakdown last year - I was not functional for a month. I was on the verge of suicide - and he was in the crowd of people cheering that on. I have since recovered via support groups, but the reason for the breakdown was because I was being accused of being a pedophile -- which was a twisted claim, based around my exhusband Marl talking to a minor inappropriately during the group I ran, that Sean briefly participated in. I had NO IDEA this was going on. Had I known, I would have done something about it -- just like I encouraged the 15 year old to come forward with their experiences. But because of being married to Marl, it was assumed that I knew, too. And this is something that Sean pushed. Now, what frustrates me about this, is that my exhusband supposedly talked to a 17 year old inappropriately, after they agreed to talk. I really don't know the details, because we split up last year after I couldn't get the truth out of him. (It was a horrible mess, and I had to restructure my whole life after escaping that relationship. I've been working through PTSD that was only exacerbated via Sean's actions, and the actions of everyone in the hate-thread.)

What really hurts me here, is that I am a victim of CSA. I was someone who would listen to and console people who had been through sexual abuse and trauma, and helped them recover from it. I used to regularly do this, until I got accused of being a pedophile by the crowd of people who don't have a problem perpetuating lies for the fun of it. The entire thread is full of people

with Sean's mentality - they don't care what's true, they just care about making sure people don't like me.

But, Sean never addressed the way he mistreated the minor. And I have another friend who relayed their personal experiences to me of how Sean treated them during 2014, and it was along the same lines of pushing boundaries and trying to use his status in order to appear cool, like someone you would want to talk to. And during that, he randomly messaged my friend to not support me or my work. I guess he's been going out of his way to undermine me to random fans for years, and I had no idea about it. I have never participated in something like that. The closest I came was the thread documenting the harassment, which I ended up deleting after I was confident that it was solved and that Sean would stop causing problems for me. I guess all he really cared about was making sure his image wasn't ruined? I don't know. I feel disheartened, and wish I had not deleted the journal detailing the harassment. I've had to recreate it here based on fishing up old logs and some thread pieces I'd saved. And since then, I've only made the one thread, and ONLY because he's at an event where I fear abuse might come into play.

I'm frustrated. He pushed false accusations onto me, because he could. He harassed me in real life, because it was funny to him. He tried all these different ways of making my life worse, when I wanted nothing to do with him and tried very hard not to talk to him until I couldn't stand it any longer, and just wanted it to stop. I don't know what to say. Maybe I'm the only person he harasses like this - in which case, well, I'm glad the harm isn't spreading. I've learned to be tougher about this stuff. I didn't want to make it a massive callout, because I'm honest to god don't want to deal with that. But I feel frustrated that he hasn't had to address any of the ways he's mistreated me or the other two people, because he's in a position where it's much harder to talk out against creepy behavior he might perform, and overstepping boundaries gets more benefit of the doubt when you're in a higher position. And he has shown he will abuse it against people he doesn't like, even when he says he won't anymore. I honestly really don't know what to do. I tried to give a condensed version before, but that really didn't suffice.

What's also frustrating is that he's the one who started orchestrating the hate mob, to begin with. I now get to deal with horrible rumors of being called a pedophile, abusive person, manipulative, etc, because of him. He has absolutely no problems lying about me, and uses the defense "nice artists don't get callouts". It's a severe abuse that frightens me. I didn't have to deal with ANY of this harassment like this until he showed up and started it, and kept pushing it. Combined with him knowing that "if enough people believe it, it's true", well... I had a twitter thread go around this past Feb where I was called a "known pedophile" for drawing some pokemon starters. That's it. And it got 5k retweets. Because that's how callout culture works, and I've been fighting it from the inside out for YEARS.

That's why I made a thread without naming him. I didn't want to start a callout, because that causes chaos/destruction in places it doesn't need to, but I didn't want to not mention this -- because to me, it felt a little like he pushes the "Glip is horrible" angle in order to run away from

having sexually harassed a 15 year old. He pushes the blame into me for that feeling, instead of owning up to it himself. And that SEVERELY frustrates me. He empathized with my exhusband, the one who also apparently did that. I don't know what else to say - I'm sorry for this huge text dump, and I'm sorry for this mess. I hope you can figure out something appropriate to do, because right now it feels like it's not really safe as an event. I have a friend at the event at the moment who hasn't felt safe being out and around because they're scared of running into him. Which... makes me really sad, actually. It's an event they've gone to before, and really enjoyed, except this time it's a little soured.

And I don't know - Sean made fun of me for not caring about how I treated others, when I always, always try hard to care about that. But I also don't have tolerance for people mistreating each other! I didn't have tolerance for people not trying to understand how someone else felt. Sean placed all of the blame onto me, for instance, for Sean making sexist jokes and me getting upset instead of "talking about it reasonably". It's just a no-win situation - he doesn't consider any emotions I have about being mistreated to be valid, whatsoever. I'm really scared this might be extending to other people or groups that he considers easy to make fun of, and I'm also concerned about the fact that he links Kiwi Farms as a source for anything. If you wanted to know about KF, aside from the fact that it encourages suicide of its targets, it also refused to surrender data linked to the New Zealand shooting.

The site is outright for these purposes, as stated by the site owner:

"Moon — an alt-right, anti-feminist, pro-white Trump supporter who claims he set up Kiwi Farms for the "gossip and exploitation of the mentally handicapped for amusement purposes" — published the exchange with Detective Michael without bothering to hide the officer's email address."

It's specifically to exploit neurodivergent individuals. Everything about it is about tormenting others for fun, and this is something Sean willingly engages with. I don't know if he does it with anyone besides just me, but it still makes my life a lot more unpleasant, and makes my friends feel unsafe as a result of seeing him at the event. This site is synonymous with "does not care if trans / mentally ill people kill themselves".

I think that's about everything. I spent many months extremely frightened of Sean. Now, he's mostly just kind of an upsetting reminder of how people will abuse their positions of power once they reach them. He paints my actions as trying to hurt his career, or paints me as a horrible oppressor, but I was really just someone trying to ban sexism from my roleplaying groups. It's so tiring. He never had specifics about the mistreatment, because they didn't exist. All he has to say is "I watched them horribly mistreat people" and it gets believed, because he pushed for the smear campaign to exist, which already wanted to hate me.

So. I'm sorry. This stuff mostly feels like... I've spent years processing the trauma that was started by him, and I've only just started to recover in the past half year. Sending an email like this before? It would have been unthinkable, because I was absolutely terrified no one would

believe me -- which started with Sean flagrantly showing off how he didn't believe me, never would, and would make sure others didn't, either. I feel a little terrified that all of this will be dismissed, just because of the fear response that's been ingrained in me over this. I would almost call it cartoonishly villainish, if it didn't actually lead to me having had to flee my home last year on account of how bad the harassment that he started got. He likes to deflect his involvement when asked about it, because a lot of people don't have the time to read over a whole document detailing harassment, and it's very easy to claim someone is bad when you know the crowd will believe you.

Anyway, that having been said, thank you for your time. I don't know what to say except my story, so here it is. I tried to back it up with logs in every place I could, but I don't have access to some of his remarks, and I don't really want to get bad stuff stuck in my head by looking through his old twitter comments any more than I have to. He only temporarily stopped harassing me once he was scared his career would be jeopardized - his dad threatened to sue me for just talking about the actual, literal things Sean said and did to me, with no exaggeration. I was floored. I kept it up until Sean's public apology, though. It was deleted sometime after that, even though he did not end up sticking to the agreement he proposed of dropping the topic.

I guess now that he's not scared of losing his career, he can be more blatant in his mistreatment? I don't know. It got worse after he got the BoTW role. He more openly blamed me after that, and pushed people to participate in trying to run me offline. One of the most bizarre occurrences was that, in the twitter thread I linked above, he's actually talking to one of the people who pushes very hard that I'm a horrible pedophile who "doesn't listen to victims". He's casually replying to them, even though there's the 15 y/o victim of Sean's sexual harassment who I openly talked about and supported. So, I guess it would be in Sean's best interest to make sure no one believes me? Because if I believe that victim, then no one who hates me has to believe anything that person says. So, what am I supposed to do? It's been such a fucking frustrating mess. He's spent a long time carefully making sure that people don't want to believe me, so that his own actions are covered up by pointing to how I'm to blame. This is part of what made me frustrated/sad about the idea of emailing the full story. I'm sorry I didn't the first time, and that you had to reach out -- I was really terrified of going into more detail, because I am extremely terrified of him and what he'll do behind the scenes. I don't think I can take another round of being driven out of my house by the mob trying to enact mob justice, and he certainly knows the psychology behind harassing others with a mob.

Thank you for listening. Again, I'm sorry this is so long. I didn't see how I could shorten it at all, on account of how messy and complicated the history is. I have done my absolutely best to recount it as accurately as possible, with as little exaggeration as possible, because I take it very seriously - people lie/exaggerate about me all the time, and I don't want to make it worse than it was, but I also want to be accurate about the negative impact it has had. Please feel free to ask me any questions and I will do my absolute best to answer. I hope this information helps you all in some way.

Sorry, followup. I've included one of the screenshots of him deflecting a callout based on sexually harassing the 15 yo... by blaming it on me. You can see some of his lies at work here - "The writer of the journal OP linked to is under investigation for child grooming and bestiality" -- the journal linked to was by the 15 yo, not me. And I've never been under investigation for those things, or for ANY things. This is something he perpetuates. He acts like police have gotten involved, or that any of his rumors/lies about me are true, in order to deflect from having to deal with what he did. He painted it as "(ongoing) harassment", and calls me an "actual documented predator" based on things he helped perpetuate from the hate site, Kiwi Farms. He links it in the screenshot. (This was a reddit post he was replying to). I don't know how to even respond to this kind of thing. I get to deal with randos perpetuating the lie that I'm "on the run" from police, over crimes I did not commit and have no involvement in. It is absurdity at its finest, the result of people really wanting vigilante justice to mean anything. It's also incredibly frustrating. How can I possibly prove something like that isn't true, to a mob full of people who want to believe whatever horrible thing fits their narrative?

What made me really sad reflecting on all of this, is that I had been trying to get help from people for my husband cheating on me back when Sean jumped into the thread, making fun of me for talking about my relationship issues. It drove me away from talking about it at all, which ended up leading me to be stuck in an abusive dynamic for years - because I was so utterly terrified of people like Sean defaming me for talking about personal issues and trying to work through them. I became incredibly isolated after that. Conventions were difficult to attend - especially Anime Expo. He planted the idea that he could hurt me if he wanted to, and no one

would believe me or care. He planted the idea that he could lie to a whole crowd quite easily, and everyone would believe it, because he hated me and liked watching me suffer. I just don't know what to do. I've never cared either way about him -- I kept trying to get over it and write him off as a creep, but he's resurfaced over and over to twist blame in weird ways.

Sorry, it's just frustrating. I've been having to deal with this for years. He's at the forefront of twisting my actions into something disgusting in order to deflect from having to address his behaviors. He says he "would not send such audio to known minors" - which I imagine is to cast doubt on the victim's testimony, in a sense of not knowing whether or not they were an adult, or at least claiming this. It makes me want to pull my hair out that he calls it ongoing harassment, when I stopped mentioning him after the public apology in early 2014. I have spent the past 5 years not talking about him - the only people I shared it with were close friends, who knew not to harass him or talk about it anywhere. I did not call for any action, or for anyone to do anything. I basically tend to forget this dude exists in between hearing about something new he's done to try to hurt me. And then, at risk of not being believed, I just don't bother replying. This is the only time in the past 5 years I've been motivated to talk about it, mostly because it has been frightening to think about the ways he could apply this behavior to anyone else while in that position.

Thank you for your time, and hopefully this should be the end of my followups.
