| Whereas(1): | In both College Station and Bryan, no more than four unrelated individuals can live in a single-family detached home, and in some areas, it is no more than two; and, |
| Whereas(2): | Many students live in violation of these ordinances, frequently not knowing that they are breaking the law and could be taken to court and fined for over-occupancy; and, |
| Whereas(3): | College Station is creating Middle Housing, a zoning type that allows more than four unrelated individuals to live together, and is rezoning some areas of town that exhibit a more dense characteristic; and, |

Whereas(4): Expanding Middle Housing zones give students and residents more housing options bolstering individuals' freedom and opportunity in housing decisions; and,

Whereas(5): The Division of Student Affairs is actively rebuilding the Off Campus Student Services office to support students through apartment finding, renter education, and community connections; and,

Whereas(6): Concerns

about over-occupancy contribute to the breakdown of student-community relations, threaten tenant privacy, and create distrust within neighborhoods.

Resolved(1): The Student Senate fully supports the rezoning of areas that already have high concentration of students and over occupancy to Middle Housing; and,

Resolved(2): The Student Senate asks the City of College Station to support rezoning expansions that promote affordable housing benefiting students and other residents alike; and,

Resolved(3): The Student Senate requests the City of College Station collaborate with students and the new Off-Campus Student Services office as it begins functioning; and,

Resolved(4): The Student Senate also asks the City of College Station to work with students who have already signed an illegal lease for the 2023-2024 academic year if they come forward, so that landlords and/or property management companies, as appropriate, can face consequences; and,
