- Shared take-aways of the September 20, 2022 Town Hall Meeting with Bishop McKenzie.
- Shared success of the CUS 150th anniversary recognition during NCC's Christian Unity Gathering
- Acknowledged UMI's withdrawal from CUS partnership. As La Verne is a UMI employee she had
 to resign from serving as Chair of Scope and Sequence Committee. A letter was sent to thank her
 for her leadership in directing the work of Cycle 25 through near completion.

- 2) Approved the edited 2021-2022 Key Executive Committee Actions and the 2022 Annual Meeting Minutes which will now be presented for vote of approval at the 2023 annual meeting.
