# **Privacy Policy**

**Game Lock** and it's websites, games and other applications believe that your privacy is really important. This Policy describes the personally identifiable information and other data that we will collect from you through the apps and games we provide, and how we will use and when we might display such data to third parties.

## 1. WHAT KIND OF INFORMATION WE COLLECT?

The information which does not identifies you and can not be used to contact you personally. It includes "your date of birth", "age", "ZIP code", "your city", "gender" as well as the information about your computer and mobile device such as unique device ID, Internet Protocol (IP) address, or other persistent identifiers, and their hardware/software/firmware. ## 2. HOW WE USE COLLECTED INFORMATION?

• We use this information to operate, maintain, and provide to you the features and functionality of our studio, and to communicate directly with you as well, such as to send you email messages and push notifications, and permit you to share your creations on the Game Lock developer with your contacts or social media sites. We may also send you Service-related emails or messages (e.g., account verification, order confirmations, change or updates to features of of our account, technical and security notices).

## 3. HOW YOUR INFORMATION MAY BE DISCLOSED

a. Personal Information. We do not store Personal Information and therefore we do not disclose your Personal Information.

b. Non-Personal Information. We do not sell, trade, or otherwise transfer to outside or third parties your information. We do not combine Non-Personal Information with Personal Information (such as combining your name with your unique User Device number).

c. We may disclose your non-personal information for promotion purpose to our trusted partners who shall comply with this privacy policy and the relevant privacy laws.

## 4. THIRD-PARTY SITES

Game Lock may employ proprietary or third party ad serving technologies that may use cookies, tracking pixels or other technologies to collect information as a result of ad serving through our Games as well as to help track results. Some dynamic in-game advertisement serving technology enable advertising to be temporarily uploaded into your Game, mobile device and replaced while you are on line. We or third parties operating the advertisement serving technology may use information such as age and gender as well as information logged from

your hardware or device to ensure that appropriate advertising is presented within the Games and to calculate or control the number of unique and repeat views of a given ad, and/or deliver ads that relate to your interests and measure the effectiveness of ad campaigns. The foregoing data may be used and disclosed per this policy and the privacy policy of the company providing the ad serving technology.

These ad serving technologies are integrated into our Games; if you do not want to use this technology, do not play.

## 5. USERS WITH WHOM YOU SHARE YOUR INFORMATION

We cannot control the actions of other Users with whom you share your information. We cannot, and do not, control the information you share with other Users using an Application or Game. We are not responsible for third party circumvention of our security measures and limits.

## 6. SECURITY

"Game Lock" is very concerned about protecting the confidentiality of your information. We do not collect Personal Information, and we employ administrative, physical and electronic measures designed to protect your Non-Personal Information from unauthorized and unknown access or use. Please be aware that no security measures that we take to protect your information is absolutely guaranteed to avoid unauthorized access or use of your Non-Personal Information which is impenetrable.

#### 7. SENSITIVE INFORMATION

We ask that you not send us, and you not disclose, any sensitive Personal Information (e.g., information related to racial or ethnic origin, political opinions, religion or other beliefs, health, immoral behaviors, criminal background or membership in past organizations, including trade union memberships).

#### 8. INTERNATIONAL USERS

If you object to your Personal Information being transferred or used as described in this Policy, please do not use any Application and immediately delete all Applications from your User Devices.

Some of our applications uses few app permissions before using any our app you must review first, or you may also find permission and their use detail in application description (on apps Store). And the user must keep in mind all of permissions is totally local, means up to application use. Such as Contact access, sd card read and write, Location access etc. contact access just for access contact by application for user operations similarly sd card permission for saving photo or editing purpose, and similarly location access for getting current location etc. while other use defined above.
