Gym Club Solutions Privacy Policy

1. Introduction

Gym Club Solutions is committed to protecting the privacy and personal information of its members, athletes, coaches, staff, volunteers, and other stakeholders. This Privacy Policy outlines the organisation's practices for collecting, using, disclosing, and managing personal information in accordance with applicable data protection laws and regulations.

2. Scope

3. Personal Information

consent at any time, subject to legal or contractual restrictions, by providing reasonable notice to Gym Club Solutions.

6. Use and Disclosure of Personal Information

Gym Club Solutions uses and discloses personal information only for the purposes for which it was collected, or as required or permitted by law. The organisation does not sell, trade, or rent personal information to third parties.

7. Retention and Security of Personal Information

Gym Club Solutions retains personal information only as long as necessary for the fulfilment of the purposes for which it was collected, or as required by law. The organisation employs appropriate administrative, technical, and physical safeguards to protect personal information against unauthorised access, disclosure, or destruction.

8. Access and Correction of Personal Information

Individuals have the right to request access to their personal information held by Gym Club Solutions and to request corrections if the information is inaccurate or incomplete. Requests for access or correction should be made in writing to Gym Club Solutions' Privacy Officer, who will respond within a reasonable time.

9. Changes to the Privacy Policy

Gym Club Solutions may update this Privacy Policy from time to time to reflect changes in its practices or applicable laws and regulations. Any changes will be posted on the organisation's website, and individuals are encouraged to review the Privacy Policy periodically to stay informed about the organisation's privacy practices.

13. Children's Privacy

14. Privacy Breach Notification

In the event of a breach of security safeguards involving personal information under Gym Club Solutions' control, the organisation will notify affected individuals and relevant authorities, as required by applicable data protection laws and regulations. The notification will include information about the nature of the breach, the personal information involved, the steps taken by Gym Club Solutions to address the breach, and the contact information of the Privacy Officer for further inquiries.

Employee and Volunteer Training

Gym Club Solutions provides training on this Privacy Policy and applicable data protection laws and regulations to its employees and volunteers who handle personal information. The organisation ensures that employees and volunteers understand their responsibilities for protecting personal information and are aware of the procedures to follow in the event of a privacy breach or other privacy-related incidents.
