#### SYLLABUS STATEMENT

This course was designed by a team of faculty utilizing the evidence-based design processes. The purpose of the syllabus is to provide clarity about course expectations and contact information. Consider using this document as a guide for the course and to provide transparency and accountability for all.

#### **COURSE DESCRIPTION**

The Urban Community Ambulatory Medicine (UCAM) program; FMCH 7600, FMCH 7700, & FMCH 7511; is tailored to students who are considering a career in Family Medicine and who are passionate about providing care to underserved, lower income and ethnically diverse patients. UCAM provides 12 weeks of continuous ambulatory experience in an underserved urban community Family Medicine clinic. Students are required to attend the Family Medicine Clerkship didactic sessions then UCAM's final 8 weeks expands the Family Medicine Clerkship exposure to patient diversity, low income, multicultural urban medicine, and community health. The curriculum will include various topics in culture, reviewing important primary care clinical content, advocacy, and priorities in providing care to the underserved. Students will partner with their site for a 12-week quality improvement/community engagement/public health project that the student will present at the end of UCAM.

From a scheduling point of view, UCAM combines the 4 weeks of Family Medicine Clerkship with an Acting Internship (FMCH 7700) and 4-weeks of hands on elective credit (FMCH 7511). Inquiries should be

- 1. **Didactic Sessions -** Zoom didactic sessions with a Co-course Director including interactive lecture/case based content. Didactic sessions are scheduled for ½ day total a week, usually late Monday or Wednesday afternoons. Attendance and participation is required in order to receive a passing grade.
- 2. **Community Engagement/Quality Improvement Project** Participate in a project in clinic. Dr. Power will give details in Week 1. The proposal is due Monday of Week 5, during UCAM Orientation. The final project will be presented on at the course conclusion. Students should have a visual representation of their project to share (poster, slide deck, graphic, etc).
- 3. **Mid Clerkship Check In** Students will meet with Dr. Power as a group during Week 6 or 7 for a check in on the course and the Community Engagement/Quality Improvement Project. Bring any questions and concerns to this meeting. Students should also check in with their site lead to discuss EPA and clinical progress through the program.
- 4. **Final Clerkship CSA** Students are required to meet with their site lead during the 12th week of the FM clerkship to complete the final CSA. A score of 3.5/5 is the passing threshold for the CSA. Site Leads who have evaluation questions should contact Elisabeth Arendt at <a href="MSE@umn.edu">MSE@umn.edu</a>. 5. Entrustable Professional Activities (EPAs) - EPAs were designed to provide useful, formative feedback to students to encourage a growth mindset, and provide a rating that does not contribute to a student's grade. During the 8 weeks of UCAM after the required Family Medicine Clerkship, we expect a total of 24 EPAs. Weeks 5-8 will be tracked under course FMCH 7700 and weeks 9-12 will be tracked under course FMCH 7511. Failure to complete the EPA requirements will result in a No-Passing grade.
