BRIEF BIOGRAPHY

To comprehend my conviction of Faith in this campaign, let me give you a brief Spiritual biography of my life, beginning the night before I came into this world.

On June 10th of 1952, my mother's doctor had a vision that he would deliver a baby with the cord around its neck. The next day my mother went

into labor. Having trouble, he decided to check for the cord and sure enough it was around my neck. An emergency cesarean section was done, at which time the doctor discovered the cord was around my neck three times and tied in a double-slip knot (hangman's noose). I arrived a month early, weighing in at 3 lbs 15 oz and 17.5 inches long.

I will not go into all the times I almost lost my life during this first year or throughout my lifetime, but will skip a few years ahead to my playmate that only I could see. I called her "Becky" as I could not say her full name. She taught me the ways of the Lord and showed me many things still to come. But unfortunately, at a young age of perhaps 4, I had a limited vocabulary so my mother thought it was all make believe. I'm sure what I learned lead to my questioning the teachings of the church at the age of twelve. Because of this, I stopped sharing what I was told, but I followed every word until I was 16.5 yrs old.

At that time, in Oct someone poisoned my two cats. The next month a new friend was found drowned in her pool. But the straw that broke me was the murder of the first love of my life. That is when I got angry at God; after heeding every word without question, I did not comprehend why the things most precious to me were taken away. I told God that He would have to prove Himself to me before I would ever follow Him again. The next 13 years I was sent many signs, but I refused them saying they were not good enough. I wanted undisputable proof, & once I got that, I began listening again. I had forgotten that everything happens for a reason in my anger and grief.

In the early 1980's, I awoke one morning to find a red circle in the palm of each hand. When my then spouse saw these, the light in his eyes went out and darkness took over. He became a different person from the one I knew; Very angry, mean, vicious and violent at times. But I believed I could bring him back so I stayed with him for 13 years. I had forgotten that only he could bring himself back into the light.

In 1986, I received hepatitis C from blood transfusions upon having a hysterectomy. Of course, this was not discovered until 1992; unable to explain my symptoms till then. I knew I was ill for a specific reason and I did not question why, but waited patiently to learn the reason. During this time, the Lord told me of many things; some I even laughed in His face saying: That would be a miracle! Why would you want to do that? He'd say, you'll see. I kept all that my Lord was telling me to myself, for some things I shared scared people and others became overshadowed by darkness. So I began keeping it all to myself until I knew beyond a shadow of a doubt that everything my Lord was telling me, was the absolute truth.

My illness had put me into an electric wheelchair by June of 2003. I wore tri-focals, had diabetes, high blood pressure, thyroid disease, COPD, a form of rheumatoid arthritis, chronic nausea and vomiting, and more. I moved to a new area in November of 2003. For the next two summers, I began using the association pools but my health began failing.

My doctors tried to tell me it was all in my head; said to just take lithium and I'll be happy all day through. I refused, for I knew something was wrong but did not know what. In June of 2006, my family came to visit and upon going to use the pools, found them contaminated. I let the association president know and a cleaning crew was out in the morning. But when the pools were opened within two hours, I began doing some research.

I discovered that there is one bacteria that takes up to 8 hours to kill and someone with a compromised immune system is more susceptible. I finally believed the reason for my illness was to save the lives of the 181 families in the association from this self-serving minister, president of the H.O.A. I got the number to the person who would handle my final arrangements, but before I could call, my mother called. I told her I was dying and making my final arrangements that day.

Before I could make my call, a surge of energy, life filled my body. 25 years of listening had begun to come to fruition. Things I'd never done before began to occur such as: automatic writing, spiritual travels, stigmata and more things in line with the Spiritual realm. One thing I wrote as an example; was that the polygamist, Jeff Jetts would be caught that year. He was, three months later.

Things deemed impossible by mankind, I've experienced; Such as going to bed one night at my normal 132 lbs, but waking to be only 107. Another morning waking to find that my feminine attributes were gone; Chest as I was at 16 years of age and my bubble rear-end now flat. Not much of a waist left either. I just know I looked up and said, I sure don't know what you are doing to me, but you must know what you are doing. I accepted the changes, yet did not understand them as yet.

About the middle of July of 2006, I awoke in the morning to find two blood red/purple marks on my feet; same spot on each; Nothing to explain how they got there. They faded away in 6 weeks. Or on another morning after waking from a Spiritual journey to find a partially healed spear wound in my inner left thigh. That left within days.

Towards the end of July, I was commanded to read the Book of Revelations. I began to argue saying: I never understood it before, so why would I now? But I finally gave in and began to read. Within a few sentences, I knew what I was reading but could not put it into words.

Upon finishing the Book, the Lord then told me to write down the months and years of the 5 events spoken of. I refused stating that No man may know that. My refusal earned me a black rose thorn in the palm of my right hand. Again I was asked and again I refused. Each of my 5 refusals subjected me to 5 black rose thorns in my right palm. Upon writing down as I was told, the thorns disappeared back into my palm.

Now the greatest stigmata that occurred, was witnessed by two others. At the stroke of midnight on December 1st, 2006, I felt like I had been dipped into the icy waters of the river Jordan, but I wasn't cold. Then my breast-bone began to dissolve away. A sink hole the size of a half of grapefruit appeared below where the breast-bone should be. You could feel three separate heartbeats on the edge of the hole; left, right, & below. My ribs all broke away, giving the appearance of those that had been buried a long time.

But worst of all, I was stripped of every explanation of the physical realm, leaving me with just the Lord's Word. I felt lost as I could no longer explain any of it. At the end of 3.5 days, the sink hole mostly filled back in and my ribs returned. But now my ribs no longer had a curve to them like you see on a skeleton. My ribs now form a Vee on each side.

Then another stigmata began; It felt like six penny nails were being driven into my head; Worst than a migraine, yet bearable. I knew I had forgotten something in time and if I did not recapture what I had lost, I would go insane. I had to make a repeat drive down the California coast, the last trip made with my father when I was 16. During this trip, many memories came flooding back; Lessons to be relearned from the passing of time.

Six months later my jaw bones changed shape as well. The dentist has not seen anything like it in the history of medicine. No explanation to be found. They cannot explain the healing of all my health problems. My eyes are again 20/20 yet I had the worst astigmatism ever seen. Normal lung & liver functions, yet was at stage 4 cirrhosis and COPD.

I finally knew why the events of 1968 had occurred. My Lord had to close me off from Him so I could learn the ways of men; learn what had happened in time. Only then could I yield the Sword of Truth to discern between right and wrong as given by the Lord, thy God.

I could tell of many other experiences, but there is not time to go into full details. Just follow over the course of the campaign trail before you make a

final decision. My integrity and conviction will speak for itself.

The last two verses of John 15 and the first 25 of John 16, tell who I am and why I was sent; To shew into remembrance that which was taught; as I was present with Christ then, as He is present with me today.

The largest issue facing this Nation and its people is the ECONOMY. It is easy to look on the surface of the situation, unemployment, home foreclosures, etc. But to truly comprehend why the economy is in the state it is, you have to look at the big picture; all the aspects that have given way to what the Nation faces today. This is not something that happened in this administration or the one before or the one before that. It has been building for a very long time.

So when we look towards solutions to the economic crisis, we must examine every aspect that has created the situation. Part of it is that the "Mind Thought" of the people has changed over time. One of the main culprits is living beyond our means, CREDIT. Be it in government or by its citizens. Government spent only what they had collected until the Federal Reserve offered credit. SECURING OUR BORDERS

Definitions of U. S. Citizenship

The [14th Amendment](#) defines citizenship this way: "All persons born or naturalized in the United States, and subject to the jurisdiction thereof, are citizens of the United States and of the State wherein they reside." But even this does not get specific enough. As usual, the Constitution provides the framework for the law, but it is the law that fills in the gaps.

Currently, Title 8 of the U.S. Code fills in those gaps. [Section 1401](#) defines the following as people who are "citizens of the United States at birth:"

- Anyone born inside the United States *
- Any Indian or Eskimo born in the United States, provided being a citizen of the U.S. does not impair the person's status as a citizen of the tribe
- Any one born outside the United States, both of whose parents are citizens of the U.S., as long as one parent has lived in the U.S.
- Any one born outside the United States, if one parent is a citizen and lived in the U.S. for at least one year and the other parent is a U.S. national
- Any one born in a U.S. possession, if one parent is a citizen and lived in the U.S. for at least one year
- Any one found in the U.S. under the age of five, whose parentage cannot be determined, as long as proof of non-citizenship is not provided by age 21
- Any one born outside the United States, if one parent is an alien and as long as the other parent is a citizen of the U.S. who lived in the U.S. for at least five years (with military and diplomatic service included in this time)
- A final, historical condition: a person born before 5/24/1934 of an alien father and a U.S. citizen mother who has lived in the U.S.

At the time that these were written, we had very few coming into the country illegally. But that is not the case today. A loophole was left that has given way to what we have today.

Now if we take a look fully at what was written, I do not see where this applies to any who are here in this country illegally. This has created the influx of so many that have no legal right to be here in the first place. Their children do not have the right to be declared a U.S. Citizen just because they were born here. These parents are not U.S. Citizens nor have they entered the country through proper channels. Any child born from one with no right to be here should automatically receive the same citizenship of its

parents, period!

By allowing this to continue, we will see more & more border problems, more families split apart because of different citizenships between the parents & their offspring, increasing medical expenses at the legal citizens expense, and so on. Instilling hatred & prejudice between borders.

It is time to nip it in the bud, so to speak. If you did not come to this country through legal means, than you have no right to any of its benefits nor do your offspring just because they were born here. Only in this way, can this influx be stopped. In the long run, savings thousands & thousands of dollars of the legal taxpayer's hard earned dollars; A very simple solution to an ever increasing problem.

WAR, WHAT IS IT GOOD FOR?

Since the history of this nation began, there has been war. But what most people are completely unaware of, is that the elite group behind the scenes is orchestrating each one to bolster their own greed. Playing each side against the other, since our revolutionary war to gain our freedom from England's rule.

This group went to England and incited them into using force against us, their unfaithful citizens. They supplied the soldiers for the enforcement, but England was to pay them for each one that died in the battle. From personal experience, I was reading at age three. My first day in Kindergarten, I was made to stand in the corner for reading a book to my classmates. In first grade, I was doing third grade work. School officials refused to let me skip grades based on my physical stature. By the time I reached High School, I was so bored with education I sat on the floor in my classes and doodled; But of course, with my teacher's approval. I

was offered a scholarship for college, but by then I didn't want any part of education. I had been bored enough.

I believe that the best classrooms were the ones as they did in one-room school houses. Children of all ages, begin taught together. The older children assist the teacher by assisting the younger children in their work. They learn compassion for others of all ages in this way of teaching and it does not promote an environment where groups bully others.

I truly like the way Charter Schools are organized. They have the same required subjects that government run schools have, but they have the Freedom to teach subjects beyond the requirements. Any parent or professional can teach the subject they know best to inspire the children in different aspects, careers, and personal growth. Assisting them to become upstanding citizens and prepared to meet the world. With so much parental involvement in the children's education under Charter Schools, I would tend to believe it is as feasible as home-schooling.

It is not the government's job to dictate every aspect of education for our children. It should be by "Parental Choice"; be it home-schooling, charter school, private school, or not at all. But it never should be mandatory by Government. This is a parent's responsibility, not government's.

HEALTH CARE

The first thing that must be done to reform medical coverage for all citizens, it that the citizens, themselves, must take responsibility for their acts that have also added to such increased rates. It used to be that you went to the doctor when necessary, everything else was handled at home. But when medical insurance became widely available, the mind thought of the people changed. Now believing that since they pay the same whether they use the doctor or not, they might as well go for every little thing; creating a greater demand, leading to higher costs.

I support the creation of a "Medical Coverage" account, similar to that of IRA's, with monthly amounts to be contributed, according to each individuals needs. Many citizens may only need to carry catastrophic insurance and later add full medical. Others may choose to pay as they go directly from their account. But the best part of this option, is that the citizen, himself, has the control over his own medical coverage. Personal

Freedom of Choice, as guaranteed under the U.S. Constitution.

OUR JUDICIAL SYSTEM

Over time, our judicial system has become nothing more than a joke and a drain on the taxpayer's pocketbooks. Criminals are given more rights over their victims, yet in other cases, only the victim's word is needed to try and convict. Everyone trying to be sure that someone's individual rights are kept, no matter the cost.

And when a child is concerned, they are considered guilty as charged before the case is set for trial. And in these cases some are done without any type of proof, just the words being spoken. Most of these cases involve a custody issue. Usually, one parent seeking revenge for losing custody, but manipulating the child to do as they say or they cannot get the custody order changed. But in the mean time, the one parent's life is complete destroyed; even if found Not Guilty!

Even when a person is convicted, they have lost nothing but the freedom to come and go as they please. They are given room & board, medical, dental, television, college courses, and so forth. It sounds more like a closed campus college. As long as there is not a set punishment for each type of crime, the offenders will keep offending for they have nothing to fear.

I hate to admit it, but I understand the logic of some eastern cultures. If a thief knows he will lose his hand if caught, he will not offend, or at least not a second time. LOL... I don't mean we need to go to this extreme, but there needs to be a set consequence, that the criminal would not want to pay the price for the crime. This in turn should result in less repeat offenders & eventually fewer and fewer first offenders. Sheriff Joe in AZ,

has done the best job yet to prove this to be true. Check out his track record yourself.

With the advancements in technology and DNA, many times there will be no doubt of the guilt of the party. When this is the case, there should be no need for a trial, for the guilt was proven by scientific means. But in other cases, it will not be as clear. These are the cases that should be done by trial. This lessens the cost and number of court cases tried each year. And if all were run in the same fashion as Sheriff Joe's, they would be supporting their own population, not depending on government taxing the law abiding people to pay for their expenses.

TERM LIMITS & PER DIEM

Part of what is wrong in the government of today, is that it has become a career choice over serving the citizens. Local governments pay a per diem for their elected officials; a token of appreciation for serving the general public. As an example, my ex-spouse received \$50 each time the Traffic Commission was in session, City Council on per diem as well.

Unfortunately in time, this is not the case in the State & Federal governments. It has become a career choice instead of a duty to serve the citizens. Congressional pay from 1/08 to 1/09, was \$174,000+ for the year. Broken down to days & actual hours served, this is outrageous pay especially when you look at the median income here in the states & what little they are accomplishing in the White House. They have put themselves first & foremost over the people they were elected to serve.

I BELIEVE President Washington said it best. He turned down the \$25,000 per year salary stating that it was his civic duty to serve and did not need the money, had his own. When was the last time we had candidates that felt it was their civic duty to serve, not pursuing a political career?

The first per diem set by the Founding Fathers, was \$6 per day of service. Covering expenses only, not luxury hotels & extravagant meals, just the basics to get the job done. In 1857, Congress provided for pay at the rate of \$250 per month while in session, or a maximum of \$3,000 per year. After taking into account the difference in time and economic growth, that equates to approximately \$5,500 per month while in session, or a maximum of \$66,000 per year. But because of the state of the economy and the fact that it is a duty to serve the people in government, I would set the Congressional pay at \$5,000 per month while in session, or a maximum of \$60,000 per year. That is a saving of \$114,000 per year, per Congressional member.

With One Hundred (100) Senators and Four Hundred and thirty-five Representatives, that would be a savings of \$60,990,000. Eliminating pensions, since this is not a career but a civic duty, the savings increases. As of October 1, 1986 there were 290 retired Congressional members receiving a pension of \$60,972 each.. That would total \$17,681,880. Now added to the total for Congress, we have a grand savings of \$78,671,880. And to keep in line with Congress pay and being a civic duty, not a career, the salary of the President will also be lowered. The current Presidential salary is \$400,000 and will be lowered to \$100,000. But to keep in line with Washington, anyone elected to serve as President with a personal wealth that exceeds \$100,000 per year, will receive one-half the salary, or \$50,000. Anyone elected to serve with a personal wealth of \$200,000 or more will receive NO compensation for their service. This provides for a minimum savings of \$300,000 per year.

The White House Staff was created in 1939 and since that time, the

number of staff members has grown, more than doubling in size. Once we dwindle the staff back down to the positions that are necessary, another great amount of savings in salaries will come about.

In setting term limits, government again takes on the role of civic duty; Bringing a continuous flow of new ideas & fresh minds; working together to serve the people, not advancing their career. A government of elected people working For, With & By the People, nothing more. Returning to the visions our Founding Fathers had for this Nation, not what it has become.

Term limits would be set as follows: Senators would be elected to a 4 year term. Each election to be held two years after the Presidential election; Senators would be elected to serve a single term; no re-election. Representatives would be elected to serve a two year term, with a maximum of two terms. Elections taking place during the Presidential election year and two years later with the Senate elections.

This will also eliminate those behind the scenes controlling the direction & steps our government takes. They can't keep them in their pocket with term limits imposed. Reuniting this Nation again as One People, Indivisible, with Truth, Justice and Liberty for All! United We Stand, Divided We Fall! Time to Stand as One and cast those seeking to fully enslave us out!
