## **Game Platform Privacy Policy**

In order to provide better and diversified services and merchandise, We will collect, use, manage and provide your information to your service provider or affiliate company under the permission of the the Personal Data Protection Act, To ensure that provide the better quality of service to you ,and to monitor as well as ensure that employees are absolutely rigorous and confidential when dealing with the information

#### 1. The purpose of collecting personal data

When using the game platform, you may need to provide some personal information so that to use the game platform member related services continuously, the main purpose of collecting personal information are as follows:

Our company is committed to follow strict guidelines to choose reputable partners to provide services, but the company's privacy protection does not protect the information that you directly to provide to the third party (the Buyer / seller online auction, online store or other websites). The game platform recommends that you advise the parties concerned about their codes and guidelines before providing any personal information

### 2. Collected information categories

- (1) **Basic information**: such as name, sex, date of birth, identity card number, passport number, telephone, address, e-mail address, marriage, family status, legal guardian name, or other information that can be identified directly or indirectly; And, if necessary, we will require a copy of the original or photocopy for checking.
- (2) **Accounting information**: such as financial institution account number, credit card number, transaction information, and other financial conditions; and, if necessary, we will require the original or photocopy for checking.

#### 3. Personal data utilization period

The game platform is available for using your information during the operating period.

#### 4. Personal data utilization area

The game platform can take advantage of your profile in global area.

#### 5. Reveal the collected information

You confirm and authorize the game platform to retain and store all of the information that you provided in one or more databases of the company. We will maintain full control and protection of all information in these databases in strict accordance with the standards of security and confidentiality and will not be disclosed to the third party, except as follows:

- (1) Employees who have received formal training to deal with customer information and have been authorized.
- (2) Third party service providers that provide support services. These suppliers are bound by the contract to comply with the privacy standards in this article.
- (3) Any person who is required to disclose information to the game platform in accordance with applicable laws, government or regulatory requirements
- (4)When the company occur business restructuring, reorganization or similar circumstances, any trustee or transferee who is the benefit of the Company.
- (5) The person or organization that you are dealing with through the platform services, such as cash flow services, banking, finance or other institutions, etc..
- (6) In the event of any of the following circumstances, the game platform will retain the right to disclose your personal information to a specific person:
- (a) The gaming platform has sufficient reason to believe that it is necessary to disclose the identity of the information system or to contact you
- (b) In violation of the user terms of game platform website or product.; Or because of your behavior for the game platform of the site, rights, products, other users cause damage or interference; interference and take legal action against you.

#### 6. The influences about without providing information or provide wrong information

## 8. Collecting information by using Cookies
