# **Motion for Restructuring the LLC and Further Reform**

## Section I - Restructuring the LLC

[A] Amend Article II of the constitution to read as follows:

#### "Section I - Establishment

- (a) The leadership of the Liberal Party (henceforth "the Party") shall be known as the "Liberal Leadership Council" or "LLC."
- (b) The Liberal Leadership Council shall consist of a Chairperson, a Vice Chairperson, and a Secretary.

### Section II - Powers and Duties

- (a) Powers and Duties of the Chairperson:
  - (i) proposing and voting on LLC motions
  - (ii) moderating the party subreddit/Discord, and settling disputes within the subreddit/discord server
  - (iii) presiding over and announcing the results of party elections
  - (iv) being a liaison between the party and the moderation of /r/ModelUSGov
  - (v) representing the Party in its external affairs, especially during coalition negotiations
  - (vi) appointing an interim Party Secretary when there is a vacancy, who will server until replaced through an election (an election must take place within 2 weeks of a vacancy)
  - (vii) nominations of and delegation of duties to LLC advisors
  - (viii) any other duty that is not explicitly stated but can reasonably be considered to fall under the jurisdiction of the Chair
- (b) Powers and Duties of the Vice Chairperson:
  - (i) proposing and voting on LLC motions

- (ii) acting as the Chair whenever the Chair is vacant or so requests, or whenever the Chair is unable or unavailable for an extended period, defined as any period more than three days
- (iii) assisting and advising the Chair in his duties, taking on the responsibilities assigned to him or her by the Chair
- (iv) recruiting and retaining members, including monitoring threads related to joining parties
- (v) any other duty that can reasonably be considered under the jurisdiction of the Vice Chair
- (c) Powers and Duties of the Party Secretary
  - (i) proposing and voting on LLC motions;
  - (ii) ensuring party members vote in Federal and State elections within the simulation, especially by using mass messaging and posting advertisements in other subreddits and Discords
  - (iii) acting as either chair or vice chair when one or both positions are vacated, or whenever one or both positions is unable or unavailable for an extended period, defined as any period more than three days
  - (iv) any other duty that can reasonably be considered under the jurisdiction of the Party Secretary
- (d) Vice Chair shall be subordinate to the Chair, but may represent the party individually with the consent of the Chair.
- (e) During votes, all three members of the Party Leadership shall have an equal vote, but the vote of the Chair shall break any tie votes to determine the majority.
- (f) Advisor nominations must be confirmed by a unanimous vote.
- (g) The specific duties of advisors are determined by the Chair as they see fit, as well as advising the Leadership in their duties.
- (h) Each member of the Party Leadership shall have full moderation powers on all party chats and subreddits, provided that such privileges may be removed in case of abuse by unanimous vote of the remaining leadership and <sup>2</sup>/<sub>3</sub> of advisors,
- (i) The LLC may expel a member of the party with a unanimous vote.

## Section III - Manner of Election/Appointment and Terms

- (a) All members of the LLC shall be elected through a single ballot via instant runoff voting.
- (b) Elections will start within one week of each state election."
- [B] This new structure will be implemented in the next LLC election.

## Section II - Further Reform

- [A] An open discussion will be held on the party subreddit about suggestions for a new constitution after the next LLC election.
- [B] The new LLC will use this discussion to help guide them in writing a new constitution for the party.
- [C] Another discussion will be held on the drafted proposal before putting the constitution to a vote.
