# VAN BUREN COUNTY COMMUNITY SCHOOL DISTRICT WORK SESSION AND REGULAR MEETING MINUTES OF THE BOARD OF EDUCATION

## **Regular Meeting**

Motion by Richards, second by Jester to approve the agenda. Motion carried unanimously.

Nobody spoke during public forum.

#### **Minutes**

The minutes from April 30, 2019 was removed from the agenda.

Motion by Smith, second by Jester to approve May 8, May 15, and May 22 minutes. (Item 4(b,c, and d) Motion carried unanimously.

### **Mascot Logo**

The Board members selected logos 7, 8, and 10 as the 3 prints.

Motion by Breckenridge, second by Richards to take the 3 prints selected by the Board, and get them put out into the public. At the July 10 meeting the Board will make a decision on the mascot logo. Motion carried unanimously. Note: The prints will be put into 1 business in every town.

Motion by Jester, second by Richards to review and accept the Iowa Youth Survey. Motion carried unanimously.

Motion by Richards, second by Cline to table this item. Motion carried unanimously.

## **Teacher Contracts-Tentative Agreement**

Motion by Richards, second by Jester to approve the tentative agreement with the teachers as listed. Motion carried unanimously.

Motion by Richards, second by Jester to approve an across the board raise of 2.1134 % for non-certified staff except for those to be discussed in the exempt session. Motion carried unanimously. Note: Those groups to be discussed in the exempt session are: Administrators, district office and supervisory staff, and grounds and maintenance.

### **Intent for Early Graduation**

Motion by Cline, second by Richards to approve the early graduation in December 2019 as presented by Mr. Adams. Motion carried unanimously.

Motion by Richards, second by Jester to table this item. Motion carried unanimously.

## **Bank Accounts**

Motion by Cline, second by Breckenridge to name State Central Bank as the main bank for the Van Buren County checking account and Libertyville Savings Bank, State Central Bank and 1st Iowa State Bank as banks for money market accounts. Motion carried unanimously.
