Register to Vote: In NJ you must register to vote prior to the General Election, NJ does not have same day registration.

Registration Deadline: for the November 8th General Election is Tuesday Oct 12.

In the November 8th election we will be deciding who will represent you in Washington. All members of the House of Representatives are up for election. Does your current representative support your 2nd Amendment rights? If not, you have the opportunity for change on November 8th. Hopefully you have a person running who will support our Constitutional right.

Vote by Mail: If you prefer voting by mail vs physically going to your local voting booth, you have that right. You must request a mail in ballot from your County Clerk by Tuesday Nov. 1st (by mail) and Monday NOV 7th if you apply in person. All Vote by Mail ballots must be received by mail or in person to your County Clerk's Office by November 8th.
