A. Introduction (Cambria, Bold, Size 12, 1,5 Space)

Provide an adequate background, context of the problems based on the literature review. State the objectives of the work and emphasize the originality (state of the art). Citation more than one cited article/reference should be written in order by year. How to write sources in the text need to clearly indicate the name of the author and source citation, in the form of the year of publication and the page where the manuscript is located. An Example is: Kuntowijoyo formulated structured and systematic steps in translating his thoughts. The reinterpretation of Islam offered, for example, was carried out through five fairly practical steps, such as (1) the structural social interpretation was for understanding the provisions in the Qur'an; (2) changing the subjective thinking into objective ways; (3) changing the normative Islam to theocentric Islam; (4) changing the historical understanding to historical; and (5) formulating the general revelation formulas to be specific¹.

B. Research Methods (Century Schoolbook, Bold, Size 12, 1,5 Space)

Provide sufficient detail methods to allow the work to be reproduced. Methods already published should be indicated by a reference: only relevant modifications should be described. Explain chronological research, including how to prepare materials research, design of the study and research. Minimum research method consists of research type, type and source of data, data collection techniques, and data analysis techniques.

C. **Results and Discussion** (Century Schoolbook, Bold, Size 12, 1,5 Space)

Results should be clear and concise. Show only the most significant or main findings of the research. Discussion must explore the significance of the results of the work. D. Conclusion (Century Schoolbook, Bold, Size 12, 1,5 Space)

Conclusions should answer the objectives of research. Tells how your work advances the field from the present state of knowledge. Without clear Conclusions, reviewers and readers will find it difficult to judge the work, and whether or not it merits publication in the journal. Do not repeat the Abstract, or just list experimental results. Provide a clear scientific justification for your work, and indicate possible applications and extensions. You should also suggest future experiments and/or point out those that are underway.
