

**NOTICE OF 60 DAY COMMENT PERIOD
AND PUBLIC HEARING ON THE USE OF TYPE B SALES TAX FUNDS**

Notice is hereby given that the Brownsville Community Improvement Corporation (BCIC), pursuant to the Texas Local Government Code Sec. 505.159, will conduct a **sixty (60) day public comment period** beginning on **March 5th, 2026**, and ending on **May 4th, 2026**, to consider the expenditure of Type B sales tax funds in the amount of **\$3,719,000** for the following quality of life projects in reference to **ordinance 2024-1743 for the City of Brownsville**:

- **Project #COB26-001 for Dean Porter Park Playground**, not to exceed One Hundred and Ninety-Five Thousand Dollars and Zero Cents (**\$195,000.00**) for the replacement of the park playground and improvement of ADA accessibility.
- **Project #COB26-002 for Gonzalez Park Pool Renovations**, not to exceed Four Hundred and Ninety-Six Thousand Dollars and Zero Cents (**\$496,000.00**) for upgrade to park facilities and ADA accessibility.
- **Project #COB26-003 for Gonzalez Park Improvements-Soccer Turf** not to exceed One Million Dollars and Zero Cents (**\$1,000,000.00**) for the installation of a high-quality synthetic turf.
- **Project #COB26-004 for West Little League Lights & Cameras** not to exceed Five Hundred and Seventy-Eight Thousand Dollars and Zero Cents (**\$578,000**) for an installation of LED lighting and security cameras.
- **Project #COB26-005 for Shuttle Bus with Wheelchair Lift** not to exceed One Hundred and Fifty Thousand Dollars and Zero Cents (**\$150,000.00**) for the installation of an ADA-compliant wheelchair lift.
- **Project #COB26-006 for Oliveira Park Tip o Tex Building**, not to exceed Four Hundred Thousand Dollars and Zero Cents (**\$400,000**) for the installation of a multi-use facility.
- **Project #COB26-007 for Morningside Park Kickball Fields**, not to exceed Six Hundred Thousand Dollars and Zero Cents (**\$600,000.00**) for the renovations of the kickball fields.
- **Project #COB26-008 for Sidewalk and Trails Master Plan**, not to exceed Three Hundred Thousand Dollars and Zero Cents (**\$300,000.00**) for the design of a sidewalk and a trails master plan.

A public hearing to consider the expenditure of Type B sales tax funds will be held by BCIC during a regular BCIC Board Meeting on **Monday, March 23rd, 2026, at 5:30 P.M.** at the **eBridge Center for Business and Commercialization, located at 1304 E. Adams Street, Brownsville, Cameron County, Texas 78520.**

The BCIC Board of Directors, in its sole discretion, may determine the total amount of funds awarded and any other terms. Projects approved by the BCIC Board of Directors will require additional approval by the Brownsville City Commission. Approved project(s) cannot begin, nor can any expenses be incurred, until the project agreement has been executed.
