

This privacy policy has been compiled to better serve the members and users of the website and other software solutions we provide, who are concerned with how their “Personal Identifiable Information” (PII) is used.

“Personal Identifiable Information”/PII as described in US privacy law is information that is used on its own or with other information to identify, locate or contact an individual in the case. Please read our privacy policy carefully to understand how we collect, use, protect or otherwise handle any information under our website.

What data we collect

We do not collect any personal information on any of our extension platforms such as name, email address, location or payment details.

In some cases (Listed Below), we only collect the amount and type of information you choose to disclose.

1. Creating an Account

In case you opt to create an online account with the Screen recorder tool or submit your data to the Screen recorder tool through one of our extensions/products. You will always be aware in this defined case as you will have to manually enter it or submit it yourself. Such information may include your name, email address, location, phone number, or payment details which you will voluntarily provide to the Screen recorder tool.

2. Information you choose to make public

From time to time, today or in the future, you may have to post, transmit, provide or display content or media that might include your details for disclosure. Any information provided in this case will be disclosed and will be public, at this point Screen recorder tool will have no control over your information as any individual could copy and disseminate your information. In such cases, you must be cautious to share your personal information as the Screen recorder tool will not be responsible.

3. Information about your device, internet connection, Access to the websites and products

When you use the websites or extensions, we automatically collect the information about your device (such as Phone, Tablet, Laptop, or PC) depending on your settings. We may collect information regarding IP address, time and date, websites/extensions you visit, URL links of the site you visit through the Web Browser you use.

The information collected or addressed under this section is anonymous and directly/indirectly does not identify the individual, however, it could identify you when used together with your other information.

4. Payment Information

All payments are handled and processed by third-party vendors and not the Screen record tool itself. All the information regarding your payment such as card details, and the expiration date is directly transmitted and is not saved or held in any form by the Screen recorder tool

How we share your data

We know how important your personal information is, Screen recorder tool never sells it. We only share your information with your consent or in ways you would expect, which means we will share your information if needed to complete one of your purchases or if we are legally bound to do so.
